Dear Governor Cuomo and Legislative Leaders,

We write today regarding the very important issue of capital funding for our state parks and historic sites. The FY 2014-2015 Executive Budget proposal included \$92.5 million worth of New York Works Capital Funding for the Office of Parks, Recreation & Historic Preservation. Unfortunately, this funding was not included in the Senate's budget resolution passed last week. It is our sincere hope that this critical funding will be restored in the final budget.

As evidenced by the creation of New York Works Capital Funding Program two years ago, the state has recognized the urgent need to improve our park infrastructure. In fact, the New York Works Capital Funding Program has already made significant progress in improving the infrastructure and amenities at 81 parks and historic sites statewide. Despite the enormous progress that has been made, aging infrastructure and extreme weather conditions have further exacerbated the need for continued capital funding for our state parks. In 2012, prior to the devastation of Superstorm Sandy, it was estimated that 83% of state parks and historic sites were deteriorating. Currently, it is projected that there is a \$1 billion backlog in much needed repairs, upgrades, and renovations. Funding from the New York Works Capital Program will help replace outdated bathrooms, guarantee safe trails for hiking, and modernize bathhouses at parks across our state.


Whether you're enjoying the beaches of Long Island, hiking in Bear Mountain, or enjoying the scenic beauty of Niagara Falls, it is clear that New York parks are the crown jewel of our state. This is evident by the continued record-breaking visitorship year after year. In 2013, 60 million visitors enjoyed parks across our state. And all this activity has value beyond the obvious beauty, educational, and health benefits parks provide. Our parks are a major

economic engine for communities across the state, especially in our beautiful upstate regions. One recent study found that state parks provide a 5-to-1 return on investment to the state by helping to generate \$1.9 billion annually in economic activity and supporting 20,000 jobs. By restoring the \$92.5 million in funds through the New York Works Capital Funding Program we can keep pace with our magnificent yet aging park infrastructure while helping to spur economic activity and job growth. Most of all, we can ensure that New Yorkers can continue to enjoy a vital source of affordable recreational and cultural enrichment.

You have all shown tremendous leadership over the years by fighting to protect our state parks. Your commitment to our parks has never been in doubt, so I ask that we all join together to ensure our parks continue to thrive. Therefore, we respectfully request that the final budget restore the New York Works Capital Funding Program for the Office of Parks, Recreation & Historic Preservation.

Thank you for your consideration of this request.


