Parents: Hispanic children being bullied in law's wake

BIRMINGHAM, Ala.

| It was just another schoolyard basketball game until a group of Hispanic seventh-graders defeated a group of boys from Alabama. The reaction was immediate, according to the Mexican mother of one of the winners, and rooted in the state's new law on illegal immigration. "They told them, 'You shouldn't be winning. You should go back to Mexico,'" said the woman, who spoke through a translator last week and didn't want her name used. She and her son are in the country illegally. Spanish-speaking parents say their children are facing more bullying and taunts at

school since Alabama's tough crackdown on illegal immigration took effect last month. Many blame the name-calling on fallout from the law, which has been widely covered in the news, discussed in some classrooms and debated around dinner tables. Justice Department officials are monitoring for bullying incidents linked to the law. "We're hearing a number of reports about increases in bullying that we're studying," the head of the agency's civil rights division, Thomas Perez, said during a stop in Birmingham.

The Justice Department has established a bilingual telephone hotline and special email account for residents to report any vio-

lence or threats based on racial or ethnic background that could be linked to the law. Officials would not provide a breakdown on the types of complaints being received. Yet the Alabama Department of Education hasn't received any reports of bullying linked to the law, said spokeswoman Malissa Valdes, and it isn't tracking the issue to determine whether there could be a problem. Any parents who call the state with complaints would be referred to their child's principal, she said.

Federal officials say some parents - particularly illegal immigrants - may not report bullying to teachers and principals because they fear coming into contact with government officials. million. All but three of the town's 28 employees will receive a 3 percent salary increase. Feehan, and town supervisors Jeffrey Moshier and Glen Rose Jr. will receive a higher increase. The town budget is under the new 2 percent property tax cap established by the state earlier this year. The state cap is aimed at reversing economic decline. The law also seeks to curb soaring property tax bills, but officials have complained it offers no relief from state mandates.

Town Assessor Linda Giardina. As a result, some residents whose assessments rose sharply, could see their taxes increase. However, the tax levy will be approximately \$4,497 less than this year's budget.

Feehan said every town department chipped in to help cut costs. "It was a consolidated effort by every single department," she said.

Budget increases were driven by a 42 percent increase from Corning Natural Gas and a 15

percent rise in workers' compensation fees. The town saved money by switching to a cheaper employee insurance plan. The tentative budget uses \$150,000 from the town's reserve fund, \$139,000 less than what was used in the 2011 spending plan. "We will make an effort to use no more than \$75,000 from the town reserve fund in the 2013 budget," Feehan said. "It's something we need to continue to use less each year."

The town reserve fund is currently about \$1.3

the drivers test sites was simply a matter of picking a number, according to Deputy County Administrator Jack Wheeler. According to the state DMV, each driver tests site must schedule 900 roads tests a year to be "viable." All three sites in Steuben schedule more than 750 tests. Close, but not close enough.

"It was an arbitrary number," Wheeler said. "They could have said 750 sites. They could have picked any number." "All I can say is it doesn't make sense," said county Legislator Pat McAllister, R-Wayland. McAllister is chair of the Administration Committee, which will meet Monday to approve a resolution protesting the DMV's

latest action. "The state is out of control and it's spreading to all the agencies. It's like the state mandates that force counties to cut the state is cutting services to our residents." What also is odd is the location of the single site. Corning is the only location near a larger urban area. That means residents in the Corning area can take drivers tests in Elmira. But residents in the western and central areas will have to drive much farther to reach driver tests sites in Corning or Belmont in Allegany County.

However, selecting a more centrally located single site, such as the county seat of Bath, is not the answer, McAllister said. "I'm opposed to closing any of them," he said. "It doesn't make any sense to close any of

them. People have to drive 30 miles to get to any of them. And we're not pitting one site against the other." Closing the sites also reduces Steuben's revenues, McAllister said. Wheeler said the DMV's decision may be an example of how out of touch Albany is becoming with rural needs. "It is becoming more urban-oriented, certainly," he said. "But really, I think this is more of an example of how government tries to fit one-size-fits-all solutions."

Other agenda items Monday include: Transferring \$6,500 from the contingency fund to the Public Defender's budget. Setting the date for a public hearing on the county's 2012 budget.
