Main points

Introduction:

Thank you, council members, for holding this public hearing.

My name is Pete Sidote; I am the Empire State Redemption Center Association president. We are a group of over 125 Redemption Centers across NYS, many of which service the five Boros. The following

statements are supported by the redemption centers across the five boroughs.

- All 125 redemption centers, 20,000 employees, and hundreds of thousands of people that we represent and rely on the deposit return systems say in unison, "we all fully support an expanded bottle bill." An expanded bill that increases the containers covered under legislation includes teas, juices, sports drinks, and wine and liquor bottles. A new bill would also increase the deposit per container from 5 to 10 cents and the handling fee from 3.5 to 6 cents.
- 2. The expanded bill makes sense for many reasons.
- The science and data are crystal clear. Deposit Return systems are one of the NYCs most effective recycling systems. According to sources like the Container Recycling Institute and New York Times, The Bottle Bill is approximately 4x more effective at recycling bottles and cans vs. curbside collection.
- 4. Also, according to the Container Recycling Institute, plastic, aluminum, and glass recycled through the redemption system are 40% more likely to be made into consumer goods vs. the same material sourced from curbside recycling. As EPR legislation is expected to pass in the coming years and more consumer products require the SAFE pet to be infused in packaging, the Bottle Bill is our state's purest source of recycled feedstock.
- 5. The Bottle Bill is a leading environmental policy and a huge economic driver.
- 6. Tens of thousands rely on the deposit money for food, medicine and shelter.
- 7. The expansion of the Bottle bill will help empower, legitimize, and establish the canning community.
- 8. With an expanded bottle bill NYS is estimated to make around \$250M annually. This is a pool of funding that the city can request resources from.
- 9. Again an expanded bottle bill will be great for the cities economy and citizens.
- 10. Despite the many clear benefits our government officials will naturally gear opposition against the bottle bill.

- 11. One point of opposition you will hear is that bodegas, spirit shops and food stores across the city do not want to take back the single use packaging that they sell. That is okay, under current and expanded legislation they can be expempt from taking material back as long as they partner with a Redemption center who will collect material on their behalf. The majority of our members have the infrustruce ready to handle the increase in deposit material. We are ready to serve our great city.
- 12. Finally, The expansion of the bill will fuel technologies that will help make the redemption system more secure against fraudulent activity while being more convenient for business, citizens.
