

As we mark the 50<sup>th</sup> anniversary of the end of the Vietnam War, Americans are uniting to express heartfelt gratitude to Vietnam veterans and their families for their service and sacrifice. Congress outlined five key objectives for the Commemoration, with the primary goal being to thank and honor our Vietnam veterans and their families.

To help fulfill this mission, this Commemoration united thousands of organizations in recognizing more than 7 million living Vietnam veterans around the world, along with members of the 10 million families whose loved ones served in the conflict. As a gesture of appreciation, each veteran will be presented with a Department of Defense-provided Vietnam Veteran Lapel Pin, a lasting symbol of our Nation's respect and gratitude.

## JOAQUIN AFONSO

Joaquin Afonso achieved the rank of Staff Sergeant in the United States Army Reserve.

Born during World War II, Mr. Afonso moved from Brooklyn to Mineola, New York at just one week old. Growing up in a family deeply committed to military service, he was inspired by their dedication and followed in their footsteps. After receiving a college deferment, he enlisted in the Reserve in 1964, reporting to Fort Dix for basic training.

Mr. Afonso was assigned to the 340<sup>th</sup> Battalion's Military Police Unit. He served with distinction and was honorably discharged as a Staff Sergeant in May 1970. Soon after, he was activated in the Army Reserve to assist during the U.S. Postal Strike, continuing his commitment to serving the Nation.

After discharge, Mr. Afonso dedicated 35 years to working as a Senior Probation Officer for Nassau County, retiring in 2000. In 1998, he was recognized as New York State Probation Officer of the Year for outstanding service. Retirement, however, did not mark the end of his service; it provided a new avenue for giving back.

As a longtime leader in the Williston Park American Legion Post 144, Mr. Afonso served as Post Commander from 2003 to 2006. After being awarded life membership, he continues to serve as Chairman of the Board. Under his leadership, the Post has remained a vital part of the community, working with Scout Troops and organizing parades, honor guards, blood drives, and dances for developmentally challenged youth. For over two decades, Mr. Afonso has spent time flagging the graves of veterans in Holy Rood Cemetery in Westbury to honor fallen Post members who have served in the Armed Forces.

Beyond the Legion, his advocacy for veterans remains steadfast. As a Town of North Hempstead Veterans Advisory Board member, Mr. Afonso has helped improve access to VA hospitals, organize clothing and gift card drives, and provide vital resources for fellow veterans. The most recent gift card drive raised over \$10,000 – just one example of his unwavering dedication to those who served.

Through it all, Mr. Afonso has always been steadfastly supported by his loving wife, Barbara, and their two daughters, Kristine and Kimberley. His devotion to family, country, and community is a testament to his character and a legacy that will endure for generations.

Jane Altacho-Davis served in the United States Army for 33 years, enlisting as a Private and rising to the rank of Lieutenant Colonel.

During her decades of service, she participated in three military conflicts, including Iraq in 2006, Kuwait in 2012, and again in Kuwait in 2015.

Throughout her career, Ms. Altacho-Davis was honored with numerous accolades for her service. As a soldier, she was awarded a Bronze Star Medal, Meritorious Service Medal, and the Iraq Campaign Medal for her contributions to the logistics efforts.

Ms. Altacho-Davis has also worked on behalf of her community by serving as a Detective in the New York Police Department for more than 20 years.

Her commitment to service extends beyond her professional career. Ms. Altacho-Davis has been a longtime resident of Shore Haven, where she raised her family, and she served on the Shore Haven Board for two years. Her efforts as a board member contributed to the betterment of her neighborhood for her fellow community members. Ms. Altacho-Davis is also an active member of her church and a dedicated participant of her women's ministry group.

Ms. Altacho-Davis holds a Bachelor's degree from Regent University and an Associate degree in Accounting from Manhattan Community College.

Among her proudest achievements has been raising her three children. Her eldest child, Justin, has been serving our Nation in the United States Air Force for fifteen years. ### ARTHUR G. AUSTIN, JR.

Arthur G. Austin, Jr. served in the United States Army National Guard and retired as a Brigadier General.

Mr. Austin is a distinguished veteran whose life of service spans more than three decades of military excellence. A native of Michigan, Mr. Austin enlisted in the United States Army National Guard in 1977, beginning his career in the Military Police. He quickly rose through the ranks, commissioning as an officer after graduating from Michigan State University in 1982.

Over the next 37 years, Mr. Austin served with unwavering dedication. His deployments included critical conflict zones such as the Cuban Refugee Crisis, Operations Desert Shield and Desert Storm, Operation Katrina, and Operations Iraqi Freedom and Enduring Freedom. His leadership roles, from Platoon Leader to Deputy Commanding General of the 46<sup>th</sup> Military Police Command, earned him numerous accolades, including the Bronze Star and Meritorious Service Medal.

Upon his 2014 retirement from active service, Mr. Austin settled in Cuba, New York. He has channeled his time and energy into supporting veterans through various local programs, including mentoring and assisting in veteran support organizations. Among those benefiting from his involvement are the Veterans Outdoors Experience and the Community Veterans Outreach, where he advocates for veterans' needs, from VA assistance to awareness programs, including suicide prevention initiatives.

Mr. Austin's dedication was recognized when he was named the 2024 Outstanding Veteran Volunteer of the Year by the Daughters of the American Revolution (DAR) for his tireless work supporting fellow veterans. This honor, bestowed at the local, State, and national levels, is a testament to his leadership and patriotism. His motto, "Honorable Service after Honorable Discharge," reflects his commitment to his country and his fellow service members.

In addition to his volunteer work, Mr. Austin has served as an educator, guest teaching at Cuba-Rushford High School and St. Bonaventure University. He continues to inspire future generations, urging them to be "part of the solution, not part of the problem."

Mr. Austin's legacy is defined not only by his exemplary military career, but also by his unwavering dedication to veterans and his community. He lives with his wife, Karen, in Cuba, New York, where he remains a pillar of support and inspiration to all who know him.

## LAWRENCE BADGER

Lawrence Badger courageously served in the United States Army during the Vietnam conflict and obtained the rank of Sergeant.

A graduate of Thomas R. Proctor High School in Utica, Mr. Badger enrolled at Mohawk Valley Community College before enlisting in the Army as a Paratrooper Infantryman while the Vietnam War was escalating. He attended basic training at Fort Jackson, South Carolina; infantry training at Fort Gordon, Georgia; and Paratrooper Airborne training at Fort Benning, Georgia.

When Mr. Badger received his Airborne wings, he was assigned to the 82<sup>nd</sup> Airborne Division, the 101<sup>st</sup> Airborne Division, and eventually the 173<sup>rd</sup> Airborne Division in Vietnam. He was promoted to the rank of E-5 Squad Leader in June 1968. Mr. Badger served in numerous campaigns, including Phase III and V of the Vietnam TET Counteroffensive. During his service, Mr. Badger showed remarkable bravery, leadership, and selflessness under intense pressure and difficult conditions.

After his tour in Vietnam, Mr. Badger volunteered an additional six months and was assigned to the 58<sup>th</sup> Infantry until his departure in July 1969. He received the Purple Heart after he was wounded on March 13, 1968, as well as the Bronze Star, Combat Infantry Badge, Army Commendation Medal with "V" device, Vietnam Service Medal, Parachute Badge, Air Medal Citation, Good Conduct Medal, and three Overseas Service Bars.

Mr. Badger remains committed to helping veterans and their families and ensuring that the memories of fallen service members never fade. You will often find him working hard behind the scenes to ensure that veteran-related ceremonies and other events go smoothly. He plays an instrumental role in many regional veterans' organizations, including serving as Vice President of the Vietnam Veterans of America Chapter 944, Finance Officer of the Military Order of the Purple Heart Chapter 490, Officer in the Masonic War Veterans Post 55, Trustee of the VFW Yorkville Post 6001, and Director of Wreaths Across America for Rome, New York. Mr. Badger is also a member of the New Hartford American Legion Post 1376, the Combat Infantry Association, and the 173<sup>rd</sup> Airborne Association.

When Mr. Badger returned home, he was employed by the U.S. Postal Service for over 30 years. He was the Chief Steward for the American Postal Workers Union for over 25 years and was also on the Veterans Committee for the Utica Post Office before retiring in 2008.

### VICKI BELLO

Vicki Bello enlisted in the United States Navy in 1985, serving on active duty as a Radioman.

A native New Yorker, Ms. Bello's various commands included Adak, Alaska and Ford Island, Hawaii. After completing her active service in 1989, she continued to serve in the Naval Reserve at Fort Schuyler in the Bronx for two additional years before receiving an honorable discharge.

After military service, Ms. Bello attended LaGuardia Community College in Queens, where she graduated with an Associate degree with honors. She then earned a Bachelor's degree in Sociology from Herbert H. Lehman College in the Bronx, graduating *summa cum laude* with minors in Puerto Rican and Women's Studies. Her academic achievements include election into the International Golden Key Honor Society and induction into Alpha Kappa Delta, the International Sociology Honor Society.

After graduating from Lehman, Ms. Bello returned to LaGuardia Community College, where she served as the Program Coordinator and, later, as the Director of the Veteran's Upward Bound Program, a federally funded college prep initiative designed to support returning service members in their pursuit of higher education.

An active member of New York City's veterans' community, Ms. Bello has served on the City University of New York Committee on Veterans Affairs and the Borden Avenue Veterans Residence Advisory Committee. Recently, she was the Vice Chair of the Bronx Borough President's Veterans Advisory Council.

Ms. Bello currently works as the Program Coordinator for the Theatre Development Fund's Veterans Theatergoers Program, which partners with veteran organizations throughout the City to provide complimentary tickets to Broadway shows.


In 2016, Ms. Bello was recognized by City & State NY with the Veterans Still Serving Award for her dedication to the veteran community. In 2019, she was honored with a Citation of Merit by the Bronx Borough President during the Bronx Week Veterans Breakfast. Most recently, in 2023, she received Samaritan Village's Veteran Partner Award, recognizing her contributions toward providing services that enhance the treatment experience for veterans.

## RICHARD BINGHAM

Richard Bingham served in the United States Army and the Army Reserve and achieved the rank of First Sergeant.

Mr. Bingham's unwavering dedication to his country began on April 23, 1968, when he answered the call to serve and was drafted into the Army. Deployed to Vietnam as a Motorpool Sergeant with the 1<sup>st</sup> Aviation Brigade, he spent a year and a half in the heart of the conflict before returning home in December 1969. Even after completing his military obligation in 1974, his commitment to service never wavered.

In 1977, Mr. Bingham joined the 414<sup>th</sup> Civil Affairs Company in Utica, New York, marking the beginning of his long and distinguished career in the Army Reserve. When life took him to California, he continued his service with the 426<sup>th</sup> Civil Affairs Company in Upland, California, where he took on the role of Military Police Supervisor (MOS 95B5M). Upon returning to New York, Mr. Bingham dedicated seven years as a Basic Training First Sergeant with the 1165<sup>th</sup> Training Unit, shaping the next generation of soldiers during annual training.

Over nearly four decades in uniform, Mr. Bingham's leadership, dedication, and service earned him numerous commendations, including the National Defense Service Medal, the Vietnam Service Medal, and the Vietnam Campaign Medal. His commitment in the Reserve was further recognized with the Army Commendation Medal, the Army Achievement Medal, the Humanitarian Service Medal, and many other honors.

In 2007, Mr. Bingham retired as a First Sergeant (1SG) with an Honorable Discharge, closing a chapter of service that defined much of his life. Yet, his devotion to his fellow soldiers and his country remains steadfast. For Mr. Bingham, wearing the uniform was more than duty – it was an honor, a privilege, and a lifelong commitment. He takes immense pride in having served alongside so many courageous men and women, and his legacy of service continues to inspire all who know him.

### EDWARD R. BLANKENHORN

Edward R. Blankenhorn served in the United States Marine Corps and achieved the rank of Corporal E-4.

Mr. Blankenhorn enlisted in the United States Marine Corps on February 29, 1960, and completed boot camp at Marine Corps Recruit Depot (MCRD) on Parris Island, South Carolina. Additionally, he received advanced combat training at Camp Lejeune in North Carolina (CLNC).

Mr. Blankenhorn attended technical school at MCRD in San Diego, California. He graduated at the top of his class and was awarded certification as a Radio Relay Repairman (occupation code 2761). He was retained in San Diego as an instructor in basic electronics.

Later, Mr. Blankenhorn transferred to Marine Corps Air Station in Iwakuni, Japan as an electronics technician, which included service in Okinawa and the Philippines. He then transferred again to Camp Lejeune until his discharge on February 28, 1964.

Along the way, Mr. Blankenhorn acquired a number of skills. He was a relay radio operator, a truck driver, a marksmanship coach, and a blood donor.

After his discharge, Mr. Blankenhorn took on several small local jobs. In 1966, he was hired by Grumman Aerospace (which later became Northrop Grumman) as an electronics technician, leveraging his military experience. With Grumman's support, he enrolled at Hofstra University as an engineering student. Upon completing his college degree, he was reassigned as a program-level Operations Analyst, where his primary responsibility was to monitor program performance at all levels and inform the program manager about how well things were progressing. Eventually, he retired in 1998.

Mr. Blankenhorn graduated from Lindenhurst High School in 1975. He received military training in radio repair. Mr. Blankenhorn also attended many seminars in program control and management and estimating technology. He graduated from Hofstra University in 1983 with a Bachelor of Science in Industrial Engineering.

Mr. Blankenhorn met the love of his life, Elizabeth Marie (Kohler) Blankenhorn (deceased), through a mutual friend in 1957, and they married in 1964. They have a daughter, Dawn Marie (Blankenhorn) Newland, who resides in Venice, Florida.

### DAVID BRISBANE

David Brisbane achieved the rank of Corporal E-4 in the United States Marine Corps.

Mr. Brisbane enlisted in the Marine Corps in 1964 and served on active duty through 1967 during the Vietnam War. From 1967 to 1970, he served on inactive reserve duty.

Mr. Brisbane recalls joining the military because it was simply what young country boys did when they were old enough. He followed in the service of his older brother.

After his service, Mr. Brisbane took college courses and worked as a machinist at Gleason Works, a manufacturer in Rochester, New York. He retired as a manufacturing supervisor after 47 years with the company. He says the training and discipline he learned in the Marine Corps helped him advance from machine operator to supervisor.

Mr. Brisbane is a Purple Heart recipient and earned numerous other honors for his service, including the National Defense Service Medal, Vietnam Service Medal with three Stars, Presidential Unit Citation, Navy Unit Commendation Medal, Republic of Vietnam Campaign Medal with Device, Navy Meritorious Unit Citation, Good Conduct Medal, Combat Action Ribbon, and Rifle Sharpshooter Badge.

In continued service to his community and fellow veterans, Mr. Brisbane is a member of the VFW, American Legion Post 256, and Marine Corps League Memorial Day Detachment 468, where he is Commandant. He is North West Area Vice Commandant of the Marine Corps League Department of New York.

For many years, Mr. Brisbane has led the annual Marine Corps Toys for Tots program, collecting and distributing thousands of toys to area children. He is a longtime volunteer for the Canandaigua VA and Honor Flight and a member of the Challenge 22 management committee, raising hundreds of thousands of dollars to bring greater awareness to veteran suicide and support for veterans.

Mr. Brisbane participates with the Honor Guard units of American Legion Post 34 in Shortsville and 256 in Canandaigua, and he organizes the Color Guards for Memorial Day and Fourth of July parades. He was instrumental in establishing Wreaths Across America at the former Sampson Veterans Memorial Cemetery, now the New York State Veterans Cemetery - Finger Lakes.

Mr. Brisbane is a resident of Bloomfield, New York.

Ventura Colon was inducted into the United States Army and achieved the rank of Specialist 4<sup>th</sup> Class, serving one year in Vietnam as a medic.

Mr. Colon was born in Puerto Rico and relocated with his family to Buffalo in 1956 when he was 10 years old. He graduated from Seneca Vocational High School with a concentration in Industrial Electricity. As a young man, he helped create a youth civic action group to help combat discrimination against the Hispanic community.

Drafted into the Army, he earned a number of medals, including the Combat Medical Badge, awarded to medical personnel who provide care under fire in combat zones, in 1967 and the Army Presidential Unit Citation, an award given to units that demonstrate exceptional heroism in action against an armed enemy.

After completing his tour of duty, Mr. Colon was honorably discharged from the Army. Once home, he attended the State University of Buffalo and received a Bachelor of Science in American Studies and Sociology. His studies led him to obtain a national license as a Vocational Rehabilitation Counselor.

Mr. Colon was employed by Lakeshore Behavioral Health as Director of the Outpatient Drug and Alcohol Counseling Center from 1987 until his retirement in 2008.

Mr. Colon's community involvement includes an extensive list of memberships: the WNY Hispanic and Friends Organization, the Erie County Youth Board, founding member of Hispanics United of Buffalo, and the originator of the Hispanic American Veterans Memorial at the Buffalo and Erie County Naval and Military Park. He currently serves as President of the Memorial and as Service Officer of the Gabriel A. Rodriguez American Legion Post 1928.

Mr. Colon continues to remain actively involved with activities in the local Hispanic and veterans community. At present, he assists by packing and distributing food for needy families, seniors, and veterans with the Belle Center on the West Side of Buffalo, the Westside Community Services, and the PS #30 Frank A. Sedita School.


His numerous honors include the City of Buffalo's Community Service Award for exemplary leadership, and he acted as Grand Marshal for the Hispanic community's annual parade.

John Cooper, Jr. served in the United States Army and achieved the rank of Sergeant.

Mr. Cooper served six years in the Army as a Sniper, from 2015 to 2021, with the 25<sup>th</sup> Infantry Division, 3<sup>rd</sup> Brigade, Reconnaissance Commandos (Recondo) and 10<sup>th</sup> Mountain Division, 1<sup>st</sup> Brigade, 2<sup>nd</sup> Battalion, 22<sup>nd</sup> Infantry Regiment. He served one tour of combat duty in Afghanistan as a Sniper Section Leader.

For his service to his Nation and bravery, Mr. Cooper earned numerous accolades, including the National Defense Medal, the Global War on Terrorism Service Medal, the Army Commendation Medal, and the Military Outstanding Volunteer Award. Mr. Cooper served in multiple leadership positions in the infantry, including Senior Sniper, Anti-Armor Section Leader, Headquarters Platoon Sergeant, QRF Squad Leader, and Sniper Section Leader.

An ordained Baptist Pastor, Mr. Cooper studied at Liberty University to earn a Master of Divinity with a focus on Organizational Leadership. While serving in the Army, he also volunteered in the ministry service and volunteered here in New York, as well as in Pennsylvania, Hawaii, and Afghanistan.

Mr. Cooper is a fierce advocate for veterans, including those struggling with addiction and homelessness. He serves as the Executive Director and Chief Executive Officer of Niagara Gospel Mission, a nonprofit organization in Niagara Falls that focuses on the physical and spiritual needs of the people it serves. The Mission operates a soup kitchen, offers free clothing, serves as a code blue shelter, has transitional housing, and offers a special program for struggling veterans. To bring additional money to the Niagara Gospel Mission, Mr. Cooper raised more than \$16,000 to benefit homeless veterans in his care by "Rucking for Rescue." He filled up his old Army bag, strapped it to his back, and marched more than 200 miles to raise awareness of the issues faced by the many people who struggle with homelessness.

Mr. Cooper actively supports veterans in many ways, including hosting a podcast and website called The Godly Grunts, a platform to discuss topics that affect combat soldiers and how they can strengthen their faith, along with showing correlations between the physical battlefield and the spiritual battlefield.

Mr. Cooper grew up in Niagara Falls, New York, where he currently resides with his wife and their four children.

Betsy Crumity served in the United States Army and the United States Army Reserve and achieved the rank of 2<sup>nd</sup> Lieutenant.

In addition, her service in the Armed Forces includes the Signal Corps, Reserve Officers Training Corps, and active duty.

Ms. Crumity worked in communication and electronics at the Signal Corps, with most of the work being done outdoors in the field. Communication is commonly defined as the transmission of information, facsimile, tactical ground-based communications, terrestrial microwave, tropospheric scatter, satellite communications systems and equipment, surveillance and signal analysis, security, direction finding and jamming. The most urgent purposes are to communicate information to commanders and orders from them.

In 1984, due to Ms. Crumity's mother's health decline, she returned to Rochester to care for her. Her mother passed nine months later. Initially, her hope was to return to service, but instead, she remained in Rochester to care for her aunt's three grandchildren. The three boys eventually came under her care and lived with Ms. Crumity until they graduated from high school and attended college.

In addition to her military life, Ms. Crumity has served on the boards for Anthony L. Jordan Health Center and William Warfield Scholarship Fund, Inc.

In October 2024, Ms. Crumity completed the United Way of Greater Rochester African American Leadership Development Program. Currently, she is an integral member of the Breast Cancer Coalition's Advocacy Committee, advocating for the breast and gynecologic cancer survivor community.

For the past seven years, she has hosted a Saturday morning radio show, *Crumity's Corner*, where members of the community share their life's journey. Her mantra is, "Never give up, never quit, and never surrender, because on the other side of failure is success."

John Flynn served as a Private in the United States Army. An Iraq War veteran, he is a pillar of the Highland Falls community.

Mr. Flynn serves as a teacher, board member for local community organizations, and Commander of the local O'Connor Doyle American Legion Post 633.

As Commander, he "single-handedly brought the [Post] back to life," according to his brother, Patrick. A nearly defunct chapter of the American Legion was made into an active community center through Mr. Flynn's personal intervention. He completed major renovation work to the Post, including extensive plumbing and heating work. It was because of his dedication that Post 633 became instrumental in recovery efforts during the devastating flooding that occurred locally in July 2023.

As main roads connecting Highland Falls and the hamlet of Fort Montgomery were washed out, Post 633 became a hub for affected residents and service organizations such as the local churches and the Red Cross.

Keeping the Post open 12-plus hours a day, Mr. Flynn and his fellow members picked up and delivered food, cooked lunches and dinners, and delivered those to residents in need. With donations of clothing coming in, the American Legion became something of a pop-up thrift store, where anyone could grab what they needed right away. Local wells and pipes were damaged by the storm, and Mr. Flynn, with help from other members, provided pallets of water to neighbors in need. His leadership during this tragic natural disaster was essential to recovery efforts.

As an active DJ with his brother, he loans his equipment and services to whoever needs them and performs in the Village. For years, they hosted a charitable event, known as "John and Pat's Pantry Raid," to collect donations for the local food bank, a tradition now continued by their sons. Mr. Flynn also serves as a board member for the Center of Highland Falls, a nonprofit organization dedicated to enhancing the lives of local residents.

Alongside his brother, he serves as a teacher at Highland Falls Intermediate School. He is beloved by his students and is affectionately referred to as the "favorite" Mr. Flynn.

Mr. Flynn has shown a true calling to service, both in his local community as a civilian and to his country, showing great bravery during a time of national turmoil.

### THE HONORABLE YADHIRA GONZALEZ-TAYLOR

The Honorable Yadhira Gonzalez-Taylor served in the United States Army Reserve and achieved the rank of Specialist E-4.

Judge Gonzalez-Taylor served as a Military Police Officer for six years and earned numerous awards, including the Good Conduct Medal and the Army Service Ribbon.

She is a dedicated lifelong public servant, educator, and author. Judge Gonzalez-Taylor was elected to the Civil Court in Bronx County in 2022, where she currently serves as Supervising Judge of the Bronx Criminal Court.

Born and raised in the Bronx and a proud graduate of the New York City public school system, Judge Gonzalez-Taylor earned her Bachelor of Science, *magna cum laude*, and Master of Arts from The City University of New York John Jay College of Criminal Justice, and a Juris Doctor from New York Law School.

Her legal career began in 2002 as an Assistant District Attorney in the Bronx, where she prosecuted cases involving economic crimes, arson, animal cruelty, and public corruption. In 2006, Judge Gonzalez-Taylor joined the New York Police Department as an internal prosecutor, handling misconduct and corruption matters. She later served as an Administrative Law Hearing Officer for the New York City Department of Education.

Outside the courtroom, Judge Gonzalez-Taylor is an adjunct professor at Monroe College and a mentor to law students and aspiring judges through various bar associations and the Franklin H. Williams Judicial Mentorship Program.

Her commitment to community extends beyond her legal work. Judge Gonzalez-Taylor has served on congressional military academy nominating committees and actively supports literacy and cultural programs in the Bronx. She volunteers with veterans' organizations and serves on the New York State Bar Association's Judicial Wellness Committee.

## DAN GUIDA

Dan Guida was drafted into the United States Army in February 1966 and achieved the rank of Lieutenant.

While in the reception station at Fort Jackson, South Carolina, he qualified for Officer Candidate School (OCS). Due to listing armored vehicles as his preference, he received basic training as part of the Second Armored Division, Hell on Wheels, at Fort Hood, Texas.

After basic training, Mr. Guida was sent to Fort Knox, Kentucky for Advanced Individual Training (AIT) as an 11E Armored Crewman. After AIT, he attended OCS and was commissioned as a Second Lieutenant in January 1967, MOS 1203 Tank Unit Commander.

In September 1967, he received his orders for Vietnam and was sent to the Panama Canal for intense jungle training. Upon arrival in Vietnam, Mr. Guida was given command of the First Platoon of A Troop 1<sup>st</sup> Squadron 1<sup>st</sup> Cavalry.

Many of his operations were platoon-level search and destroy missions in the areas of Tam Ky and Cigar Island. His main major battles fought were the 1968 TET Counteroffensive and the battles of the Pineapple Forest and Burlington Trail.

For his bravery and service to his Nation, Mr. Guida was awarded a Bronze Star for distinguishing himself in connection with military operations against hostile forces.

After returning from service, Mr. Guida went back to college under the GI Bill and became a Certified Public Accountant. Currently, he is an active member of VFW Post 6249 Rocky Point, New York. His activities as Quartermaster for the VFW include assisting with their annual 5K charity run and the annual golf outing. The funds received at these functions support many veterans in need, as well as organizations such as Tunnel to Towers.

Currently, Mr. Guida is involved with several local schools. When students are studying the Vietnam conflict, he participates as a guest lecturer, giving lifetime experiences and answering questions.

Mr. Guida has spent time as a volunteer at the Long Island State Veterans Home in Stonybrook. There, he stepped up to help transport his military brothers to their medical appointments. For some, he is able to assist with their therapy treatments, as well as accompanying them on field trips.

## THOMAS JAMES HARNISHER

Thomas James Harnisher served in the United States Army and achieved the rank of Chief Warrant Officer 2.

A lifelong resident of the island community of Broad Channel, Mr. Harnisher enlisted in the Army at the age of 19. He served two tours in Vietnam as a helicopter pilot and was honorably discharged in November 1969. As Mr. Harnisher proudly states, "There I was, just 20 years old and flying combat missions with the elite First Cavalry Division in Vietnam. It was an unforgettable experience." Mr. Harnisher's tenure in Vietnam from 1967 to 1969 coincided with the heaviest fighting in the War, including the Battle of Khe Sanh and the Tet Offensive.

Mr. Harnisher amassed over 1,500 combat hours, and in recognition of his meritorious service, he was awarded the Distinguished Flying Cross, Bronze Star, Air Medal and Silver Star. He is also a Purple Heart recipient. His Silver Star citation reads, "Without regard to his own safety, Warrant Officer Harnisher stayed in the rescue area, exposed to intense enemy fire, until all members of the team had been rescued. Warrant Officer Harnisher is credited with saving the lives of the men in the patrol team. His gallant action reflects great credit upon himself, his unit, and the U.S. Army."

After completing his military service, Mr. Harnisher joined the brotherhood of the New York City Fire Department (FDNY). During his 34 years with the FDNY, he was assigned to Engine 214 (Brooklyn), Engine 331 (Howard Beach-Queens), and Marine 1 (Manhattan). In 1998, Mr. Harnisher received the prestigious Life Saving Benevolent Award for a daring sea rescue.

On September 11, 2001, Mr. Harnisher was off duty, but upon learning of the horrific attack on the World Trade Center, he succeeded in getting to Ground Zero to offer assistance. He surprisingly met up with his brother, John, a retired FDNY Lieutenant who had the same idea. Both narrowly escaped the collapse of the 7 World Trade Center building. For days afterward, Mr. Harnisher and other Marine 1 firefighters doused the smoldering ruins of the World Trade Center from their fireboats.

Today, Mr. Harnisher enjoys skiing, boating, and spending time with his wife of 37 years, Debi, who is an Air Force veteran.

### JAMES A. HODGES, SR.

James A. Hedges, Sr. served in the United States Army and attained the rank of Command Sergeant Major.

Mr. Hedges was born in Tifton, Georgia on May 24, 1928, the seventh of 12 children born to Edgar J. Hedges and Easter Gervin Hedges. Growing up in a segregated South, where the only option was to pick cotton, Mr. Hedges instead joined the military at 16 years old, enlisting in the United States Navy.

It was not long before the Navy discovered that he was too young to have enlisted. However, Mr. Hedges was not discouraged and shortly thereafter proceeded to enlist in the U.S. Army, where he was active in three wars: World War II, the Korean War, and the Vietnam War. Mr. Hedges remained in the military, rising in rank along the way. While serving with the Army, he was simultaneously employed as an electronic engineer with Airborne Instruments Laboratories, a division of Eaton Corporation.

Mr. Hedges retired from the Army, having attained the rank of Command Sergeant Major, after serving 40 years and nine months. However, his dedication to his fellow man did not stop there. He oversaw the Nassau County Auxiliary Police Department, Roosevelt Unit 124, for 26 years, while also providing community services through a 24-hour, seven-days-a-week childcare program.

Mr. Hedges remains involved in community activities and services with the 55 Mansfield Avenue Community Center and the Mount Sinai Baptist Church in Roosevelt, New York. To that end, planning is in progress to have Mansfield Avenue named in his honor.

Mr. Hedges recently celebrated his 97<sup>th</sup> birthday. He continues to be a man of the people, a man of the church, a man of the community, and a family man.

In 1951, he met Eura Lee Davis. They married and had three children: Tara (Hedges) Gilbert, James A. Hedges, Jr., and William Reese Hedges. They were married for 56 years until her passing in 2007.

Mr. Hedges has treasured his ability to help others and continues to strive to bring positive community enhancement to make a better place for all.

### MORRISON JOHN HOSLEY JR.

Morrison John Hosley Jr. enlisted in the United States Army and United States Army Reserve and achieved the rank of Colonel.

A graduate from Rensselaer Polytechnic Institute in 1961, Mr. Hosley enlisted in the Army and completed basic training at Fort Dix, where he was awarded Trainee of the Year. He then completed Pharmacy School at Fort Sam Houston and was assigned to Fort Richardson, Alaska.

In 1963, Mr. Hosley was commissioned and took command of the 64<sup>th</sup> Field Hospital. His unit responded to the Great Alaska Earthquake in 1964, setting up the 64<sup>th</sup> Field Hospital; the seven-story Air Force hospital had been destroyed.

Mr. Hosley was then assigned to Fort Hood, where he served as the Assistant Operations Officer at the base hospital. During his tenure, he directed the transition of the hospital from the old barracks to a modern medical facility at the Darnell Army Hospital. Later, he was given command of the 514<sup>th</sup> Medical Detachment.

Mr. Hosley was accepted into the Army helicopter training program and graduated in 1966. He was sent to Vietnam to fly as a medevac pilot, where he served two 12-month tours, separated by a 14-month tour in Japan.

Mr. Hosley was promoted to the rank of Major and received many commendations, including the Silver Star for Valor in Combat, the Distinguished Flying Cross, two Bronze Stars, the Vietnamese Cross of Gallantry, two Purple Hearts, 16 awards of the Air Medal, one Air Medal for Valor, and two Army Commendation Medals. Two of Mr. Hosley's four combat commands were also awarded Presidential Unit Citations. He separated from active duty in 1972, but continued to serve in the U.S. Army Reserve until 1992, when he retired as a full Colonel.

Mr. Hosley continued his public engagement by serving on the local school board, including 10 years as its President. He was elected as Town Supervisor, a position he held for 16 years. He also served on the Board of Directors for the Tupper Lake National Bank for 34 years.

In July 1963, Mr. Hosley married Loretto Ehrbar. For more than 50 years, Mr. Hosley and his family have owned multiple businesses serving the Adirondack community, including Hoss's Country Corner, their flagship store.

## RANDY JURGENSEN

Randy Jurgensen is a decorated U.S. Army veteran, retired NYPD homicide detective, acclaimed author, and film industry consultant whose career exemplifies extraordinary dedication to public service — both in the military and law enforcement.

Born in Harlem in 1933, Mr. Jurgensen served as a Paratrooper during the Korean War, fighting in the Battle of Pork Chop Hill. His heroism earned him three Bronze Stars and a Purple Heart, and his helmet is displayed at the U.S. Military Academy at West Point in recognition of his service.

In 1958, Mr. Jurgensen joined the NYPD, where he spent over two decades as one of the Department's most respected homicide detectives. He led major investigations, including the 1972 Harlem mosque incident, in which Officer Phil Cardillo was fatally shot. His 2006 book, *Circle of Six*, reignited public interest in the case, leading to a new investigation and a lasting tribute to Officer Cardillo in Queens.

Mr. Jurgensen's exceptional bravery and service were recently recognized with the prestigious NYPD Combat Cross, one of the Department's highest honors, awarded for acts of heroism in the line of duty. His distinguished assortment of accolades also includes the Medal of Valor from the Honor Legion and the Isaac Bell Medal for Bravery.

Beyond law enforcement, Mr. Jurgensen became a sought-after technical advisor and actor in major films, lending his expertise to classics such as *The French Connection*, *Donnie Brasco*, and *Cruising*. He appeared in over 50 films, including *The Godfather*, and co-wrote and produced the film *Heart*.

Now, his remarkable career is the focus of the upcoming documentary *Reel Cop*, which explores his journey from the streets of New York to Hollywood, offering an insider's perspective on the portrayal of law enforcement in film.

Mr. Jurgensen's life of service — as a soldier, police officer, and storyteller — has left an indelible mark on public safety and American culture. His contributions embody the best of New York's veterans and public servants, ensuring his legacy continues to inspire generations.

### MICHAEL KILANO

Michael Kilano served in the United States Marine Corps from 1999 to 2003.

Born and raised in Queens, Mr. Kilano is a dedicated veteran advocate and crisis coordinator who has transformed his personal struggles into a mission to help and support others. Shortly after the attacks of September 11, 2001, he was deployed to the Middle East, participating in Operation Enduring Freedom.

Mr. Kilano's service left him with deep scars. His battalion was one of the first units deployed to Iraq, and after only three months, he noticed that the experiences were beginning to change him and take a toll on his mental well-being. As a result of the many combat missions, he struggles with daily life activities, anxiety, and has been diagnosed with combat-related PTSD. The impact on Mr. Kilano's life has been profound, particularly in his role as a father. Raising five children while managing PTSD has presented unique challenges, requiring patience, resilience, and constant effort to maintain a stable and nurturing environment. Despite these difficulties, he has found ways to manage his PTSD, allowing him to be the great father that his children need.

While receiving inpatient care at the Northport VA Hospital in New York, Mr. Kilano met a fellow veteran who was part of Paws of War, an organization that helps pair veterans with PTSD with a fully trained service animal. When Mr. Kilano was discharged from the VA Hospital, he set out on a mission to find a dog that could help him. The pivotal moment in his recovery came when he received his service dog, Nova, from Paws of War. This lifesaving support not only improved his mental health, but also enhanced his ability to be present and engaged with his family.

Inspired by Nova and the positive change in his life, Mr. Kilano now works full time with Paws of War, helping other veterans navigate their own struggles. He plays a crucial role as Director of Veteran Advocacy and as a Crisis Coordinator, assisting with various tasks, including community outreach presentations, transporting dogs, and helping veterans in need.

His journey from combat to advocacy shows his resilience and commitment to making a difference in the lives of fellow veterans. Balancing his responsibilities as a father with his commitment to helping other veterans, Mr. Kilano exemplifies the meaning of dedication.

### TED KNIAZUK

Ted Kniazuk was drafted into the United States Army. He served as a Specialist-4 from 1966 to 1968, including one tour in Vietnam.

In Vietnam, Mr. Kniazuk was stationed in the Central Highlands, where he supplied power to various sites. This crucial role ensured communication capabilities between his sites and other bases, allowing them to receive essential air support and artillery assistance as needed.

The Vietnam conflict took a toll on Mr. Kniazuk, along with his fellow soldiers. In addition to the horrors of battle, he was exposed to Agent Orange, the very substance used by the country he was serving; the effects continue to affect him today.

Despite this, Mr. Kniazuk visits the local VA Hospital for treatment and also volunteers with AMVETS Post 8113, serving ice cream and assisting at the Golden Age Games. Even during his time in Vietnam, Mr. Kniazuk's commitment to others was evident as he helped a local priest at an orphanage secure extra supplies to care for war-affected children. Today, he and his wife, Janet, regularly donate clothing and supplies to the Homeless Veterans organization in Buffalo.

Mr. Kniazuk serves as Provost Marshal of AMVETS 8113 and is a trustee of American Legion Post 735. He is a longtime member of the Color Guard, providing honor guard services at events and funerals. Mr. Kniazuk also places American flags on graves for veterans, including at the "forgotten" cemetery for African American veterans in West Seneca. Additionally, he collaborates with local schools that request a veteran's presence for educational purposes.

Beyond his work with veterans, Mr. Kniazuk is an active, lifelong practicing Roman Catholic involved at St. Adalbert Basilica. He opens the Basilica for visitors, maintains the grounds, organizes the marching crew for the Dyngus Day and Pulaski Day parades, and helps raise funds at the Broadway Market during Easter. Mr. Kniazuk also volunteers with his son's nonprofit, The Big Easy, and at the annual Music is Art Festival.

Mr. Kniazuk was born in 1944 and raised in the Old First Ward. He later raised his family in the Broadway-Fillmore neighborhood and currently resides in Kaisertown. He has been happily married to his wife, Janet Sobolewski, for 59 years and has one son, Tod.

### FRANK LAMARSH

Frank LaMarsh enlisted in the United States Navy and achieved the rank of Petty Officer 3<sup>rd</sup> Class.

After high school, in 1969, Mr. LaMarsh trained at the Naval School of Construction in Davisville, Rhode Island and was assigned to the Public Works Great Lakes Naval Training Center as a member of CBMU 401. He was reassigned to MCB 62, working on the Seabee base at Gulfport, Mississippi that was destroyed by Hurricane Camille.

Mr. LaMarsh volunteered for duty in Vietnam and was deployed to NSA Da Nang, Vietnam to work with Vietnamese Seabees and civilians on construction projects. Later, he transferred to CBMU 302 in Bien Hoa. After duty in Vietnam, Mr. LaMarsh was discharged in February 1972 and served three years in the Reserve before receiving an honorable discharge in 1975.

For his service to our Nation, Mr. LaMarsh earned numerous military honors, including the National Defense Service Medal, Vietnam Service Medal, Vietnam Campaign Medal, Vietnam Civic Action Award First Class, the M16 Marksmanship Ribbon, and NYS Medal of Merit.

Mr. LaMarsh served as American Legion Gold Star Post Commander for two years and then was elected County Commander, followed by his election as 2<sup>nd</sup> District Commander. He took the role of Department Legislative Chairman, working on resolutions and memorandums of support benefiting New York State veterans. As Department Legislative Chairman, he testified before the New York State Assembly and New York City Council. Additionally, he served on the National Legislative Commission and currently serves as Department Legislative Advisor.

He was elected American Legion Department Commander from 2021 to 2022. During his term, Mr. LaMarsh traveled throughout the State meeting with veterans and offering assistance, highlighted by speaking at the dedication of the Purple Heart monument in Watertown, New York.

Presently, he is serving on the National Children & Youth Committee and various State-level committees. Mr. LaMarsh also served as Gold Star Post's Adjutant for over 20 years, County and District Adjutant, New York State Department Vice Commander, editor of the Post newsletter, and Richmond County's Staten Island Legionnaire for 20 years.

Mr. LaMarsh's other affiliations include Veterans of Foreign Wars, Vietnam Veterans of America, and the Salvation Army Advisory Board.

Eladio Lamboy served in the United States Army and achieved the rank of Sergeant First Class.

Mr. Lamboy entered the military in June 1980. His training encompassed areas of infantry, telecommunications, human resources, finance, and Equal Employment Opportunity. As part of his training, Mr. Lamboy was tasked with developing the skills necessary to help and train others to succeed and become leaders.

As a Noncommissioned Officer (NCO), he was deployed to Bosnia in support of Operation Joint Endeavor/Guard from January to September 1997. As NCO, one of his many duties was to ensure that troops were prepared and followed military standard operating procedures. He also assisted with security management protocols. In December 2003, Mr. Lamboy was deployed in support of Operation Iraqi Freedom.

Aware of the challenges many veterans face in transitioning from the military to a healthy and purposeful civilian life, Mr. Leonard developed and led therapeutic outdoor adventure programs.

Knowing from personal experience that time outdoors can help, he was focused on supporting the health and well-being of military service members, veterans, and first responders.

Beginning with the Sierra Club Military Outdoors in 2015, and then in 2021 as the Executive Director of Guardian Revival's Another Summit program, Mr. Leonard has been instrumental in training hundreds of veterans to be outdoor leaders, resulting in thousands of veterans having an opportunity to explore and enjoy the natural world.

Mr. Leonard founded and is Chair of the Outdoor Rx Coalition in New York. Its purpose is to increase access to State parks and public lands for the over 770,000 veterans living in the State. Additionally, he advises the United States Department of Veterans Affairs' Task Force on Outdoor Recreation for Veterans. Mr. Leonard is a nationally recognized leader in outdoor adventure education, who regularly speaks at recreation conferences and symposiums regarding the benefits of outdoor programs designed for the veteran community.

Currently, Mr. Leonard is the Chief Executive Officer of Guardian Revival, a non-profit organization based in Beacon, New York. Its mission is to revive, improve, and preserve the mental health and well-being of military, veterans and first responders – our guardians – and their families, at no cost to them. A community-based organization with a national reach, Guardian Revival serves thousands of guardians and their families through eight programs, including Another Summit, Boots & Paws, Champions, Encore, Homefront, Peer Services, and Rise.

Mr. Leonard volunteers as a firefighter and Lieutenant with the Cold Spring Fire Company No. 1 and is a member of the American Legion Post 275.

A father of five, Mr. Leonard resides in Cold Spring, New York with his wife, Leslie.

Daniel Luciano served in the United States Army and achieved the rank of Specialist 4.

Mr. Luciano was born in Brooklyn in 1946. As his family's only male child, he was eligible for a deferment during the Vietnam War era, but he refused it, and in 1966, he chose to enlist in the Army and was stationed in Korea.

His father, also named Daniel, was a member of the United States Armed Forces who served in World War II, and his example of how a strong leader should act left a lasting impression. Inspired by his father's example and a strong sense of patriotism, Mr. Luciano saw that it was his duty to serve his country and fight on behalf of our Nation.

During his service, Mr. Luciano was tasked with guarding the Demilitarized Zone (DMZ). There, he was exposed to an unidentified substance, an incident that later resulted in a 100 percent disability rating from the Department of Veterans Affairs. Despite the chronic pain that has followed him throughout his life, Mr. Luciano's resilience never let it dampen his spirit or limit his commitment to his family.

Soon after his discharge, Mr. Luciano married the love of his life, Jodi. Together, they raised two daughters, Janine and Laura, in the same Brooklyn community that he loved.

Mr. Luciano became a member of both the Disabled American Veterans and the Eastern Paralyzed Veterans Association, finding camaraderie and commiseration among fellow veterans.

Today, Mr. Luciano and Jodi are the proud grandparents of three granddaughters, Dakota, Autumn, and Hailey, who carry their grandfather's legacy of resilience and strength. His life stands as a testament to sacrifice, patriotism, and the enduring love of family.

## Louis Lupinacci

Louis Lupinacci enlisted in the United States Army during World War II, and he achieved the rank of Private First Class Antiaircraft Machine Gunner.

Mr. Lupinacci trained at Fort Sheridan as a machine gunner. He landed with the first wave at Easy Red Beach (a section of a five-mile-long beachhead code-named "Omaha") during the invasion of Normandy on June 6, 1944. Mr. Lupinacci worked his way through France, Belgium, Holland, Scotland, England, and Germany, securing the beaches.

For his bravery and service, Mr. Lupinacci earned numerous recognitions and awards, including the Army Good Conduct Medal, WWII Victory Medal, Meritorious Unit Commendation, European-African-Middle Eastern Campaign Medal, World War II D-Day Commemorative Medal, American Campaign Medal, and the Army of Occupation Medal.

After returning home, Mr. Lupinacci was part of the 52/20 Club, a United States government program that gave WWII servicemen \$20 per week for 52 weeks until they were able to find employment. He first took a position in a fish packing company. Later, his uncle offered him a job in construction, and he worked his way up to foreman and then supervisor, retiring after 42 years.

Mr. Lupinacci is a proud veteran and member of the Veterans of Foreign Wars Labetti Post in Rosebank on Staten Island. On September 13, 2024, he celebrated his 100<sup>th</sup> birthday. Borough President Vito Fossella presented a proclamation to Mr. Lupinacci in his honor and declared October 9 as Louis "Louie" Lupinacci Day in the Borough of Staten Island.

He met his wife, Nancy, in 1948, when she worked with his sister, Camille. They were married in 1951 and celebrated 56 years together before her passing. Mr. Lupinacci feels that his greatest accomplishment was becoming a father figure to his nephews and nieces. He has created precious memories with family and friends, which have grown to include their children and their children's children. Mr. Lupinacci is affectionately known by all as "Uncle Louie."

### LUKE A. MAGLIARO, JR.

Luke A. Magliaro, Jr. served in the United States Navy and achieved the rank of Commander.

Mr. Magliaro served in Vietnam as a Naval Flight Officer assigned to Carrier Air Wing 21, aboard the *USS Hancock* operating in the Gulf of Tonkin. He participated in Operations Babylift, Frequent Wind, and Eagle Pull, as well as the recovery mission of the *SS Mayagüez* from Communist forces in the waters off the coast of Cambodia. Following Vietnam, he was released from active duty and continued in the Reserve assigned to the *USS John F. Kennedy*. He retired in 2001.

For his valor and service to his Nation, Mr. Magliaro was awarded the National Defense Service Medal, the Navy Efficiency "E" Award, Navy Unit Citation with three stars, the Navy Meritorious Unit Citation with two stars, the Navy Sea Service Deployment Award with two stars, Vietnam Service Medal, Vietnam Campaign Medal, Navy Expedition Medal, Armed Forces Expeditionary Medal with three awards, and the Humanitarian Service Medal with three stars. He also earned several personal citations, including the Navy Marine Corps Medal, the Purple Heart, the Defense Meritorious Service Medal, Navy Air Medal, Joint Service Commendation Medal, Distinguished Service and Meritorious Service Medals, the Navy Commendation, Navy Achievement, and the Navy Rifle and Navy Pistol Expert Medals.

Mr. Magliaro became the first Vietnam veteran elected Post Commander of the PFC John J. Oliveri VFW Post 158. Under his command, the Post earned several community service awards and the distinct title of All-State and All-American Commander. Today, he continues to serve as Post Quartermaster and Judge Advocate.

Mr. Magliaro serves the VFW as National Deputy Chief of Staff and State Chief of Staff. As Commander of the Nassau County Council, he earned the status of All-State County Commander. In addition to being a Gold Legacy Life Member of the VFW, he is President of the Inwood Veterans Association, a Life Member of the Military Order of the Cootie of the United States, a Life Member of the Vietnam Veterans of America, a Life Member of the Military Order of the Purple Heart, and a Life Member of the American Legion.

He serves his community as a member of the Inwood Fire Department and is a Senior Counselor of the Nassau County Critical Incident Crisis team. As a diplomate member of the Academy of Experts in Traumatic Stress, Mr. Magliaro is Board-certified in acute traumatic stress and post-traumatic stress disorder (PTSD).

Mr. Magliaro is employed with the Town of Hempstead as a Veterans Service Counselor. He also serves as Veterans Affairs Advisor to New York State Senator Patricia M. Canzoneri-Fitzpatrick of the 9<sup>th</sup> Senate District and New York State Assemblyman Ari Brown.

## JOSEPH BERT MAHONEY

Joseph Bert Mahoney served in the United States Navy and achieved the rank of Petty Officer Second Class AE-2.

A resident of Waterford, New York, Mr. Mahoney served in the Navy from 1964 to 1968 and participated in three combat tours in the Vietnam War.

Mr. Mahoney entered active duty on April 7, 1964, and served in aircraft maintenance as an Aircraft Electrical Inspector. After training in Great Lakes, Illinois and Jacksonville, Florida, Mr. Mahoney was assigned to VA-163 on board the aircraft carrier *USS Oriskany*. He served with this unit from May 1965 until his discharge in January 1968.

During its deployments to Vietnam, the *USS Oriskany* lost 71 aircrafts and 79 service members, a shockingly high number by modern carrier aviation standards. While Mr. Mahoney was on board, the *USS Oriskany* experienced a horrible at-sea fire in October 1966, which claimed the lives of 44 sailors.

Mr. Mahoney also served in support of Navy pilot, then-Lieutenant Commander John McCain, who was shot down over North Vietnam.

For his valor and service to our Nation, Mr. Mahoney was awarded the National Defense Service Medal, Vietnam Service Medal with two Bronze Stars, Navy Unit Commendation Medal with one Bronze Star, and Republic of Vietnam Campaign Medal with 60 Device.

Mr. Mahoney was trained at the U.S. Navy Aviation Electrician Mates School and numerous aircraft technical schools, as well as the U.S. Armed Forces Institute. He attended Hudson Valley Community College for Electrical Technology and SUNY Albany for Fire Service Management.

After his military service, Mr. Mahoney was employed by GE Silicone Products for 32 years, retiring as a Project Engineer/Electrical Instrumentation Supervisor.

An active participant in the Waterford community since 1968, Mr. Mahoney has been a member, Captain, Assistant Chief, and Chief of the Waterford Fire Department. He has diligently served as the Mayor of the Village of Waterford since 1998.

He is Past Commander of the Waterford Memorial Post 5800 VFW and a member of the American Legion Post 235, Waterford Knights of Columbus, and Cohoes/Waterford Elks.

Mr. Mahoney has been married for 57 years to Margie "Mike" Mahoney. They have two boys, Bert and Russell, and five grandchildren.

Benjamin W. Margolius served in the United States Army and achieved the rank of Colonel.

After completion of his ROTC training, he was commissioned as an Army Second Lieutenant and entered active duty in the Transportation Corps in 1963. Mr. Margolius is a graduate of the U.S. Army Command and General Staff College, the Marine Corps Command and Staff College Extension Course, and the Marine Corps Instructor Technology School.

In addition to serving as the Chief of Joint Operations for the U.S. Transportation Command, he held important positions in the fields of transportation management, operations, logistics, and war planning in Korea, Germany, Okinawa, Vietnam, the Netherlands, Virginia, Maryland, Florida, Kansas, and Illinois. ### PRIVATE FIRST CLASS THOMAS FRANCIS MINOGUE

Thomas Francis Minogue served in the United States Army and achieved the rank of Private First Class. He is recognized in honor of his extraordinary bravery and selflessness during the Vietnam War.

A young man from Inwood, Private First Class Minogue was deeply rooted in a community where service to the Nation was a revered duty. As a medic with the HHC, 2<sup>nd</sup> Battalion, 35<sup>th</sup> Infantry, 25<sup>th</sup> Infantry Division, he showcased immense courage and a profound commitment to his comrades.

On March 21, 1967, during the Battle of “One-Niner,” Private First Class Minogue made the ultimate sacrifice. With his company severely compromised by an enemy attack, he displayed exceptional valor by returning fire and tending to the wounded, all while protecting his company commander from enemy fire.

Private First Class Minogue’s actions were crucial in keeping the command operational, allowing for essential support and medical evacuation calls. This selfless act not only saved the company commander, but also preserved the lives of many fellow soldiers.

The valor and extreme gallantry demonstrated by Private First Class Minogue during these critical moments speaks volumes of his character and dedication. His conduct was in the highest traditions of military service and reflects great credit upon himself, his unit, and the Armed Forces of the United States.

For service to his Nation and for protecting his fellow soldiers, Private First Class Minogue was posthumously awarded the Distinguished Service Cross.

It is with great respect and admiration that we at the office of State Senator Robert Jackson put forward his name for recognition. We believe that Private First Class Minogue’s bravery is deserving of our highest commendation.

### JOHN W. MULLEN JR.

John W. Mullen Jr. reached the rank of Specialist 4<sup>th</sup> Class in the United States Army.

Mr. Mullen's Army service began in 1965. He completed a year-long deployment in Vietnam as a Supplies Specialist at the Tan Son Nhut Air Base.

Mr. Mullen's service-connected disabilities could not hinder his tireless advocacy nor contain his boundless reservoir of compassion for his fellow veterans. He worked diligently to secure needed health coverage and earned benefits for innumerable veterans struggling to navigate government services, including those exposed to Agent Orange.

Mr. Mullen championed countless combat veterans who earned awards, badges, and medals but never received them, doggedly pursuing State and federal officials and elected government officials to redress the wrong and deliver the deserved recognition. He even ensconced the medals in shadow boxes at his own expense, providing the veterans with lasting tributes to their service that will be passed down in their families for generations. Mr. Mullen did the same for the family members and descendants of veterans, securing posthumous recognition for Purple Hearts and other awards.

Mr. Mullen served on the Board of Directors of the Rensselaer County Vietnam Veterans Monument in Troy. His deep community ties helped raise over \$500,000 for the project. He also assisted the Tri-County Council of Vietnam Era Veterans in fundraising for the Albany County Vietnam Monument.

Mr. Mullen was perhaps best known for founding The Rev. Francis A. Kelley Military Honor Society, an unmatched vehicle for educating our community on local military history and honoring veterans for their civic and military service. Each year, one decorated combat veteran from Albany County and one from Rensselaer County receive the Hometown Hero Award, one of the most prestigious military honors in the Capital Region.

It would be impossible to overstate Mr. Mullen's contributions to Capital Region veterans. No challenge was too big. No kindness was too small.

Born in Albany, Mr. Mullen graduated from Cardinal McCloskey Memorial High School. He resided in Troy and enjoyed a nearly four-decade-long career with the New York State Department of Public Service.

Mr. Mullen is interred at the Gerald B.H. Solomon National Cemetery.

## MICHAEL GERALD O'CONNOR

Michael Gerald O'Connor is a Vietnam War veteran, public servant, and longtime community volunteer.

A resident of Ossining, Mr. O'Connor has been committed to serving our Nation and New York State. For decades, his exceptional leadership has had a significant impact on the lives of his fellow residents.

Mr. O'Connor served in the United States Army from October 1963 to October 1966. He was deployed to Vietnam from April 1965 to April 1966 and achieved the rank of Specialist 4<sup>th</sup> Class. Mr. O'Connor was awarded numerous recognitions, including the U.S. Vietnam Service Medal, Republic of Vietnam Campaign Medal, U.S. National Defense Service Medal, U.S. Army Good Conduct Medal, and U.S. Army Expert Marksman with Rifle Badge. Additionally, he was awarded a Certificate of Commendation from the Commanding General of Fort Dix, New Jersey in 1966.

Dedicated to public service, Mr. O'Connor was a Council Member in the Town of Ossining for 16 years before being elected Superintendent of Highways for 14 years, where he modernized the Department. Mr. O'Connor has also served for 50 years as a volunteer with the Ossining Fire Department (OFD). Always stepping up to support local charitable causes, he packs and distributes OFD Christmas holiday food baskets and Elks Lodge food bank supplies to the needy.

In the mid-1980s, Mr. O'Connor was asked to help create a facility to house Ossining's young, unwed mothers with children. Thus, Job's Refuge was born and, after years of success, was absorbed into the Westchester County government. To celebrate his dedication to this program, Mr. O'Connor was awarded the Cardinal Cooke Award by the Archdiocese of New York.

Mr. O'Connor has been a member of veterans' organizations for over 40 years. He is the Commander of Ossining Veterans of Foreign Wars Post #1041, Vice Commander of Ossining American Legion Post #506, and Chairperson of Ossining Central Committee of Organized War Veterans.



## Louis Joseph Picarazzi

Louis Joseph Picarazzi, a lifelong resident of Selkirk, New York, has dedicated his life to service through military duty, public leadership, and community volunteerism. Born in 1931 to Domenick and Maria Picarazzi, Italian immigrants from the Lazio region, Mr. Picarazzi was the first of their nine children to be born in the United States. Raised during the Great Depression, his early life was shaped by the values of hard work, humility, and strong community bonds.

In 1951, Mr. Picarazzi answered the call of duty by enlisting in the United States Air Force during the Korean War. He served honorably until 1955, achieving the rank of Staff Sergeant and earning several commendations, including the Good Conduct Medal and the National Defense Service Award. His military service was nationally recognized in 2024 when he was honored as the "Veteran of the Game" by the New York Yankees during a televised tribute.

Following his military service, Mr. Picarazzi began a long and respected career with the United States Postal Service. In 1964, he was appointed Postmaster of the Selkirk Post Office by President Lyndon B. Johnson, a position he held for nearly 30 years. Under Mr. Picarazzi's leadership, the Post Office was more than just a mail center – it became a vital community hub, connecting rural residents with government services and with one another. His detailed historical account of the Selkirk Post Office remains preserved in the Bethlehem Town Archives.

Beyond his professional accomplishments, Mr. Picarazzi has been a stalwart of the Selkirk Fire Department, having served as a volunteer firefighter for over 75 years since joining at the age of 18. His steadfast presence at local fundraisers, farmers markets, and civic events – along with his iconic handcrafted wooden American flags – has made him one of the most recognizable and beloved figures in Bethlehem. Affectionately known as the "Mayor of Selkirk," Mr. Picarazzi's life is a testament to public service, patriotism, and the enduring power of community.

Now in his 90s, Mr. Picarazzi continues to inspire all who meet him, representing the very best of the American spirit.

### THOMAS PIKE

Thomas Pike served in the United States Army and achieved the rank of Colonel.

A native New Yorker, Mr. Pike served for over 30 years with the Armed Forces. He grew up in Manhattan and attended school on the Upper East Side. His career as a military intelligence officer prominently featured support for the Global War on Terrorism, where he held multiple leadership positions of increasing responsibility.

His commitment to service included five deployments—three to Afghanistan and two to the Balkans, where he held several leadership positions. During his final deployment, he served as the Director of Counterintelligence and Human Intelligence (HUMINT) for the International Security Assistance Force (ISAF) in Kabul, Afghanistan, providing critical support to U.S. and NATO forces. He returned to the United States to take command of a brigade.

In 2018, Mr. Pike returned to his New York City roots with his family. His final military assignment involved supporting the Federal Emergency Management Agency (FEMA) at its downtown Manhattan office. He assisted in several emergency response missions, including earthquake relief in Puerto Rico, a hurricane response in the U.S. Virgin Islands, and assistance to 50,000 Afghan refugees at Fort Dix, New Jersey following the fall of Kabul in 2021. His most extensive mission came during the COVID-19 pandemic, when he leveraged Department of Defense medical support at the Javits Center and 11 public hospitals in New York City. He subsequently assisted with FEMA's vaccine initiative, coordinating Navy and Air Force units as they administered vaccines in underserved communities in Queens and Brooklyn.

Today, Mr. Pike focuses on mentoring the next generation, teaching leadership and responsibility to children and teenagers across New York City. He serves as the Assistant Commandant for the Knickerbocker Greys, a historic after-school cadet corps for boys and girls established in 1881. Additionally, he leads the Military Order of Foreign Wars in New York, a non-profit organization supporting veterans' issues, youth development, and military history.

An accomplished author, Mr. Pike has published three books—two on the Vietnam War and one chronicling the history of the Knickerbocker Greys. He is frequently invited as a guest lecturer on topics related to the Vietnam War, intelligence operations, and critical infrastructure preparedness, where he shares his expertise with diverse audiences.

Mr. Pike's awards include three Legions of Merit, three Bronze Star Medals, three Defense Meritorious Service Medals, and the Combat Action Badge.

## ANTHONY RABASCO

Anthony Rabasco served in the United States Army during the Korean War and achieved the rank of Staff Sergeant.

Mr. Rabasco was born in January 1928, and shortly thereafter, our Nation sank into the Great Depression. His father, an immigrant from Italy, struggled to make ends meet, so at a young age, Mr. Rabasco went to work. Whether it was shining shoes, carrying blocks of ice up four-story walk-ups, or restocking sodas, he worked to help his family make ends meet.

While still a teenager, Mr. Rabasco was hired by electricians because they were impressed by his curiosity and knowledge. Over time, he learned the trade that carried him through much of his career. When he graduated from high school in 1947, Mr. Rabasco chose to enlist in the Army. However, before being called for active duty, he passed his electrical master's exam for the City of New York and was prepared to open his own business.

Once in Korea, Mr. Rabasco served as a member of the Signal Corps, providing communications links between headquarters and the frontlines. Due to the nature of his work, he served in combat duty for as long as two months at a time. Mr. Rabasco suffered from severe frostbite and recurring malaria before returning home in April 1952. He earned four Bronze Stars and a field promotion to Staff Sergeant.

Gradually, Mr. Rabasco acclimated to being home, and in 1955, he and his partner opened Metro Electric, specializing in large commercial work, postwar housing, and work on the trolley car in Yonkers. After several years, Metro Electric was reorganized into Bosco Electric, of which Mr. Rabasco became the owner. When that venture ended, he discovered a new opportunity as an Electrical Inspector working with various firms. He passed Electric General, followed by One- and Two-Family Dwellings exams in 2009 at the age of 81.

Mr. Rabasco has four devoted sons, two grandsons, Joshua and Benjamin, and one granddaughter, Jenna, who is graduating from R.O.T.C. at the University of Georgia. She is being commissioned as a Second Lieutenant in the United States Air Force.

### THE HONORABLE CHARLES B. RANGEL

The Honorable Charles B. Rangel served in the United States Army from 1948 to 1952 as a Staff Sergeant.

For his bravery and dedication to his Nation, Representative Rangel was awarded the Bronze Star. He earned the Purple Heart for his service in the Korean War when he led 40 United States soldiers from behind enemy lines despite being wounded himself.

Born and raised in Harlem, Representative Rangel graduated from DeWitt Clinton High School. He went on to earn a Bachelor's degree from New York University under the GI Bill in 1957. Three years later, he earned a law degree from St. John's University Law School.

In 1963, U.S. Attorney General Robert F. Kennedy appointed him Assistant U.S. Attorney for the Southern District of New York. He later served as an aide to the Speaker of the New York State Assembly and was counsel for the President's Commission to Revise the Draft Laws in 1966.

In March 1965, Representative Rangel participated in the famous voting rights march led by Dr. Martin Luther King, Jr. from Selma to Montgomery, Alabama. In 1966, he won a seat in the New York State Assembly, representing Central Harlem.

Known in his Harlem community as the "Lion of Lenox Avenue," Representative Rangel rose to become the first African American Chair of the powerful Ways and Means Committee. With a House career that spanned 46 years, he was one of the longest-serving members of Congress in American history.

Representative Rangel helped found the Congressional Black Caucus in 1971 and was a staunch defender of urban economic development and international trade. His assignment to the Ways and Means Committee gave him considerable influence over America's tax policy, and he shaped major bills that ranged from anti-drug policies to health care reform.

In 2003, Representative Rangel introduced legislation to reinstate the military draft, revisiting an issue he had worked on before his first House campaign. "How can anyone support the war and not support the draft?" he asked amid U.S. conflicts in Afghanistan and Iraq. He argued repeatedly that the government relied on disadvantaged and working-class enlistees to fight its battles. Representative Rangel also sponsored the Heroes Earnings Assistance and Relief Tax (HEART) Act to provide financial help to America's veterans. The bill became law on June 17, 2008.

Alphonse Joseph Ranni served in the United States Army and achieved the rank of Specialist 5<sup>th</sup> Class (E-5).

Born in Brooklyn, New York, Mr. Ranni is a veteran, business owner, and community volunteer. He graduated from John Adams High School in Queens and proudly served in the Army during the Vietnam War. Mr. Ranni was assigned to the 3<sup>rd</sup> Squadron, 5<sup>th</sup> Cavalry, 9<sup>th</sup> Infantry Division and took part in critical missions, including the battles of Hue City and A Shau Valley.

As an Armored Reconnaissance Specialist (MOS 11D), Mr. Ranni operated with the 101<sup>st</sup> Airborne and the 3<sup>rd</sup> Marine Division. For his service from September 1968 to August 1969, he was awarded numerous honors, including two Bronze Stars, two Purple Hearts, two Presidential Unit Citations, the Combat Infantry Badge, and several Army Commendation Medals.

After his military service, Mr. Ranni returned to civilian life and held various roles in the accounting field. He later pursued a career change and successfully owned and operated a United States Customs Bonded Container Station at JFK Airport, a business he managed for over 25 years.

Mr. Ranni is active and engaged in the Queens community where he resided as a young child. Now retired, he dedicates his time to volunteering with local service and veterans' organizations.

Mr. Ranni is a life member of the Veterans of Foreign Wars (VFW), Disabled American Veterans (DAV), and Vietnam Veterans of America (VVA) Chapter 32, where he currently serves as Treasurer.

## BING CROSBY REAVES SR.

Bing Crosby Reaves Sr. served in the United States Army and achieved the rank of Master Sergeant.

Mr. Reaves is a decorated veteran, law enforcement professional, and community leader with a lifelong commitment to service. Born and raised in St. Petersburg, Florida, he relocated to Rochester, New York in 1970 after graduating from high school. Shortly after, Mr. Reaves began working for the City of Rochester Recreation Department before joining the New York State Mental Health system.

On November 11, 1971, Mr. Reaves was drafted into the U.S. Army, where he trained in Air Defense Artillery at Fort Bliss, Texas. After a brief assignment at Fort Ord, California, he was deployed to the Republic of Korea, serving 12 months with Alfa Company, 2/61<sup>st</sup>, and voluntarily extending his service by three months for an early discharge. Mr. Reaves later joined the 817<sup>th</sup> Medical Evacuation Unit before returning to his civilian job in mental health.

Seeking new challenges, Mr. Reaves transitioned to law enforcement and joined the Rochester Police Department (RPD), where he served with distinction for 32 years. Rising through the ranks to Sergeant, he worked as a patrol officer, sex crimes investigator, evidence technician, and booking sergeant, earning multiple awards for his lifesaving actions and exemplary service.

During his time with the RPD, Mr. Reaves reconnected with the military, joining the U.S. Army Reserve. Over 34 years in the 98<sup>th</sup> Division, he rose from Private to Master Sergeant, serving as First Sergeant of the 98<sup>th</sup> Division Band and as the Division Color Sergeant for over two decades. Mr. Reaves's contributions to operations and training helped lay the foundation for what is now Homeland Security. His service earned him numerous awards, including the Meritorious Service Medal and the Army Commendation Medal with four oak leaf clusters.

In retirement, Mr. Reaves remains deeply involved in veterans' organizations. He organizes the Rochester Memorial Day Parade, serves on multiple veteran advisory boards, and holds leadership roles in the VFW, American Legion, and Korean War Veterans. Mr. Reaves also educates the community on Buffalo Soldiers' history, continuing a 30-year tradition.

A devoted husband of 39 years and a father, Mr. Reaves has raised a grandson who now serves in the Navy. His lifelong dedication to service, leadership, and advocacy continues to leave a lasting impact on his community and beyond.

## SALVATORE RICCOPONO

Salvatore Riccobono proudly served in the United States Army Medical Corps from 1965 to 1967 and achieved the rank of Specialist E-4.

Stationed in Vietnam from May 1966 to May 1967, Mr. Riccobono was part of a combat support group for helicopter medical evacuation and the 93<sup>rd</sup> Evacuation Hospital. He participated in medevac missions and humanitarian flights to remote Montagnard villages – areas with no roads, electricity, or running water – bringing care and relief to those in need.

After his military service, Mr. Riccobono dedicated himself to protecting his fellow citizens as a New York City Police Officer. Assigned to the East Village on Manhattan's Lower East Side, then one of the City's most volatile neighborhoods, he spent over a decade in a plainclothes unit, working to remove dangerous criminals from the streets. Though the work was challenging and the pay modest, Mr. Riccobono took great pride in making his community safer.

In 1977, Mr. Riccobono joined the American Legion in Queens, New York. When he moved to St. James in 1999, he continued his involvement and, in 2000, became a member of VFW Post 395 (Sgt. John W. Cooke Post), where he currently serves as Junior Vice Commander. For over ten years, Mr. Riccobono has organized the Memorial Day and Veterans Day parades in St. James, ensuring local heroes are honored and remembered.

Mr. Riccobono is also a longtime member of the Greater St. James Civic Association and the Fraternal Order of Police.

He holds a deep love for the United States and the freedoms it offers – freedoms he has spent his life defending. From the jungles of Vietnam to the streets of New York, his unwavering belief in service, sacrifice, and patriotism has guided every chapter of his life.

Patrick R. Rourk served in the United States Air Force and achieved the rank of Chief Master Sergeant E-9.

## KEVIN SWAB

Kevin Swab served in the United States Army and in the Army National Guard. He achieved the rank of Major.

Serving for 24 years in the Armed Forces, Mr. Swab began his career in 1987 as a Rifle Platoon Leader before leaving for active service and deployment to Saudi Arabia during Operation Desert Storm in 1990.

In 1994, he was deployed again, supporting Operation Restore Democracy in Haiti before returning to the National Guard full-time in 2000 as a Battalion Operations Officer. Mr. Swab planned the deployment of soldiers for Operation Noble Eagle in 2001, the enhanced homeland security mission for his battalion, which provides soldiers to assist with security at commercial airports statewide.

Mr. Swab retired as a Major in 2009 and was awarded numerous recognitions, including the Meritorious Service Medal, Army Achievement Medal, Combat Infantryman Badge, Ranger Tab, and Airborne and Air Assault Badges.

After retiring, Mr. Swab worked for over 10 years as a Senior Military Science Instructor and for over six years as a Recruiting and Operations Officer with Cornell Army Reserve Officer Training Corps. Then he returned to service in the New York Guard, the State's self-defense force, where he was promoted to Lieutenant Colonel during the COVID-19 pandemic after being asked to come out of retirement to provide his expertise in joint task force operations.

In January 2022, Mr. Swab became the Director of Veteran Services for Cayuga County. He has gone above and beyond, spending countless hours to seek out veterans and ensure they are receiving support to help them lead better lives. Mr. Swab encourages the local veteran community to continue to uphold the Army values and serve others while building the camaraderie they had in service. He reminds them they are Versatile, Experienced, Trusted, Energetic, Resilient, Astute, and Noble.

Mr. Swab holds a deep Christian faith and serves as an Elder at Auburn Alliance Church, where he has attended services for over 28 years. He teaches Sunday School, is a small group facilitator, serves in the church nursery, and chaired the committee for a multimillion-dollar addition. Mr. Swab volunteers for many events with Auburn Alliance Church, including Night to Shine, and at the local Auburn YMCA-WEIU.

### NEIL D. THOMAS

Neil D. Thomas served in the United States Marine Corps from September 1994 to September 2002 and retired at the rank of Sergeant.

Mr. Thomas was assigned to the 2<sup>nd</sup> Platoon, Bravo Company, 1<sup>st</sup> Battalion, 13<sup>th</sup> Marine Expeditionary Unit (Special Operations Capable), also known as the "USMC Raiders." As Corporal, his excellence in Company B prompted him to fill additional key billets within his unit, which included Squad Leader, Assistant Chief Scout Swimmer, and Forward Air Controller.

As Scout Swimmer, Mr. Thomas was tasked with doing forward reconnaissance of the beach before the arrival of the remainder of the raid force. While serving as Rifleman, he maintained ground combat operations. His duties included locating, constructing, and camouflaging infantry positions; evaluating topographical information; maintaining field communications; performing minesweeping activities on land; and participating in basic reconnaissance operations.

During his time as Platoon Sergeant, Mr. Thomas operated as the principal advisor of his platoon to the First Sergeant and Company CO. He was responsible for 12 NCOs, 21 Marines, and one Navy Corpsman in aspects including their health, welfare, morale, discipline, and performance.

After retiring, Mr. Thomas joined the FDNY in Brooklyn from May 2002 through May 2005, where he acted as a first responder to all types of emergency situations. Additionally, he has provided over a decade of service to volunteer fire and EMS units.

Currently, Mr. Thomas serves as Captain of Special Operations for South Country Ambulance in Brookhaven, New York; holds the rank of Class A Firefighter for Bellport Fire Department in Bellport, New York; and is a Town of Brookhaven Fire Marshal. His resume also boasts numerous certifications, including EMT – Basic, Hazmat Operations, and U.S. Coast Guard Boat Operator/Rescue Procedures.

Mr. Thomas is a 1994 graduate of Eastport High School in Eastport, New York.

Mr. Thomas's integrity and confidence in crucial roles has left impressions on superior officers and civilians alike. He married Amy Thomas (née Price) in 2012, and he is a father to son, Hunter, and daughters, Lochlyn and Eastlyn. Mr. Thomas and his family reside in Bellport, New York.

## HECTOR VAZQUEZ

Hector Vazquez has spent his life in service, from the cockpit of a C-141B Starlifter as a Technical Sergeant in the United States Air Force to the streets of Manhattan.

Mr. Vazquez's journey began at Aviation High School in Queens, where he honed his technical expertise before enlisting in the Air Force in 1985. Initially serving as an Aircraft Technician, he soon transitioned into the role of Flight Engineer. After training in Oklahoma, he joined the 702<sup>nd</sup> Military Airlift Squadron.

His service spanned continents and conflicts. As a Flight Engineer, he supported critical missions worldwide, from Diego Garcia to the Arctic. During the Gulf War, Mr. Vazquez played a vital role in Operation Desert Shield and Operation Desert Storm, ensuring the success of military airlift operations.

After more than a decade in uniform, Mr. Vazquez returned to civilian life and settled in the Chelsea neighborhood of New York City. For over 25 years, he has been a persistent advocate for his community, working within the Tenant Association at NYCHA's Elliott-Chelsea Houses and, later, Fulton Houses. Collaborating with City agencies and local law enforcement, Mr. Vazquez has championed housing rights, public safety, and neighborhood improvements, ensuring his fellow residents have a voice.

His leadership extends beyond his block through his service as a member of Manhattan Community Board 4, among other local organizations, including the Hudson River Park Advisory Council, the High Line Neighbors Council, and the Whitney Museum Education Council. Mr. Vazquez also volunteers with Paws of War, an organization supporting veterans through the training of service dogs. This includes Mr. Vazquez's own dog, Jojo.

Perhaps his most meaningful contributions exist beyond his civic engagement. A cancer survivor, Mr. Vazquez's resilience is evident in the strength he brings to his family. As a proud father to Malia and Darien, he credits his late mother, a compassionate registered nurse, with instilling in him the values of perseverance, empathy, and unwavering dedication.

With a lifetime shaped by service, Mr. Vazquez remains steadfast in his mission to uplift those around him. He encourages others to step up and be the change their communities need. His motto is simple: "Get involved!"

### SCOTT M. WARD

Scott M. Ward served in the United States Army and achieved the rank of Lieutenant Colonel.

A native of Steuben County, New York, Mr. Ward was commissioned through the ROTC program at Cornell University in 1988. He served as an Infantry Platoon Leader, Light Armored Cavalry Troop Commander, Infantry Brigade Liaison Officer, Basic Combat Training Company Commander, and Battalion/Brigade Operations Officer.

In his first combat deployment, Mr. Ward served as a Senior Military Advisor of a Military Transition Team (MiTT) with the Iraqi Intervention Forces (IIF) in Fallujah, Iraq from 2004 to 2005.

After transitioning out of Iraq, Mr. Ward returned stateside and was recruited for a Battalion Executive Officer position by the incoming commander of the new Regional Training Center East at Fort Dix, New Jersey. He supervised combat service support personnel to prepare soldiers for mobilization to Iraq and Afghanistan. During his tenure, more than 4,500 soldiers underwent training.

From 2009 to 2012, Mr. Ward served as Installation Mobilization Officer at Fort Jackson, South Carolina. While there, he was given the additional duty of Deputy Director of Plans, Training, Mobilization and Security of the Installation. He was recruited to serve as the Officer in Charge of the South Carolina Agribusiness Development Team 3-49 in Helmand Province, Afghanistan in 2013.

Mr. Ward received numerous prestigious military awards, including the Bronze Star Medal (OLC), Combat Infantryman Badge, Expert Infantryman Badge, Air Assault Badge, Airborne Badge, Meritorious Service Medal (OLC), Army Commendation Medal (OLC), and the Army Achievement Medal (two OLCs).

After returning home to Steuben County, Mr. Ward has continued a life of service as a member of the Bath Central School Board, Vice President of the Steuben County Farm Bureau, Board of Directors of American Legion Charles E. Westcott Post 0173, and member of the Safety and Security Team at Victory Highway Wesleyan Church. He is a well-known agriculture education promoter for area schools, a GST BOCES Agriculture Advisor, and a member of Congressman Nick Langworthy's Agriculture Advisory Committee.

He and his wife, Kari, have three children, sons Bradley (Gabrielle) and Christopher (Alexandra), and daughter, Danielle (Chase) Howard. They currently own and operate Windydale Farm in Avoca, New York.

## PATRICK WEMITT

Patrick Wemitt is the embodiment of service to others. He served his country as a retired United States Marine Corps Sergeant E-5, his community as a civic leader, and the youth of Columbia and Greene counties as an educator and coach. Through his selfless contributions, Mr. Wemitt has left an indelible mark on our region, representing the ideal of good citizenship.

A lifelong resident of Chatham, Mr. Wemitt joined the Marine Corps in 1968, serving honorably for four years in Vietnam as an electronic repairman with a cryptography clearance. For his exemplary military service, he was decorated with multiple medals, including the National Defense Service Medal, Good Conduct Medal, Vietnam Service Medal with one bronze service star, Republic of Vietnam Campaign Medal, Rifle Marksman Badge, and Honorable Reserve Discharge Button.

Returning to his native Columbia County, Mr. Wemitt began a long and distinguished career in public schools, dedicating his life to the idea that all children deserve a first-class education. Over a three-decade career, he prepared countless young people for successful lives and careers, serving as a teacher, Assistant Principal, and Principal at both the elementary and high school levels. Mr. Wemitt spent 20 years in the Taconic Hills Central School District, followed by another decade in the Catskill Central School District. A devoted educator, he influenced generations of students, demonstrating exceptional patience, empathy, and mentoring abilities.

In our small towns and rural areas, engaged citizens like Mr. Wemitt are the lifeblood of the community, helping to run the organizations that create a vibrant civil society. He has served his home county in countless ways, including as President of the S.W. Smith Hook and Ladder Co. of the Chatham Fire Department, as a Village of Chatham Trustee, as Director of the Columbia County Agricultural Society, and as Director of the Columbia County Fair. Mr. Wemitt has coached several sports and has even acted in productions at Chatham's Mac-Haydn Theatre.

Mr. Wemitt credits his wife of 53 years, Joan, for all of his success and cites her unwavering love and support as the reason he survived Vietnam.

The greatness of a nation is measured by the work of upstanding citizens like Mr. Wemitt, who commit themselves to the greater good of their communities. The people of Columbia County are fortunate to count him as one of their own.

## MARK Woods, JR.

Mark Woods, Jr. served in the United States Army and achieved the rank of Major while serving in Iraq.

Born in Brooklyn, New York, Mr. Woods attended Catholic school and was inspired by his Vietnam War veteran uncle to pursue a military career. He attended The Citadel, excelling academically and as a leader, before being commissioned as a Second Lieutenant in the Army Infantry. His first assignment took him overseas to Berlin at the close of the Cold War. Mr. Woods served in the United Nations peacekeeping mission during the Bosnian crisis, earning his Blue Beret.

After four years in the Army, Mr. Woods transitioned to law enforcement, working as a corrections officer and border agent before joining the New York Police Department (NYPD). Stationed in Coney Island before 9/11, he later assisted in rescue and recovery efforts, an experience that shaped his life.

In 2005, Mr. Woods was recalled to active duty and deployed to Iraq for a year, where he worked in Civil Affairs to foster democracy in a war-torn city under constant threat. Upon his return, Mr. Woods rejoined the NYPD, serving in the Vice Squad and Joint Terrorism Task Force (JTTF). He was assigned to Vice to combat human trafficking and organized crime. He was subsequently transferred to the JTTF for his next assignment, where he fought United States-designated terrorist groups Hamas and Hezbollah.

After retiring from law enforcement, Mr. Woods devoted himself to veterans' advocacy. He was appointed Deputy Director of the Rockland County Veterans Service Agency, where he worked to secure housing, employment, and vital resources for his fellow veterans. Later, he led the Joseph P. Dwyer Peer Support mentoring program at BRIDGES, where he made a profound impact on veterans with post-traumatic stress disorder (PTSD).

Elected to the Clarkstown Town Council, Mr. Woods diligently worked to improve community services, including championing an accessible playground for children of all abilities. He continued his unwavering devotion to veterans, organizing meaningful trips for them.

On May 17, 2024, Mr. Woods passed away suddenly at the age of 54, an immense loss to his family, friends, and the entire Rockland community. Mr. Woods lived a life of honor, sacrifice, and leadership. His legacy of service and compassion earns him a rightful place in the New York State Veterans Hall of Fame.

## AARON YI

Aaron Yi is a proud United States Army veteran who served as a Private First Class E-3.

Mr. Yi was honorably discharged due to injuries sustained during combat training. He was born and raised in Flushing, Queens. He has consistently demonstrated a deep commitment to service and community.

After his medical retirement from the Army, Mr. Yi pursued higher education, earning an Associate degree from LaGuardia Community College and, later, a Bachelor's degree in Economics from Queens College.

During the COVID-19 pandemic, he enrolled in the Institute for Career Development's AbillTy Cisco Academy – a program created in partnership with the Mayor's Office for People with Disabilities to teach IT skills to students with disabilities. Although the Institute has since been dissolved, its mission lives on through Mr. Yi's ongoing commitment to empowering others.

Graduating from the program in May 2021, Mr. Yi became the first student to transition into a teaching role at the Academy, where he began as a teaching assistant. There, he provided accessible instruction tailored to students with diverse needs, drawing on his own journey as both a veteran and a student to create a meaningful, supportive classroom experience.

Mr. Yi's teaching philosophy – shaped by the Army's values of selfless service and never leaving anyone behind – continues to inform his approach to education and advocacy. Passionate about bridging gaps in healthcare and technology, he is now pursuing an Associate of Applied Science in Health Information Technology at SUNY Broome, preparing for a future at the intersection of patient care, data, and service delivery.

For his unwavering dedication to both country and community, Mr. Yi is being honored by State Senator John C. Liu as a 2025 inductee into the New York State Senate Veterans Hall of Fame. This recognition celebrates a journey of resilience, growth, and leadership – from soldier to student to teacher, and now to a future healthcare professional.

Rooted in Queens and driven by purpose, Mr. Yi continues to turn adversity into advocacy and service into a lifelong mission.
