# **COMMITTEE JURISDICTION AND OVERVIEW**

The New York State Senate Standing Committee on Civil Service and Pensions has legislative oversight responsibilities for initiatives concerning public employees and retired public employees. These initiatives range from legislation concerning employee benefits to amendments to the Retirement and Social Security Law.

During the 2018 Legislative session, 220 bills were referred to the Committee for its review. The Committee met on 8 occasions. The detailed legislative history of each bill referred to the Committee is available through the Civil Service and Pensions Committee link on the Senate's website (https://www.nysenate.gov/committees/civil-service-and-pensions), as well as from the Legislative Bill Drafting Commission. Additionally, a list of the bills referred to the Committee, along with each bill's final disposition, is provided at the end of this report.

In addition to its' regular Committee meetings, the Committee held two round tables and one public hearing. Following-up on the November 15, 2017 Public Hearing discussing the issues surrounding accidental disability retirement for governmental employees who participated in the World Trade Center rescue, recovery and cleanup activities, the Committee held two round table discussions, on February 18, 2018 and July 17, 2018. On September 17, 2018, the Committee held a Public Hearing to investigate the use of 9/11 line of duty sick leave, to determine whether the program is working and to discuss any changes that need to be made to the program.

# **COMMITTEE HIGHLIGHTS**

Key legislation enacted in 2018 includes the following bills that were referred to the Civil Service and Pensions Committee.

Chapter 426 of the Laws of 2018, sponsored by Senator Golden, provides that members of the New York State and Local Employees' Retirement System who retire with an outstanding retirement system loan will not face a permanent retirement annuity reduction due to the loan. When a retiree repays the loan in full, his or her retirement annuity payments will increase because the outstanding loan offset will have been eliminated. Members of the New York City Employees' Retirement System and the Board of Education Retirement System of the City of New York have enjoyed this benefit since the enactment of Chapter 511 of the 2005.

Chapter 448 of the Laws of 2018, sponsored by Senator Savino, removes the administrative burden associated with the process of offsetting a deficit in either the Member Contribution Accumulation Fund (MCAF) or Retirement Reserve Fund (RRF) with a surplus in the other account. Under prior law, the offset did not occur until retirement. By allowing the offset to occur before retirement, the retirement process will be smoother and more efficient.

Chapter 403 of the Laws of 2018, sponsored by Senator Parker, directs the President of the State Civil Service Commission to study and evaluate wages paid to public sector employees to determine if wage disparities exist. The President is required to report any wage disparities related to the job titles segregated by the gender, race and/or national origin of the employees in the title.

Chapter 419 of the Laws of 2018, sponsored by Senator Golden, addresses the City of New York's Plan to reduce the number of provisional City employees whose appointments are managed by the Department of City-Wide Administrative Services ("DCAS"). In 2008, the State Civil Service Commission approved the DCAS plan to reduce the number of provisional employees whose appointments are managed by DCAS. Since 2008, the Plan has been revised and the deadline for substantial compliance has been extended numerous times. This Chapter requires a DCAS to submit a revised plan to the State Civil Service Commission for approval. If, on December 31, 2021, there is not substantial compliance with the revised plan required by this Chapter, an Advisory Workgroup will be created to examine the provisional employee issue and submit to the Governor and the Legislature a single recommended plan for the reduction in the number of provisional employees whose appointments are managed by DCAS.

# NEW LAWS AND VETOES

In 2018, 49 of the 220 bills referred to the Committee passed both Houses of the Legislature. Of those 49 bills, the Governor signed 17 bills and vetoed 20 bills. As of December 27, 2018, the remaining 12 bills are on the Governor's desk awaiting approval or a veto. Collectively, 31 of these bills sought to amend the Civil Service Law, Education Law, and the Retirement and Social Security Law. Eighteen of these bills sought to amend the Unconsolidated Laws.
