Dear Colleagues:

We are profoundly disquieted by the actions of federal agents operating on the streets of Portland, Oregon. Their presence is in direct contravention of the declarations of both the mayor of Portland and the governor of Oregon, as well as both Oregon United States Senators, all of whom have demanded that the federal agents be removed. It is clear to us, the undersigned members of the New York Legislature, that the presence and actions of the federal agents in Portland, who operate without any identification or accountability, detaining citizens without warning or reason and violently attacking peaceful protesters, is an abuse of power and patently illegal. These activities smack of dictatorship and are wholly at odds with the U.S. Constitution. If allowed to continue unabated and without correction, we fear we will see such lawless federal forces on the streets of Buffalo, Albany or New York City.

While we join in the call by Senators Merkley and Wyden and Representatives Blumenauer and Bonamici for investigations into the presence and actions of unmarked federal agents in Portland, Oregon, we have little faith that either the Department of Justice or the U.S. Department of Homeland Security offices of Inspector General will conduct such investigations. Rather, we urgently call on you, as our state's representatives in Congress, to take immediate action to curb this federal lawlessness in Portland and prevent it from being replicated in any other location. The Customs and Border Patrol and the Department of Homeland Security must be required to respect the law and prohibited from operating as an unrestrained and violent federal police force within our country's boundaries and in our cities.

We stand ready to assist you in protecting our right to protest, the accountability and transparency of our government, and our democracy.
