# Senator Sanders Bring STEM / Tech Education to the Community with MLK Blueprints for Success Event

In commemoration of the Rev. Martin Luther King Jr. Day, a national day of service, State Senator James Sanders Jr. hosted a STEM / tech event in Far Rockaway on January 20, 2020. It was a full day of workshops, panel discussions and resource tables as well as entertainment - all aimed at encompassing the vision presented in Dr. King's famous speech, "What is your Life's Blueprint?" The event was co-sponsored by Assembly Members Clyde Vanel and Alicia Hyndman.

"Dr. King famously spoke about having a blueprint for life that includes the determination to achieve excellence in your various fields of endeavor, so it is only fitting that we honor his legacy with an educational event that will help community be prepared for a technologically advanced future," Sanders said. "The Rev. Dr. Martin Luther King Day Jr. is a day of service and we are proud to be serving Southeast Queens and beyond with this STEM focused event.

More than 100 people of all ages, both youth and seniors, attended the event. It was great to see the different generation learning together, side by side. The workshops tackled subjects like online banking, financial literacy and the environment. The green-themed classes explored wind energy by having attendees make and test fan blades out of different materials while another class explored creating new green spaces in one's own neighborhood by using Google Earth. In the area of technology sessions on block coding and how to use Microsoft Office were offered. There was even an opportunity to learn about aviation. The Black Pilots of America discussed how to get a pilot's license.

### 32BJ Rally (Albany) - Healthy Terminals Act

Senator James Sanders Jr. joined members of 32BJ SEIU in support of the NY Healthy Terminal Act (S6266C/A8142C), a bill which he has co-sponsored, that would provide transportation hub employees with a benefits supplement to help them access high-quality health care.

"I am a strong supporter of unions and of 32BJ," Sanders said. "These workers help to ensure that our city runs efficiently and they deserve proper healthcare."

The members of 32BJ include office cleaners, security officers, doormen, porters, maintenance workers, engineers, bus drivers and aides, window cleaners, school cleaners, and food service workers.

The bill would ensure that these workers who are employed at New York City's John F. Kennedy International Airport, LaGuardia Airport, Port Authority Bus Terminal, Pennsylvania Station and Grand Central Terminal can afford health insurance.

Assembly Member Felix Ortiz and Kyle Bragg, president of 32BJ, were also in attendance at the rally.

# **Hundreds Attend Senator Sanders Town Hall Meeting** on Sewage Spill in SE Queens



Hundreds of homeowners who were affected by the sewage spill attended the town hall meeting hosted by Senator Sanders at PS 223 in Jamaica on Sunday.

Senator James Sanders Jr. held a town hall meeting on Sunday, December 8, 2019 at PS 223 in Jamaica to address the recent sewage spill in Southeast Queens, which damaged some 300 homes over the Thanksgiving holiday weekend.

"This is a terrible and unfortunate incident to have happened, especially around the holidays," Sanders said. "My office will be working with the city and all of the appropriate agencies to help affected homeowners recover and resume their busy lives."

Senator Sanders was joined by other Queens elected officials and all relevant city agencies to provide residents with updates on the situation and answer their many questions. The primary concern people had regarded covering the cost of the cleanup and repairs to their homes, whether the cleanup crews dispatched by the city were qualified and any health repercussions stemming from being near the sewage.

Many homeowners have flood insurance, which does not cover disasters like sewage spills. All

affected residents may file a claim with the NYC Office of the Comptroller within 90 days of their loss. However, the Comptroller's Office will not begin to process claims until the Department of Environmental Protection determines the exact cause of the blockage. It is also important to note that if a person decides to hire a private lawyer, they forfeit their ability to file a claim with the Comptroller.

The exact cause of the blockage is still unknown, is being investigated and will take a few more days, according to DEP Commissioner Vincent Sapienza. The affected pipe, which is located 40 feet below ground, is hard to reach and excavate, leading to the delay. Areas heavily impacted by the sewage spill include the section of Jamaica near the Belt Parkway and Kennedy Airport.

The city has added a pump around system (a pipe at ground level that can carry the sewage away from the area), while the main pipe is being repaired. DEP and the Department of Health told residents

that the water in their homes is safe to drink because it is transported through different pipes.

The DOH also said they tested the air quality in the affected homes and nothing abnormal was detected. They also have an epidemiologist who will continue to evaluate the areas flooded by sewage. Senator Sanders told the DOH that he wants to receive continuous reports regarding their findings.

Deanne Criswell Commissioner of the NYC Emergency Management Department said all of the cleaning crews dispatched to homes by the city are qualified to perform the sewage removal services and that the work is evaluated by a city inspector once its completed to ensure it meets the highest standards and is conducted to the satisfaction of the homeowner.

Senator Sanders advised all of the city agencies that they need to be more proactive regarding the maintenance and cleaning of pipes and other infrastructure and to improve response times when unforeseen accidents do occur. Many residents complained about what they considered a poor performance by 311.

The city had set up an emergency center at the Courtyard Marriott, 145-11 North Conduit Avenue, Jamaica, NY 11436, to provide affected residents with resources.

Senator Sanders had a limited supply of cleaning kits available for pick up at his District Office for those who need the proper gear. He also had Comptroller claim forms.

We would like to thank PS 223 for the use of their space to host the event.

# Senator Sanders Hosts Leadership Dinner and Discusses the Epidemic of Human Trafficking



Many community and faith-based leaders attended the event.

Senator James Sanders Jr. held a community leadership dinner at the Springfield Gardens Church of the Nazarene on January 23, 2020, where experts and advocates presented important information on the global epidemic of human sex trafficking which is also afflicting the local community in Queens.

According to 2019 report by the U.S. Department of State, human sex trafficking is one of the most horrible crimes on Earth, impacting people's freedom and human dignity. It is reported that a figure of 24.9 million people are currently being sex trafficked.

"This is a serious epidemic and it is our duty to protect our community, particularly our youth, from being exploited for the purpose of commercial sex or forced labor," Sanders said. "We need to stop this victimization before it starts, because once these traffickers get a hold of someone they will use psychological and physical coercion to prevent them from leaving."

Among the speakers at Senator Sanders' event were representatives from UNITAS, an international humanitarian organization working to provide solutions in the fight against human trafficking, Detectives from the NYPD Human Trafficking Team, and Nicky Sunshine an actress, comedienne and writer, who shared her own experience of engaging in sex work as a massage parlor madam.

Lamont Hiebert, UNITAS Program Director, discussed the different types of human trafficking, which can include labor trafficking and sex trafficking and explained that all types usually involve force (violence, starvation, and confinement), fraud (lies, tricks, and false promises) and coercion (threats, debt bondage, and drugs). Youth are especially vulnerable

because the trafficker will identify the victim's need – food, clothing, shelter, etc. – and fill that void, leading the victim to become trapped and dependent.

Hiebert was joined by Tonya Turner, UNITAS Training and Education Director, and Dr. Coralanne Griffith-Hunte, UNITAS Board Member, psychologist and clinical trauma specialist.

"These victims feel broken," said Dr. Griffith-Hunte. "Trauma doesn't have an expiration date and when it comes to trauma, there is no onesize-fits-all solution."

If someone is being forced to engage in sex for money, a place to live, for other necessities, or because someone is holding their important documents like a passport, they may be a victim of trafficking, according to the NYPD. Detective Olashina Williams of the NYPD Human Trafficking Team explained that this crime is getting worse in Queens, with many young men choosing to pimp women instead of selling drugs

because they see it as a less dangerous way to make fast cash. When it comes to helping victims, Williams said, "You have to engage them where they are. They feel judged. They feel shame."

Nicky Sunshine spoke about her time as sex worker at a "rub and tug" massage parlor and admitted that she felt ashamed of what she was doing but became addicted to the easy money. "There's a value system in our society," she said. "As a black woman, I did not know how vulnerable I was." Now, she uses her platform as a public figure to educate and warn others.

The Rev. Lenroy Pascall, Pastor of the Springfield Gardens Church of the Nazarene, where the event was held, said he has noticed that more and more of his congregants have confided in him that they have been trafficked. "I don't think any human being should have to go through that," he said, adding that he believes the perpetrators must be experiencing some type of "spiritual and psychological madness" to commit such crimes.

Sanders distributed greeting cards, gloves, hats, scarves, socks, towels and other items which were donated by community members and groups such as P.S. 104 (The Bayswater School) – Far Rockaway, P.S. 176 (Cambria Heights), Alpha Kappa Alpha Sorority (AKA), August Martin High School, Blaque Resource Network, Females Making Moves, Flowers of Hope, House-A-Soldier, New York Racing Association (NYRA), Queensborough Community College and Success Academy.

"I would like to extend a special thank you to all of our donors, without whom this event would not have been possible," Sanders said. "Their generosity and commitment to helping this community will not soon be forgotten. I would also like to thank the New York State Veterans Home at St. Albans for their hospitality and allowing us to use their space to interact with their residents."

Also in attendance at the event were: April Jones, Founder of House-A-Soldier, who donated 10 new coats, Gina Vasquez, Founder of Flowers of Hope, who donated 30 new scarves, and long-time volunteer with Senator Sanders' Office, Ms. Lucille Fowler, who donated pants and other items.

The patients at the New York State Veterans Home at St. Albans have served in either World War II, the Korean War, Vietnam War, or Gulf War and have suffered a service-related injury that requires skilled nursing care. Others are spouses or dependents of military personnel, who receive medical or rehabilitative care. Residents range in age from 45 to 100 years old, and their stay can last anywhere from 6-8 weeks to the rest of their lives.

We would like to extend special thanks to Deirdre Samuel, Coordinator of Volunteer Services, at the NYS Veterans Home at St. Albans for helping to facilitate the event as well as the home's volunteers, many of whom are students at the Institute of Health Professions at Cambria Heights.
