**NYS Farm Labor Wage Board Decision** 

## FARM LABOR WAGE BOARD DECISION TO MAINTAIN OVERTIME THRESHOLD SUPPORTS ALL WHO DEPEND ON NY AGRICULTURE

The Farm Labor Wage Board made the right decision today to delay consideration of lowering the 60-hour farm labor overtime threshold during this unprecedented year. New York Farm Bureau President David Fisher supported Chair Brenda McDuffie's position of delaying a decision and avoiding any unintended consequences that could negatively impact New York's farmworkers, family farms and access to local food.

"I had encouraged giving the process more time to fully evaluate what a lower threshold would mean for all involved, especially with such limited data from this challenging year. I'd like to thank my fellow wage board members for their time and professionalism and encourage the Department of Labor to continue to work with the farming community to do what is best for our farms and employees. We need each other for agricultural production and our rural economies to flourish," said NYFB President Fisher.

New York Farm Bureau also thanks its members who testified and submitted written comments. The care they have for the men and women who are essential workers on their farms is evident. We all value their work and want the very best for farm employees, that includes the ability to earn a good livelihood in the profession they have chosen.

Late last week, the New York State Farm Labor Wage Board decided to delay a decision on lowering the 60-hour overtime threshold (the public comment from the New York Farm Bureau regarding the decision is posted above). I'm pleased that common sense and our advocacy prevailed! This was good news for our hard-working family farmers. Our farmers have such a small profit margin, meaning they cannot pay time and a half. I hope when the time comes to reevaluate, the Farm Labor Wage Board will see that lowering the 60-hour overtime threshold is not a good idea.

#### Columbia County COVID-19 testing update



At-home COVID-19 testing is available: LabCorp currently offers an at-home COVID-19 test, which can be viewed <u>here</u>. This test does not detect antibodies or immunity. It is designed to determine active infection with the virus that

causes COVID-19. After completing a short eligibility survey, choose a billing option, which can be through personal insurance, the use of federal funds to cover the cost of this test if uninsured, or with a credit card. The test kit will arrive via FedEx. After collecting and returning the sample, the average time to deliver results is one-two days from when the sample is received at the lab, according to LabCorp.

According to the Columbia County Department of Health, individuals who are 75 years or older may now call or email the Department of Health to register their names to sign up for COVID-19 vaccination when vaccinations for that group become available.

INDIVIDUALS WHO ARE 75 AND OLDER WHO CALL OR EMAIL TO SIGN UP SHOULD NOT EXPECT TO RECEIVE A RETURN CALL OR EMAIL AT THIS TIME. THOSE INDIVIDUALS WILL BE CONTACTED ONCE VACCINATIONS FOR THOSE 75 AND OVER ARE AVAILABLE. ONCE THAT PHASE BEGINS, THOSE WHO HAVE SIGNED UP WILL RECEIVE A CALL OR EMAIL WITH INFORMATION ABOUT WHERE AND HOW TO RECEIVE THE VACCINATION.

VACCINATIONS WILL BE ADMINISTERED AT MOBILE CLINICS RUN BY THE COLUMBIA COUNTY DEPARTMENT OF HEALTH. AT THIS TIME, THE DEPARTMENT OF HEALTH DOES NOT HAVE INFORMATION ABOUT WHICH TYPE OF VACCINE WILL BE AVAILABLE NOR THE SPECIFIC LOCATIONS OF THE MOBILE CLINICS.

#### Phase IA

New York State is currently in Phase IA of the vaccination program. This is the phase during which only healthcare providers and nursing-home and long-term care employees and residents are receiving vaccinations.

#### Phase IE

Phase IB is the phase during which individuals who are 75 years or older will be eligible for COVID-19 vaccination. According to New York State, this will be the next vaccination phase of the state's vaccination program. Columbia County Department of Health hopes to begin this next phase — which can only begin under directive from the NYS Health Department — by the end of January. Columbia County Health Department emphasizes that this timetable is not guaranteed. The timetable depends on vaccine availability and distribution.

## Current updates regarding the COVID-19 vaccine



Group 1a qualifies to receive the vaccine first, this includes healthcare workers. There are 2 million healthcare workers in the state, and there are 900,000 vaccines. Distribution is not the issue, but supply is.

Group 1b will be receiving the vaccine second, which includes police officers, firefighters, teachers, public safety, and those over 75-years old. There are 3 million people in this category, and the vaccines will be distributed by private sectors, including EMS/EMT for first responders, pharmacies for residents over 75, and health networks within schools and public safety for the teachers and public safety workers. Again, distribution is not the issue, but the short of supply is.

Be assured that our NYS hospitals are making real progress. They are now administering over 50,000 vaccinations a day. In the meantime, stay safe. We are all in this together!
