Standing up for our police

Just days after the observance of National Law Enforcement Appreciation Day, my Senate Republican colleagues and I once again stood up for our dedicated police officers in response to a political lawsuit recently filed by the New York State Attorney General against the New York Police Department. I will always proudly, and strongly, stand with the men and women of law enforcement. My Senate Republican colleagues and I oppose this political lawsuit that will make the already incredibly difficult job of our brave NYPD officers even harder. NYS SENATE REPUBLICANS BLAST POLITICAL ASSAULT ON NEW YORK'S

New York State Senate Republican Leader Rob Ortt and members of the Senate Republican Conference today expressed their outrage with New York Attorney General Letitia James's announcement of a brazenly political lawsuit against the New York Police Department. Today's announcement comes after last summer's riots, looting, and senseless other destructive acts were estimated to have cost New York City residents and businesses tens of millions of dollars in property and personal damages. Adding a federal monitor will make the NYPD's job even more difficult as they deal with a rising crime rate (shootings up 100% in the city), a once in a lifetime pandemic, and a hostile Democratic Legislature that has made anti-cop legislation a priority.

"In a time when the brave men and women of our law enforcement are under constant barrage, today's announcement by the Attorney General serves as nothing else but a political attack against the NYPD for doing their jobs. Last summer's riots in New York City were not the result of the NYPD. Last year's skyrocketing violent crime rates in New York City were not the result of the NYPD. Outside forces, when combined with awful rhetoric and policy coming out of New York City and State Democrats, made for the environment we see today. This lawsuit will do nothing to protect law-abiding New Yorkers and do everything to further undermine New York's finest. Our conference stands with our NYPD and all local enforcement around the state," said Senate Republican Leader Rob Ortt.

Frustration and questions amid New York State's COVID-19 vaccination rollout

My office has received numerous inquiries regarding the availability of the COVID-19 vaccine and determining eligibility. To find out if you are eligible for the COVID-19 vaccine at this time, you can visit the New York State website <u>here</u>. Unfortunately, the online system is overwhelmed right now. A second option is calling the state hotline to make an appointment for vaccination at 1-833-NYS-4-VAX (1-833-697-4829).

I've also heard from many of my constituents who are understandably frustrated and rightfully concerned with New York State's disorganized, chaotic, and confusing rollout of the COVID-19 vaccine. I share your concerns and want this broken process fixed ASAP! My message that I recently shared on my Senate Facebook page regarding the need to fix New York's broken COVID-19 rollout program is directly below.

"Constituents have shared that their calls to the state's vaccination hotline (1-833-NYS-4-VAX or 1-833-697-4829) have only caused frustration. Constituents have also shared that when they've called that number – at all hours of the day – they only get an automated message and are disconnected. That needs to stop: the state hotline needs to be staffed with real people who can answer real questions. There are literally thousands of employees all across state government. Just as I advocated in addressing New York's massive unemployment claim backlog in the spring and summer, we need to get people answering the phones who can provide real assistance.

Our counties are 100% ready, willing, and able to carry out emergency plans that they've had for years yet have been given little to no vaccine supply to work with. Some vaccines have even been thrown away due to state protocols of only distributing to the group in Phase 1A, but not having enough people in that category show up, while thousands of other residents remain waiting.

That's unacceptable. The state's approach is overly bureaucratic and isn't working. Local governments – counties like Rensselaer, Saratoga, Columbia, and Washington – have previously performed mass vaccinations, have multiple distribution sites already set up, and can get the job done, safely, effectively, and expeditiously. Albany needs to stop micromanaging this process and start empowering local governments.

The vaccine rollout by the State has been neither thoughtful nor effective. That's why I'll continue fighting for a better process. My Senate Republican colleagues and I will keep pushing the Governor and State Department of Health to fix this broken process and get COVID-19 vaccines out the door to local governments ASAP."

SENATE REPUBLICAN LEADER ORTT, ASSEMBLY REPUBLICAN LEADER BARCLAY PRESS HEALTH COMMISSIONER ON STATE'S SLOW VACCINE ROLLOUT

Republican Leaders in the state Legislature today penned a letter to Department of Health Commissioner Dr. Howard Zucker, former-Secretary to the Governor Larry Schwartz, and Secretary of State Rossana Rosado imploring officials to answer several questions about the state's vaccine rollout and distribution efforts.

Members from the Senate and Assembly Minority Conferences were briefed by Dr. Zucker and Mr. Schwartz on Tuesday, January 5th about the state's vaccine distribution. However, only five legislators were given the opportunity to pose questions pertaining to the state's delayed vaccine rollout.

"While we appreciate the Health Commissioner taking the time to speak to our Conference and field questions from our members, unfortunately, many questions went unanswered and, in some instances, we were given mixed messages and conflicting information. The bottom line is the vaccine rollout throughout the state has been inefficient and ineffective, and I look forward to getting the answers that we, and all New Yorkers, deserve," said Senate Republican Leader Rob Ortt.

"The early stages of the state's vaccine rollout and distribution plan is already behind, and quite frankly, it's inexcusable. New Yorkers need to be confident in the state's expedient and thorough distribution of the vaccine, and the current plan is not instilling that confidence. Dr. Zucker must address a number of questions – that remain unasked and unanswered – regarding the vaccine's distribution, including why New York State is being outperformed by other states' ability to administer vaccines to their residents," said Assembly Republican Leader Will Barclay.

Senator Daphne Jordan named Ranking Republican Member on Senate Racing, Gaming and Wagering Committee, Senate Libraries Committee, Senate State-Native American Relations Committee, and Senate Women's Issues Committee

On Thursday morning, Rensselaer County Executive McLaughlin delivered an optimistic, hopeful, and energetic State of the County during a virtual address to the Rensselaer County Regional Chamber of Commerce, saying the County will meet the challenges presented by the pandemic and return to prosperity. County Executive McLaughlin noted the County's history and heritage of innovation, industry, and ingenuity, and said those characteristics will again serve the County well during 2021.

"We have seen major challenges before, and responded with excellence, innovation and ingenuity. That spirit is needed again in Rensselaer County," said Rensselaer County Executive McLaughlin.

"Today, I am calling on you, the leaders of our county in business, education, technology, government, and agriculture to use your skills, talents, optimism and energy to restart and revitalize in 2021. Let's return to our winning ways," added Rensselaer County Executive McLaughlin.

The County has worked to be well-positioned in the new year. All three of Rensselaer County Executive McLaughlin's budgets have included tax decreases and been adopted unanimously. The County successfully paved 50 miles of roads in 2020, a record, with the county paving over 105 miles during McLaughlin's three years as Executive. The County's bond rating has also been upgraded during McLaughlin's service as Rensselaer County Executive.

The County has also seen historic job creation with the Amazon project in Schodack and the ongoing expansion at Regeneron Pharmaceuticals in East Greenbush. Other projects in Troy and surrounding towns have also created new jobs and opportunity. The County has also seen encouraging returns on sales tax numbers in 2020, one year after leading the state in sales tax growth. "Every day presents an opportunity. We believe we have made the best of the opportunities given to us in Rensselaer County, and improved on our foundation for growth, investment, and job creation. As a County, we have also taken hard hits during 2020 but responded with courage, compassion, innovation, and hard work. We can achieve great things and look forward to working with all of you to make 2021 an historic year of comebacks and

new victories," said Rensselaer County Executive Steve McLaughlin.

The County's response to the pandemic has been inspiring and shows the strength and resiliency of the County, noted Rensselaer County Executive McLaughlin. When the County was unable to secure a test site, the county paid to establish an independent COVID-19 testing facility, the only county in the region to make such an investment. The facility has played a role in providing nearly 160,000 tests in the County.

Rensselaer County Executive McLaughlin also pointed out the outstanding work of county government during the pandemic by the Health Department, County Aging Department, and other departments. He also noted the important role vaccines will play in restoring the economy.

"The Health Department and Mary Fran deserve special recognition and thanks. They have been on the frontlines battling the outbreak seven days a week since February. They have given so much over these difficult months to keep us safe, while essentially putting their own lives on hold. We owe them great thanks for their service. Their work during these difficult months represents the finest service our county can offer," said Rensselaer County Executive McLaughlin.

Advocating for the Dwyer Program to help our veterans

Dear Senator Brooks,

It has come to our attention that neither the Office of Mental Health (OMH) nor the Division of the Budget have been directed by the Senate Majority to release funding allocated in last year's budget for the Joseph P. Dwyer Veterans Peer-to-Peer Support Program. It is discouraging to see this critical funding held up, particularly amidst the current pandemic and the strain it has placed on the mental health of our New Yorkers' -- including our veterans.

The Legislature has consistently worked in a bipartisan fashion to fund the Dwyer program since its inception in 2012, helping veterans in twenty-four counties and New York City. The Senate Minority Conference writes you today to urge the Senate Majority to immediately take the steps necessary to make available the \$4,505,000 allocated in the 2020-2021 State Budget, as well as the remaining allocation for the program from the 2019-2020 State Budget.

The mission of the Joseph P. Dwyer Program, to connect veterans suffering from post-traumatic stress or traumatic brain injury, has only become more important during the COVID-19 pandemic. At a time when social isolation aggravates mental illness and substance-abuse issues, the Joseph P. Dwyer Peer to Peer Support Program provides an invaluable lifeline for veterans. Additionally, as the economy continues to struggle, the Joseph P. Dwyer Program is an invaluable support for veterans struggling with housing and employment issues.

The Senate Minority Conference fully understands the fiscal limitations posed by the pandemic — however, the Joseph P. Dwyer Peer-to-Peer Support Program is crucial for ensuring the well-being of veterans in New York State.

Our veterans continue to sacrifice so much for our state and our country. As policymakers, we often look for opportunities to honor their service. New York State made a commitment to our veterans; it's incumbent upon us to honor that commitment.
