Statement from the NY National Guard:

Killed in the January 20 crash of a UH-60 Black Hawk were Chief Warrant Officer 5 Steven Skoda, Chief Warrant Officer 4 Christen Koch, and Chief Warrant Officer 2 Daniel Prial. These Soldiers were a part of our National Guard family and we mourn their loss, alongside their family members and loved ones. The New York National Guard will be there for these family members as they navigate these trying times. Our chaplains and casualty assistance officers will be with them whenever needed. Our service members wish to extend their heartfelt thanks to the members of law enforcement, first responders, and the community at large for their support and sympathy during this trying time."

Let them play



Late last week, Governor Cuomo allowed for high risk school sports to be played starting February 1, but the initial decision has to be made by County Departments of Health. Many parents, students, and coaches have been speaking out, advocating for the local departments to allow the students to play, and rightfully so! The largest number of tweets came from my hometown school, Shenendehowa. My answer to Shen parents and students was "I believe Shen and other schools can provide their student-athletes with a safe season."

Just yesterday, Rensselaer County approved the return of high risk school sports without restrictions to begin this Monday. Today, Saratoga County has joined Columbia County in allowing high-risk sports to resume IF their county can get at or below a 4% threshold for a rolling seven day average on positivity rate of COVID-19 tests. Washington County has not yet made a decision. While the counties have deliberated and set their parameters, individual school districts will have the final say over whether they'll participate in high-risk sports. Our student athletes deserve to play in the sports they've worked so hard in. Let safe practices start and then let the games begin!

This week's Committee Highlight: Agriculture



I am proud to serve on the Senate Agriculture Committee and was happy to be a part of the virtual meeting earlier this week (pictured above). During our Committee meeting, we moved bills out of Committee on their trek to possibly reaching the Senate floor for a vote. The bills dealt with penalizing animal fighting, improving urban and rural access to locally produced healthy foods; requiring veterinarians to notify owners of potential risks and side effect of medication prior to prescribing the medication to an animal; including agricultural custom operators as entities eligible for agricultural protections; and the expansion of regional farmer's markets to specifically targeted food deserts. Upstate New York is in the top-ten national producers for cow milk, apples, grapes, onions, sweet corn, and many other products! I am a strong advocate for our farmers and will always stand up for them and what they do for our economy.

Plan to reset NY's restaurant & hospitality industry





New York's restaurant and hospitality industry face staggering financial challenges caused by COVID-19 and the economic closures. Our package of legislation unveiled this week will provide much-needed assistance to these sectors that employ hundreds of thousands of New Yorkers and are vital small businesses that support local communities.

One of the bills featured in our package, my "Save Our New York State Restaurants Act," is bipartisan legislation that would create a 30-day sales tax exemption for food and drinks sold at restaurants and taverns to bring attention and business to our restaurants and also bring in customers that may not have otherwise planned on eating out. Restaurants and taverns need the state to step up and deliver this much-needed support and assistance now before they are forced to close their doors forever and cost our economy even more jobs.

The restaurant, service, and hospitality industries are the lifeblood of so many local economies. Before the pandemic, restaurants, and food service jobs employed nearly 900,000 New Yorkers and generated over \$3 billion in revenue to our state, and because of coronavirus, these industries have been devastated, and these jobs are disappearing. Nationwide, 74 percent of unemployment claims are from restaurant workers. Over 365,000 residents who work at restaurants have lost their job in the past year. Now we're facing fewer locally owned businesses, fewer jobs, and a lesser quality of life for every New Yorker. If we're going to help the record number of out-of-work New Yorkers and keep beloved local establishments open, we must act now.

That's why on Tuesday, my Senate Republican colleagues and I announced legislation to help accomplish that. Our bills would provide immediate support and relief, keeping small businesses open and thousands employed. Specifically, our plan would:


- Cap the service and delivery fees internet-based food service providers like GrubHub and DoorDash charge local restaurants;
- Give the State of New York Mortgage Agency the ability to provide interest-free loans or lines of credit;
- Provide a fee-less one-year extension of liquor licenses that expired during the pandemic;
- Allow businesses an additional 90 days to pay any monthly sales and payroll taxes, as well as 90 days to pay any fees and penalties from state and local agencies;

• Provide an additional 60 days for businesses to pay any business or property taxes; and

• Give an exemption from unemployment insurance rate increases to small businesses who are forced to terminate an employee.

New Yorkers are scared and need our help. Our service, hospitality and restaurant industries are suffering. Taking immediate, decisive action now will make years of difference, and we can protect the livelihood and preserve the paychecks of so many hardworking New Yorkers.

Fighting for our fair share in transportation funding



In his budget proposal this year, Governor Cuomo is shortchanging our roads and bridges.

He's looking to spend over \$50 BILLION on the MTA and downstate projects, but less than \$12 billion total for the rest of the state. On a year-to-year basis, the Governor's plan includes 70 percent more in funding annually to New York City transportation than to the rest of the state.

As if this wasn't bad enough, the Governor wants to slash \$65 million in Extreme Winter Recovery funding. This would be a disaster for our communities, where our roads and bridges receive a beating all winter long from snow and ice. Infrastructure funding is crucial to our economy and creating good jobs, as well as keeping our residents safe. There's more to New York State than just the City, and all regions of our state must be treated equally.

In past years, our Senate Republican Conference has successfully fought for and delivered parity in transportation funding. For the sake of all our residents, this must continue. We need and deserve a fair share of transportation funding. As State Budget hearings begin and negotiations commence, I am going to push back against the Governor's unfair proposals. NYS Attorney General Letitia James issues stunning report on nursing homes' response to COVID-19



Nursing Home Response to COVID-19 Pandemic

January 2021

New York State Attorney General Letitia James yesterday issued a comprehensive report that made clear what I, and so many legislators and advocates such as FOX News Senior Meteorologist Janice Dean (who I proudly stood with), have been saying for months: the State Department of Health (DOH) was intentionally misleading New Yorkers on the true extent of the tragic deaths from COVID-19 that occurred in nursing homes across our state. The extent of the misinformation and, frankly, obfuscation from the leadership of the State Department of Health on this matter is breathtaking. One of the many takeaways of the Attorney General's report was that the DOH drastically undercounted the number of nursing home deaths by nearly 50%. Other key findings from the Attorney General's report included the following:

- As much as 50% more nursing home residents died from COVID-19 than DOH data reflected;
- Lack of compliance with infection control protocols put residents at increased risk of harm;
- Nursing homes that entered the pandemic with low U.S. Centers for Medicaid and Medicare Services (CMS) Staffing ratings had higher COVID-19 fatality rates;
- Insufficient personal protective equipment (PPE) for nursing home staff put residents at increased risk of harm;
- Insufficient COVID-19 testing for residents and staff in the early stages of the pandemic put residents at increased risk of harm;

• The current state reimbursement model for nursing homes gives a financial incentive to owners of for-profit nursing homes to transfer funds to related parties (ultimately increasing their own profit) instead of investing in higher levels of staffing and PPE;

- Lack of nursing home compliance with the executive order requiring communication with family members caused avoidable pain and distress; and
- Government guidance requiring the admission of COVID-19 patients into nursing homes may have put residents at increased risk of harm in some facilities and may have obscured the data available to assess that risk.

Without question, we need, as I've been calling for since last spring, an independent state-federal investigation into New York's nursing home tragedies to provide answers, accountability, and transparency. I also have called for State Health Commissioner Zucker to tender his resignation in light of this growing scandal and for deliberately misleading New Yorkers.

RE: Allowing the statewide reopening of billiard halls

Dear Governor Cuomo:

I write to follow-up on my correspondence issued October 1, 2020, requesting that the Empire State Development Corporation, under your direction, develop a plan for the immediate safe reopening of billiard halls throughout New York State.

Today, I write respectfully requesting your administration's urgent consideration of the recent New York State Supreme Court decision (370 BREWERTON ROAD, LLC d/b/a Brick House Billiards Bar and Restaurant et al., v. ANDREW M. CUOMO) that provided preliminary injunction relief allowing 16 billiard halls across New York State to reopen following phase four rules for indoor entertainment. The lead attorney for the plaintiffs stated that the court's preliminary ruling means that billiard halls could operate much like bowling alleys or casinos, which are presently functioning at 50 percent capacity in accordance with state requirements. While the case awaits a final ruling, Judge Neri's issuance of preliminary injunction relief bodes well for the 16 billiard halls that brought this legal action.

As stated in my letter from October, billiard halls – which have been closed in New York State since March 16, 2020 – have made sanitation and cleanliness a top priority. In many venues, patrons will be provided their own sanitized billiard balls and cue sticks to use and will be directed to go to an assigned sanitized table. Billiard halls also can provide a unique, socially distanced, safe experience for patrons as they are specifically centered around reserved table spaces and times. Groups stay at their assigned table rather than coming and going from their table to other social spaces within the business.

Billiard halls allow small groups to enjoy socially distanced activities if correctly arranged. Billiard halls routinely undertake extensive sanitation protocols to ensure the health and safety of customers.

Millions of New Yorkers and I concurred with your comment on January 11, 2021 in favor of reopening our economy when you stated "We will have nothing left to open. We must reopen the economy, but we must do it smartly and safely." Governor, those words were true January 11, and they remain true today.

We need to reopen our economy, safely and sensibly, with every consideration toward on-site COVID-19 mitigation. Doing so will provide a lifeline to countless small businesses at serious risk of being crushed by the COVID-19 pandemic's ongoing economic fallout. The next logical step in this necessary effort would be looking to the State Supreme Court's initial ruling in 370 BREWERTON ROAD, LLC d/b/a Brick House Billiards Bar and Restaurant et al., v. ANDREW M. CUOMO that billiard halls can re-open.

Our state should extend the reopening of these initial 16 billiard halls to all such facilities on a statewide basis. I encourage you to strongly consider pending legal precedent and immediately authorize such re-openings. Thank you for your consideration of my request.
