## New York to vaccinate individuals with comorbidities



My office has received many questions regarding when will individuals with comorbidities be vaccinated in New York State? I am pleased to share that beginning this Monday, February 15, local health departments will begin administering COVID-19 vaccines to

people with comorbidities. View the Spectrum News article here.

## The following list is of adults of any age who fall into this category:

- Cancer (current or in remission, including 9/11-related cancers) Chronic kidney disease
- Pulmonary Disease, including but not limited to, COPD (chronic obstructive pulmonary disease), asthma (moderate-to-severe), pulmonary fibrosis, cystic fibrosis, and 9/11 related pulmonary diseases
- Intellectual and Developmental Disabilities including Down Syndrome
- Heart conditions, including but not limited to heart failure, coronary artery disease, cardiomyopathies, or hypertension (high blood pressure)
- Immunocompromised state (weakened immune system) including but not limited to solid organ transplant or from blood or bone marrow transplant, immune deficiencies, HIV, use of corticosteroids, use of other immune weakening medicines, or other causes
- Severe Obesity (BMI ≥ 40 kg/m2 ), Obesity (BMI of 30 kg?m2 or higher but
- Pregnancy
- · Sickle cell disease or Thalassemia
- Type 1 or 2 diabetes mellitus
- Cerebrovascular disease (affects blood vessels and blood supply to the brain)
- Neurologic conditions including but not limited to Alzheimer's Disease or dementia
- Liver Disease

# My statement on inmates being vaccinated before vulnerable New Yorkers



Last Friday, February 5, I issued the following public statement (below) regarding the Governor's inexplicable policy to put inmates ahead of law-abiding New Yorkers in terms of

receiving a COVID-19 vaccine:

"The Cuomo administration's foolish decision to allow inmates to be vaccinated against COVID-19 while vulnerable New Yorkers must wait their turn, whenever that will be, for the life-saving vaccine is outrageous, shameful, and nonsensical. The state's COVID-19 vaccine rollout has been bungled, botched, and micromanaged from the very beginning. Prioritizing prisoners – putting lawbreakers ahead of law-abiding, vulnerable New Yorkers – is the latest example of Albany's 'Bizzaro World' misplaced priorities. Criminals being placed ahead of law-abiding citizens, including immunocompromised individuals, for the COVID-19 vaccine is simply inexcusable." – Senator Daphne Jordan

Working to rescind the Governor's expanded emergency powers



On Monday, I spoke on the Senate floor offering an amendment on behalf of our Senate Republican Conference to rescind Governor Cuomo's expanded emergency powers. It was the TWELFTH time that our Conference has tried to restore checks and balances to New York! Unfortunately, not a single Senate Democrat voted to reestablish the Legislature as a co-equal branch. My full statement is below:

"On behalf of our Senate Republican Conference, during session yesterday I offered a

common-sense amendment to rescind Governor Cuomo's expanded emergency powers and restore much-needed checks and balances to our state government. Yesterday marked the twelfth time that we have pushed to reassert ourselves and re-establish the necessary separation of powers so vital to our democracy. New Yorkers have endured this administration's arbitrary economic restrictions, fumbled vaccine rollout, as well as its disastrous and deadly nursing home scandal. The Governor is not a king and the continuation of his one-person rule is antithetical to democracy.

In recent weeks we have seen the State Attorney General's bombshell report on nursing homes and learned of the mass exodus of State Department of Health officials. Our Senate Republican Conference continues calling for an independent investigation of New York's nursing home tragedies and true accountability and transparency. My colleagues and I again urged the Senate Majority to stop turning a blind eye to the Cuomo administration's failings. This issue is bigger than partisan politics: it's about doing what's right, and the state legislature reasserting its rightful prerogative as a coequal branch of our state government to ensure proper checks and balances. While it is disappointing that the Senate Democratic Majority did not join us in our push for good government and greater accountability from Albany, we will continue working toward a restoration of checks and balances necessary for a better New York State."

# Cuomo aide admits they hid nursing home data so feds wouldn't find out

Governor Andrew Cuomo dismissed the matter of where nursing home fatalities actually took place.

Late Thursday night saw the release of yet another bombshell revelation into the Cuomo Administration's widening, deepening nursing home scandal and attempted coverup of the more than 15,000 tragic deaths caused by the Governor's deadly mandate that they accept COVID-19 positive patients. Now, after months of denial, delay, and deceit, the Cuomo Administration FINALLY admitted that it deliberately withheld the state's true nursing-home death toll from COVID-19 because they "froze" out of fear that the true numbers would be used in a lawful, independent federal investigation. This is an outrageous betrayal of the public trust and an insult to the thousands of NY families who lost a loved one because of the Cuomo Administration's dishonesty and sheer incompetence.

Tellingly, the only apology from the Cuomo Administration has been to the Democratic politicians for the "inconvenience" it caused in their campaigns and political lives, not the families who lost a loved one. Not only should Health Commissioner Zucker resign, but there must also be a state-federal investigation as I've been calling for, to provide answers, accountability, and transparency. #### RE: New York State allowing the opening of overnight summer camps

Dear Governor Cuomo:

I write respectfully requesting that overnight camps be allowed to open so thousands of children may receive much-needed opportunities to safely enjoy New York's great outdoors, spend quality time with their peers, make new friends, and create lifelong memories.

The past year of the COVID-19 pandemic has been especially challenging for children and families across New York State. From social distancing to mask-wearing, remote/hybrid academic learning, the cancellation or suspension of sports, clubs, and other beloved extracurricular activities, the children of New York State have experienced unprecedented changes and challenges to their everyday lives. New York's children have continually shown incredible resiliency and courage in the face of these disruptions.

Last year, out of an abundance of caution for the health and safety of children and camp staff, New York State suspended the operation of overnight summer camps. Now, as we will soon mark one year since the COVID-19 pandemic's onset, we thankfully have multiple vaccines that are proven safe and efficacious in preventing severe COVID-related illness, hospitalization, and death. We also know much more about the virus, how it spreads, and that effective risk mitigation efforts such as proper social distancing, thorough sanitization, and the wearing of masks can help prevent and reduce the spread of COVID-19.

On Tuesday, February 2, 2021, the New York State Camp Safety Advisory Council, comprised of representatives from the New York State Department of Health, the medical community, camp owners, and directors held a public meeting on the resumption of summer camps. The resolution of their meeting was the passage of a resolution affirming that overnight and day camps can operate safely this summer. The Council unanimously voted to both recommend to New York State that overnight camps should be allowed to operate and that there should be no limitations on group size on overnight and day camps. The Council's detailed report advocating for the resumption of summer camps is currently being circulated within the State Department of Health.

Without question, sleepaway camps serve an invaluable role in children's positive social-emotional development. Camp is perhaps the safest and best place for young people to be, both from an emotional and physical health perspective, given all they have been subjected to because of COVID-19.

Serious economic consequences are expected if overnight summer camps in New York State are not allowed to return to full operational status this summer. In fact, it is anticipated that many New York State sleepaway camps may permanently go out of business due to ongoing financial hardships, meaning more lost jobs and opportunities for our state.

Governor, sleepaway camps in Maine and New Hampshire safely operated in 2020. Furthermore, on June 26, 2020, your administration announced that day camps statewide were allowed to resume operations effective June 29, 2020, and they did so, successfully. New York State's overnight summer camps should be afforded the same opportunity for the benefit of countless children who missed out on this experience last year due to the pandemic.

New York State providing advance notice that overnight summer camps can resume their operations will assist them in successfully implementing all necessary COVID-19 safety protocols including testing, capital projects, supply ordering, and hiring staff. Overnight summer camps are ready, willing, and able to meet and exceed all health and safety protocols to provide a positive experience for guests. They must be allowed to do so.

Thank you for your consideration of my request made on behalf of overnight summer camps across New York State.

**Protecting local taxpayers and services** 



Governor Cuomo is passing his fiscal crisis onto local governments by cutting nearly \$10 million in financial support and proposing draconian cuts to our communities. Some cities face a 20 percent cut in the direct state aid to municipalities known as AIM funding. Towns and villages would receive no state support at all. This forces counties to make up the difference through sales tax collections (and probably sales tax increases).

All local government assistance payments are facing a 5-percent cut. On top of this, the Governor is reducing aid to localities for economic development by \$20 million and cutting nearly \$10 million in state support to Video Lottery Terminals statewide, making it that much harder for our communities to recover from the coronavirus pandemic.

The Governor is putting an additional strain on overburdened local governments and taxpayers. First, it's sales tax increases to replace AIM. Then, the cuts in other assistance programs make it harder for local governments to both stay within the property tax cap and maintain essential services.

We need to ensure local governments are equipped to make it through the current crisis and have the resources to help rebuild our state in the years to come.

Residents shouldn't have to fear a decline in services or about having to pay more in sales and property taxes. As we continue the budget process, I will fight for our taxpayers and our local officials and ensure they have everything they need to keep our communities strong.
