#### Fix NY's Broken Budget Process

The State of Politics blog recently featured an article by Nick Reisman regarding the Governor seeking to "reframe" the State Budget and include non-budgetary measures like bail "reform" in the annual spending plan. This is entirely the wrong approach and why we need to fix NY's broken budget process. As I've said previously – and will continue saying – the State Budget is the legal authority for the state government to spend money, period! The budget is for appropriations and should not be mixed with legislation needing review and input from taxpayers, and vigorous debate and oversight by legislators. Non-budgetary matters shouldn't be in the State Budget in the first place – they should be considered as stand-alone legislation. Let's focus on New York's massive \$6.2 billion deficit and getting the state's finances in order, and stop trying to make policy through the budget. # **Department of Homeland Security Briefing**





On Monday, I received a policy briefing from Congressman Tom Reed and representatives from the U.S. Department of Homeland Security on New York's Green Light Law – and how this bad law takes our state back to a dangerous, pre-9/11 mentality. It was emphasized throughout the briefing that a DMV check is one of the very first steps taken by border and immigration enforcement when interacting with an individual and that such a check often yields critical information regarding anti-terrorism, counter-narcotics, transnational organized crime, and the horrific human trafficking of children. Congressman Reed and DHS officials reiterated the point that NY's Green Light Law prevents the sharing of NYS DMV info with Immigration And Customs Enforcement (ICE) and U.S. Customs and Border Protection, (a point I made during my Senate debate with the Green Light sponsor and continually voicing my opposition to the Green Light Law). By withholding this critical information, the Green Light Law endangers the safety of the men and women serving on the front lines of keeping our country safe – as well as jeopardizing our national security. My thanks to Congressman Reed, and Directors Kelly and Brophy (all pictured above) for their informative briefing. I proudly stand with law enforcement and remain committed to the complete repeal of the atrocious Green Light Law. We also must require the NYS DMV to stop playing politics and share its information with law enforcement!

#### **Calling for NYS DMV to Help Protect our Borders**

Tuesday featured a press conference led by my good friend, Assemblyman Jake Ashby, and included Rensselaer County Veterans Service Agency Director Peter Goebel, Columbia County Veterans Service Agency Director Gary Flaherty, Emil Baker of the Employer Support of the Guard and Reserve (ESGR), Capital Region veterans and veteran's advocates, calling for proper investment in the proven programs that help our heroes. I specifically advocate for the restoration of \$3.7 million for the Joseph P. Dwyer Veteran Peer-to-Peer Program in the 2020-21 State Budget. It's shameful that veterans have to come to the State Capitol and advocate for proven, life-saving initiatives like the Dwyer Program, while Albany seemingly has no problem finding \$27 million for the DREAM Act to give free college for illegal immigrants. Where are Albany's priorities? Meeting the needs of our veterans – our heroes – will always be my priority!



Advancing an Amendment to Repeal the Green Light Law

After September 11, everyone agreed that local, state and federal law enforcement needed better cooperation and coordination. Here in New York, the site of the worst terror attacks in our history, Senate Democrats ignored this lesson and passed the so-called Green Light Law giving licenses to illegal immigrants and blocking information that could thwart future terrorist attacks from being released to federal authorities. Because of Senate Democrats, our public safety has taken a backseat to a radical, extreme political agenda. It's time to put the brakes on the Green Light law and support a full repeal of this misguided initiative. That's why on Tuesday, my Senate Republican colleagues and I advanced an amendment to repeal the Green Light Law. While we were unsuccessful in enacting our amendment, I'll keep fighting to get this bad law off the books.
