#### Latest state actions regarding COVID-19

The following are some of the very latest actions and announcements from New York State as we continue responding to the Coronavirus pandemic. You can also view all of these and more news and announcements at the following website:

- Schools and nonessential businesses will stay closed through May 15th.
- Governor Cuomo issued an executive order requiring all people in New York when in public and unable to properly keep social distance to wear masks or face coverings including when taking public or private transportation or riding in for-hire vehicles.
- An executive order directs employers to provide essential workers with masks free of charge to wear when interacting with the public.
- NYS will conduct antibody tests prioritizing frontline workers beginning this week.
- A blueprint to un-PAUSE New York will be implemented in coordination with other regional states to get people back to work and ease social isolation without triggering the renewed spread of the virus.
- Governor Cuomo and several northeast state Governors announced the creation of a multi-state council to restore the economy.
- New COVID-19 testing facilities are opening downstate, primarily in minority communities.
- New Yorkers who have recovered from COVID-19 are encouraged to donate blood. Here's how to donate: <a href="https://nybc.org/donate-blood/convalescent-plasma-covid-19-donor-request-form/">https://nybc.org/donate-blood/convalescent-plasma-covid-19-donor-request-form/</a>.
- New Yorkers without health insurance can apply through NY State of Health through May 15, 2020; must apply within 60 days of losing coverage.

- New Yorkers can call the COVID-19 Emotional Support Hotline at 1-844-863-9314 for mental health counseling.
- Testing is free for all eligible New Yorkers as ordered by a health care provider.

3 ozs edible portion meat, fish, poultry or alternative

2 1/2 cups servings of vegetables

1 serving whole grain or enriched bread

1 teaspoon butter or margarine

1/2 cup dessert

1/2 pint milk, 2% or fortified skim

Proudly Recognizing our Hometown Business Heroes Helping in the Fight Against the Coronavirus



I'm so incredibly PROUD of our hometown hero businesses from across the 43rd Senate District who've stepped up to lead in the fight against the Coronavirus.
