

Standing up for our military members and their families

In fact, an Airman hailing from my 43rd Senate District that is stationed in Texas was recently denied an opportunity by the administration to return to New York for his beloved grandfather's funeral in Upstate. After long, grueling training periods away from their families, New York's patriots deserve to be welcomed back to civilian and professional life, not sequestered into a mandatory 14-day quarantine because they trained in a certain state.

That's why I called on the Cuomo administration to immediately begin COVID-19 testing for every military troop transport plane when it lands in New York State and provide for expedited results. We need to ensure that the men and women of our military who protect our liberty have access to the very same cherished freedoms as all New Yorkers and can return to their families!

Dear Governor Cuomo:

We write concerning your recently issued Executive Order No. 205: "Quarantine Restrictions on Travelers Arriving in New York" and call attention to your mandate's real-world impact on the courageous men and women of our military returning home from training or the performance of their official duties.

Your Executive Order No. 205 mandates that anyone entering New York from one of 16 designated states (Alabama; Arkansas; Arizona; California; Florida; Georgia; Iowa; Idaho; Louisiana, Mississippi, North Carolina; Nevada, South Carolina; Tennessee; Texas and Utah, respectively) to quarantine for 14 days unless taking part or engaging in responsibilities as a first responder/essential worker upon their entry or return to New York (or meet some other exemption, i.e., if the individual were in one of those states for less than 24 hours).

Thus, as mandated by your Executive Order, National Guard troops from New York State taking part in military training in South Carolina that return home must quarantine unless they are continuing National Guard duties while in New York or are in some other way an "essential worker" in their regular jobs.

The reality of your quarantine requirement is causing undue hardship for members of our military and their families. Case in point, an Airman hailing from the 43rd Senate District and stationed in Texas was recently denied an opportunity by your administration to return to New York for his beloved grandfather's fineral in Upstate due to your Executive Order.

After long, grueling training periods away from their families, New York's patriots deserve to be welcomed back to civilian and professional life, not sequestered into a mandatory 14-day quarantine because they trained in a certain state. As you will recall, at the height of New York's COVID crisis, which our National Guard so bravely and effectively responded to, our state had three times the rate of Coronavirus cases as the threshold set for your recent travel quarantine. Without question, the men and women of our military deserve the same freedoms as all New Yorkers and the state should take every appropriate step to ensure their safe, timely re-entry.

Accordingly, we call upon your administration to immediately begin COVID-19 testing for every military troop transport plane when it lands in New York State and provide for expedited results.

As you have often alluded to during your press conferences, New York has emerged as a leader in testing capacity, so the State Department of Health should already have the necessary supplies ready to test returning military members immediately upon their arrival. As your quarantine mandate was a state order, New York State should, of course, pick up all costs associated with testing or any lost work.

Thank you in advance for your attention to our request made on behalf of the courageous men and women of America's armed forces who are returning home to New York State.

Calling for accountability and an independent state-federal investigation into Governor Cuomo's nursing home policies



Our new Senate Republican Leader Senator Rob Ortt issued the following powerful statement earlier this week (below) about the need for an independent investigation into Governor Cuomo's deadly mandate that forced nursing homes to accept COVID-19 positive patients. The Governor's reckless mandate is widely believed to have claimed nearly 6,000 senior citizen's lives, possibly many more. Instead of blaming family members or nursing home staff, the administration should accept responsibility for issuing their mandate.

We need a thorough, independent state and federal investigation as I've been calling for these past few months to get answers, ensure accountability, and provide nursing homes the resources and support they need to prevent such an avoidable tragedy from ever happening again.

STATEMENT FROM NYS SENATE REPUBLICAN LEADER ROB ORTT ON CORONAVIRUS IN NURSING HOMES

Governor Cuomo and his Department of Health Commissioner's continual attempts to distort reality are an insult to every New Yorker who lost a mother, father, grandma, grandpa, or other loved one in a nursing home, long-term care, or assisted living facility.

The fact is that coronavirus ravaged a nursing home in Kirkland, Washington in late February, and the devastation illustrated the danger the virus posed to our

seniors. Instead of swiftly acting to protect our most vulnerable, Cuomo and his Health Commissioner did nothing.

The Cuomo administration now blames family members and dedicated staff instead of their botched March 25 directive that sent COVID-19 positive patients walking into the door. The Cuomo administration's failure to accept responsibility for their disastrous response has been outrageous, but to blame family members who have suffered devastating losses – who were not even able to say goodbye at funerals – is the ultimate low.

It's not only the March 25 directive that led to this disastrous and deadly outcome. At the start of the crisis, the Cuomo administration fixated on holding daily briefings to gain national attention while our seniors in nursing homes were an afterthought.

The Senate Republican Conference called for measures to be taken, but not Cuomo or a single Democrat did anything.

An independent investigation is needed to understand what went wrong to provide answers to families and to help our nursing homes deal with infection control, not a report issued by the Cuomo administration and their allies.

Update on Canal water levels from New York Power Authority

This week, my office received an informational update that I'm sharing (below) from the New York Power Authority re: Canal water levels:

"As you are well aware water levels on the Canal are approximately 6 inches below normal. This condition is a result of the Canal corporation's efforts to install the upstream movable dams coupled with the abnormal dry conditions that exist. We are working with Canals to ensure that their actions don't impact the Vischer Ferry pool level. The Crescent pool is about 2-3 inches lower but being maintained at current levels. We are reaching out to the local marina operators to give them the heads up as well. We will continue to keep you posted."

It's always terrific being able to provide this much-needed resource that will help keep individuals and communities safe and healthy!


