Successfully Advocating for Residential Group Home Visitation



Families recently received some great as NYSOPWDD stated that group home residents may begin resuming visits home with their families, have outings in the community, and, best of all, day habilitation programs will resume!

I strongly advocated for these important successful outcomes in my correspondence to the Governor on June 10 urging these common-sense steps for families who count on these services as NYS continues to move forward with reopening. I'm glad the Governor finally listened.

OPWDD released the following statement confirming this positive development:

"OPWDD understands how challenging the temporary suspension of day services, home visits, and community outings has been for the people we support and their families during the COVID-19 global pandemic response. As regions across New York are now starting to re-open, OPWDD is working closely with the NYS Department of Health to establish a process to safely begin returning to regular activities, including a phased-in approach to the resumption of community-based programs and visitations."

Advocating for New York State Bowling Centers to Reopen



I recently sent a letter to Governor Cuomo advocating for the Empire State Development Corporation (ESD) to develop a plan for the immediate reopening of bowling centers throughout NYS. Bowling centers are important for recreation, are easily reconfigurable for social distancing, and can abide by indoor occupancy parameters just as easily as restaurants or other businesses which are now open. Much like other "Low-Risk Indoor Arts & Entertainment" venues included for reopening in Phase Four, bowling centers are unlikely to have large, close-quarter crowds which could pose a risk to public health.

Many bowling centers are small businesses operating on small margins of profitability. Those who own and operate bowling centers, like other business owners, are more than willing to make accommodations to ensure that their businesses open in a safe, responsible way.

More details on the 13 specific safety steps bowling centers are prepared to take to ensure the health, safety and wellbeing of their guests is included within my correspondence. I'm hopeful the Governor will listen! To read a copy of my letter, click <u>here</u>.

Continuing to Demand Answers about Governor Cuomo's COVID Nursing Home Policy Failure

For this edition, I'm proudly recognizing the Crisp Cannoli Bakery & Cafe in East Greenbush, and Scout Troop 16 of Saratoga Springs. The Crisp Cannoli - Bakery & Cafe, East Greenbush

The Crisp Cannoli Bakery & Cafe wanted to purchase two automated external defibrillator (AED) devices: one for the East Greenbush Police and one for the Schodack Police. They reached out to New York State Automobile Dealers Association (NYSADA) who had some available. When the team at NYSADA found out they were purchasing for donation to the police, they graciously donated them. The Crisp Cannoli supports the police and appreciates all the members of law enforcement who risk their lives every day, many times with little outside appreciation, as they continue protecting and serving our communities. The Crisp Cannoli also launched "Operation Gift Card" where employees used tips from customers and purchased several hundred dollars in gift cards to grocery stores. They then split the cards up between East Greenbush and Schodack police officers who distributed them throughout the community.

Boy Scout Troop 16, Saratoga Springs

On Saturday, June 27, Boy Scout Troop 16 held a food drive to benefit the Wilton Food Pantry in support of the Saratoga-Wilton Elks Lodge's Senior Outreach Program. Since March, the Scouts were limited to virtual meetings but wanted to help their community and charter organization. They used social media and flyers in their individual neighborhoods, collected donations, and brought them to the Wilton Food Pantry, with seven scouts and their parents participating. According to the food pantry, the troop collected 526 pounds of food. At the standard food bank rate of \$1.62/lb, that's \$852 worth of food! At 45 pounds per family per week, that would be almost 12 families fed for a week. There was a \$200 cash donation as well. An additional box of food was delivered on July 8 from neighbors that missed the original date but wanted to be part of this effort. The troop is led by Scoutmaster Ron Tremper.
