Continuing to get Real Results for 43rd Senate District



Providing constituent services and helping solve problems are important parts of my role as State Senator for the 43rd District. I was recently notified by Copake Town Board Member Dr. Terry Sullivan about an ongoing situation at Taconic State Park regarding thousands of people gathering at the Park and flowing into Town streets afterward with no regard for COVID-19. There has been continuous dumping of garbage in the park and surrounding areas (see pictures above that show the litter, YUCK!).

My office promptly reached out to the New York State Office of Parks, Recreation and Historic Preservation, relayed these concerns, and specifically asked for State Parks to address this situation, especially the ongoing dumping of garbage in and around the Park.

Thankfully, my advocacy achieved real results as State Parks has announced the following: "Taconic State Park will be closing when designated parking lots reach capacity this weekend. There will be no overflow parking allowed at the Copake Ironworks Area or in the Hamlet of Copake Falls. Park staff and police patrols will be strictly enforcing no picnics,

grills, coolers, chairs, large speakers, and illegal parking at Bash Bish Falls. All entrances to State Rte. 344 will be closed to day use park traffic once capacity is reached. Please find alternative destinations if possible."

My thanks to Dr. Sullivan for sharing this important local concern, and for the State Office of Parks, Recreation and Historic Preservation for taking prompt, positive steps to address the situation. I'll continue working to get real results that make a positive difference!

In fact, many bowling centers may close their doors forever unless the Governor acts SOON!

Bowling centers like Kingpin's Alley also have deep, strong roots in the community and are HUGE supporters of charitable and non-profit community causes like Big Brothers Big Sisters of America and many more.

I'm pictured in these photos standing with Alison and Doug Bohannon President, New York State Bowling Proprietors Association, and owners of Kingpin's Alley Family Fun Center, along with bowling center owners and managers from across the Capital District and Upstate, as well as Assemblywoman Carrie Woerner, at today's press conference, as we advocated for the reopening of bowling centers. The owners are pointing upward to a banner that reads "Please Governor Cuomo Let Us Bowl." Also pictured is my personal message to Governor Cuomo on a bowling pin in support of the safe reopening of 300 bowling centers in NYS. Our signed bowling pins and their personalized messages will be delivered to the Governor.

Honoring more Hometown Heroes





I am happy to highlight more fantastic Hometown Heroes from my 43rd Senate District, and their hard work. This week's Hometown Heroes are the Mechanicville Area Community Services Center, MVP Healthcare, the United Way of Greater Capital Region, and Jack Byrne Ford! These businesses and non-profit agencies recently worked together to assist the Mechanicville Area Services Center (MACSC) purchase a new vehicle, so that the Center could expand their food distribution program. MVP Healthcare, the United Way and Jack Byrne Ford contributed funds to purchase the vehicle, and Jack Bryne Ford acquired the van for the Center. Without this help, there would have been no van. The staff at MACSC picks up coolers of lunches for distribution and delivers to five sites throughout Mechanicville,

averaging about 100 lunches a day, 5 days a week. With the onset of COVID, there was a need for the Center to increase the number of summer meals program sites, and a van became an absolute necessity! For the summer, the van is primarily being used to deliver healthy summer meals, but will also be utilized for produce and meat pickups from local grocery stores, perusing the Regional Food Bank for fresh donations. The van will be conveniently able to double for victims of domestic violence who need assistance with moving their belongings to safe space. This was a great collaboration between businesses and non-profits, working together in order to support our community.
