Dear Governor Cuomo,

I respectfully write on behalf of constituents and driving schools in my 43<sup>rd</sup> Senate District asking you to direct the Empire State Development Corporation to develop a plan for the immediate reopening of drivers' pre-licensing courses and exams in a socially distanced classroom setting and to provide guidance for teleconferencing course and exam availability. The pre-licensing course, known more commonly as the "five hour course", is a necessary step in attaining a driver's license, getting new drivers on the road and people to work. Consequently, it is a critical part of our State's economy. Correspondence between my office and Empire State Development revealed that there are currently no concrete plans for reopening beyond the currently available in-vehicle education. It is my belief that, by developing a socially distanced methodology for providing the "five hour course" in classrooms and online, our State can continue to protect public health while simultaneously getting our economy "back on track".

Last October, you signed Chapter 368 of the Laws of 2019. In your own words in Approval Memo 6 of 2019, this bill "would build upon the success of the online defensive driving course, (by providing) students with the convenience of completing the pre-licensing course in the comfort of their own homes." While the Department of Motor Vehicles continues its preparations for providing this pilot program, the difficulties of COVID-19 and its associated shutdown have expedited the need for online availability, a need which you recognized even before the outbreak of this pandemic. Based on correspondence with my office, the Empire State Development Corporation believes using Zoom or other teleconferencing services may be possible under the Vehicle and Traffic Law, but have provided unclear guidance. In communications with driving schools, they seek this guidance as there is great uncertainty as to what they may offer. I respectfully request that you direct Empire State Development to issue clear guidance and parameters for the use of these remote services for accessing the pre-licensing course.

The ability to drive is not merely a "right of passage" for young adult New Yorkers, it is a critical means by which our economy functions. AARP reports that New Yorkers on average have a 31.6 minute commute each way, and in this time of pandemic, even New Yorkers who have access to public transportation may be weary of taking advantage of it. The pre-licensing course is a fundamental step for individuals to fully participate in our economy, and I ask you to ensure that it becomes available to the public as soon as possible by both in-classroom and online means.

Thank you for your attention to my request.

Daphne Jordan State Senator, 43rd District I'm pleased to share that thanks to my advocacy, New York State is now allowing student drivers to take their pre-licensing course (aka the "five-hour course:) online after many individuals were otherwise unable to get their license due to the COVID-19 outbreak. The Governor recently announced that New York State will allow the five-hour required course to be offered through video conferencing via Zoom, Go to Meeting, or Skype so driving tests can finally move forward for the many student drivers who've been waiting months.

I became involved in this effort when a 16-year-old from my swim family texted me asking for help, as did a fellow Swim Mom of her 17-year-old son (Jaden Homan and Bethann Erin Silaika, respectively). I wrote to the Governor specifically advocating for him to direct the Empire State Development Corporation to develop a plan for the immediate reopening of drivers' prelicensing courses and exams in a socially distanced classroom setting, and to provide guidance for teleconferencing course and exam availability. I'm glad the Governor heeded my suggestions.

New York State's COVID-19 mandates made it incredibly difficult for student drivers to obtain licenses. The restrictions forced the cancellation of in-person pre-licensing courses and required the rescheduling of numerous road tests. There was a great deal of confusion among driving schools who were uncertain of what they were able to do (and understandably so!). A copy of my letter to the Governor from July 15 is pictured above. I'm proud to have advocated for and helped deliver this real result that will make a positive difference for families all across my 43rd Senate District and statewide!
