

Senator Daphne Jordan and Assemblyman Angelo Santabarbara continue their bi-partisan push for "Ayshawn's Law," new legislation that would increase criminal penalties on drive-by shootings to first-degree murder

In light of this afternoon's arrest of the suspected killer of 11-year-old Ayshawn Davis by the Troy Police Department, New York State Senator Daphne Jordan (R,C,I-Halfmoon) and Assemblyman Angelo Santabarbara (D-Rotterdam) today continued their bi-partisan push for new legislation titled "Ayshawn's Law" that would increase criminal penalties on drive-by shootings to firstdegree murder.

The arrest of the suspect in the case, Jahquay Brown of Cohoes, by the Troy Police Department was reported earlier this afternoon, along with the fact that Brown will be charged with second-degree murder for the killing of Ayshawn Davis.

Senator Jordan and Assemblyman Santabarbara's new legislation dubbed "Ayshawn's Law" in memory of Ayshawn Davis, the victim of the senseless crime (Senate Bill S.8988, an Assembly companion bill has been introduced, bill number is being assigned) would amend the State Penal Law to establish a "drive by shooting" as being defined when a person, with the intent to cause the death of another person, discharges a firearm from a motor vehicle at another person outside of the motor vehicle and carry with it the charge of first-degree murder.

"I thank the excellent work of the Troy Police Department in investigating this horrific, senseless violent crime and making a swift arrest. The murder of Ayshawn Davis, a beloved boy with a bright, boundless future, is a crime so brutal and breathtaking that it's beyond comprehension. The murder of this innocent 11-year-old boy warrants the greater charge of first-degree murder that our bi-partisan legislation titled 'Ayshawn's Law' would achieve. There have been more than a dozen drive-by shootings that we know of in New York State since July. We have to say – as a community and a state – NO MORE! I'm hopeful that both houses of the state legislature will join us, and stand with us, in calling for enactment of this bi-partisan public safety legislation as soon as possible to provide a further deterrent for criminals who would prey upon the innocent. Our prayers continue going out to the Davis Family," Senator Jordan said.


"This was an unthinkable crime and an attack on our community, plain and simple," said Assemblyman Santabarbara. "I thank law enforcement for the work they have done to bring those responsible to justice, but we as legislators have a responsibility to take action as well. We cannot stand by while innocent bystanders continue to become victims, in this case 11-year-old Ayshawn Davis." Santabarbara said. "There's a family that will never be the same again. And to know that there are still people out there who would randomly fire shots from a moving car, without regard for who and how many are killed is unthinkable. This bill is tough on crime and we all need to be tough on crimes like this if we want it to stop," Santabarbara added. "Our communities shouldn't have to live in fear, wondering every time a car drives by if more shots will be fired at them."

Celebrating the Grand Opening of the new Mechanicville section of the Zim Smith Trail




Wednesday morning, I was proud to take part in the grand opening of the newly completed Mechanicville section of the Zim Smith Trail. What a terrific trail with incredible scenic beauty!

As noted on Saratoga Plan's website, the Zim Smith Trail will be the backbone of the County trail system, and is a 9-mile, multi-use trail connecting Ballston Spa to Coon's Crossing in Halfmoon, through the towns of Ballston, Malta, and Clifton Park, and the Village of Round Lake. Most of the trail is asphalt, with some hard packed dirt sections south of the Village of Round Lake. The trail is well maintained and is excellent for strollers, wheelchairs, and bicycles. This wonderful trail also runs through the Fairways of Halfmoon.

Individuals at Wednesday's grand opening include Libby Smith, whose late husband the trail is named in memory of, Mr. and Mrs. Floud, who owned some of the property, as well as my good friend Henny O'Grady, who is one of the original trailblazers in the Town of Halfmoon and Saratoga County, and is still active on the Halfmoon Trails Committee.

During my remarks, I spoke about this incredible trail being part of the Empire State Trail, and recognized all of the trailblazers, past and present. I also spoke about how trails help provide connectivity to towns and opportunities for people to exercise and enjoy the outdoors, especially during the COVID crisis, as many people who never used trails are now discovering just how great they are. Saratoga Motorcycle grand opening and ribbon-cutting ceremony






