Proudly announcing Peter Goebel as my 2020 inductee to the New York State Senate Veterans' Hall of Fame

I was proud and honored to recently announce Peter Goebel, Director of the Rensselaer County Veterans Service Agency, and retired United States Army Colonel, as my 2020 inductee to the New York State Senate Veterans' Hall of Fame. This year's Senate Veterans Hall of Fame online announcement coincided with Veterans Day, which was observed on November 11, 2020.

I encourage you to read the following details of Peter Goebel's honorable record of military service that is highly distinguished, decorated, and exemplary.

Peter A. Goebel is a retired Colonel in the United States Army who grew up in Rensselaer County and graduated from Averill Park High School in 1977. He was commissioned into Air Defense Artillery in 1981 upon graduation from the United States Military Academy at West Point.

Completing the Air Defense Artillery Officer Basic Course and Improved HAWK Officer training at Fort Bliss, Texas, and Airborne and Ranger Schools at Fort Benning, Georgia, he was assigned to the Federal Republic of Germany, as an IHAWK Platoon Leader.

He graduated from the U.S. Army Command and General Staff College at Fort Leavenworth, Kansas in 1999. He served with the First Marine Division, First Division (United Kingdom), and the 82nd Airborne Division during Operation Iraqi Freedom I from March of 2003 until March of 2004.

After 27 months of successful Battalion Command, he assumed duties as Chief of Training, Readiness, Operational Exercises, and Support for U.S. Army South (ARSOUTH) at Fort Sam Houston, Texas. He deployed to Afghanistan for Operation Enduring Freedom in October 2009. After one year in Afghanistan, he returned to Fort Sam Houston, Texas, to become the Chief of Strategic Synchronization and Engagement for U.S. Army North/Fifth Army (ARNORTH), before retiring as a Colonel in February 2012.

Among his awards are the Legion of Merit, the Bronze Star Medal, the Defense Meritorious Service Medal, the Navy and Marine Corps Presidential Unit Citation, the Joint Meritorious Unit Award, the Meritorious Unit Citation, the Armed Forces Expeditionary Medal, the Afghanistan Campaign Medal (with 2 Bronze Service Stars), and the Iraq Campaign Medal (with 2 Bronze Service Stars). He earned the Combat Action Badge, the Parachutist Badge, the Air Assault Badge, and the Ranger Tab during his service.

In addition to serving as the Director of the Rensselaer County Veterans Service Agency, Mr.

Goebel serves in the Veterans of Foreign Wars, the American Legion, the AMVETS, the Disabled American Veterans, the Friends of the New York State Military Museum, the Sons of the American Revolution, the Dutch Settlers Society of Albany, and the West Point Society of the Capital District of New York.

Congratulations Peter Goebel and thank you for your honorable, faithful, and distinguished service to our nation, and to Rensselaer County's military veterans!



My legislative agenda for 2021

With victory assured by the following day, Jordan began to look ahead, especially to bipartisan legislation.

"Delivering real results starts with smart, bi-partisan public policies that help improve the quality of life for my constituents," she said in an email. "That's why affordability, opportunity, and security will remain at the heart of my bi-partisan legislative agenda for 2021.

She added that working to help struggling small businesses recover and come back even

stronger from the COVID closures is a top priority for her, as is helping unemployed New Yorkers return to work safely and sensibly. Expanding broadband for rural and underserved communities is another issue she wants to work on, especially for Columbia County and Washington County.

"Broadband for all has to finally become a reality, especially for families with students who are taking part in distance learning and for parents who are working remotely," she said.

She also mentioned economic development that adds value and creates more good-paying jobs as another issue in her sights. Looking deeper into her platform Jordan said she will continue her efforts to repeal what she term's Albany's failed "bail" reform law.

"Repealing that and supporting law enforcement are essential public safety priorities," she said. "The state Legislature also needs to work in a bipartisan fashion to restore the necessary and proper checks and balances in state government and serve as an effective check on the executive."

Other local community issues like a 400-acre solar farm project in the Town of Copake and working with the Town of Germantown to oppose Amtrak's unpopular fencing plan are also on her radar.

"I'll remain an outspoken advocate for, and keep partnering with, local governments," she said. "I'm honored to continue serving voters of the 43rd Senate District and I thank them for their strong support."

HEAP Program helps qualifying families heat their homes this winter

Home Energy Assistance Program

Winter's on its way, meaning colder temperatures and higher home heating bills. Thankfully, the Home Energy Assistance Program (HEAP) helps low-income people pay the cost of heating their homes. All of the following information is featured on the New York State (OTDA) Office of Temporary and Disability Assistance website at https://otda.ny.gov/programs/heap. Please Note: there is a limited amount of annual funding for HEAP; if you or a loved one need assistance, don't delay in applying! Besides visiting OTDA's website, you can also call my office at (518) 371-2751 if you have questions or need help applying for HEAP.

About HEAP

If you are eligible, you may receive one **Regular HEAP Benefit** per program year and could also be eligible for **Emergency HEAP Benefits** if you are in danger of running out of fuel or having your utility service shut off. HEAP may be able to help you if you heat your home with electricity; natural gas; oil; coal; propane; wood/wood pellets; kerosene, and corn.

Regular HEAP Benefit

The 2020-2021 Regular HEAP benefit opened on November 2, 2020. If you are eligible, you may receive one regular HEAP benefit per program year to help you pay for heating your home. Eligibility and benefits are based on income; household size, the primary heating source, and the presence of a household member who is under age 6, age 60 or older, or permanently disabled. Regular benefits for households that pay directly for heat based on actual usage are paid directly to the vendor that supplies the household's primary source of

heat. Your household may be eligible for a Regular benefit if:

- You and your household members are United States Citizens or qualified aliens

- Your household's gross monthly income is at or below the current income guides for your household size as posted in the table below or

- You receive Supplemental Nutrition Assistance Program (SNAP) benefits or
- You receive Temporary Assistance or
- You receive Code A Supplemental Security Income (SSI Living Alone)

Emergency HEAP Benefit

The 2020-2021 Emergency benefit will open on January 4, 2021. If you are eligible, the Emergency HEAP Benefit can help you heat your home if you are in a heat or heat-related emergency.

Emergency HEAP benefits and eligibility are based on income, available resources, and the type of emergency. If you have an emergency, you must contact your HEAP Local District Contact for assistance. You may be eligible for an emergency HEAP benefit if:

- Your electricity is necessary for your heating system or thermostat to work and is either shut-off or scheduled to be shut off or

- Your electric or natural gas heat is off or scheduled to be shut-off or

- You are out of fuel, or you have less than one-quarter tank of fuel oil, kerosene, or propane or have less than a ten (10) day supply of wood, wood pellets, corn, or another deliverable heat source

- Your income is at or below the current income guidelines, or you receive Family Assistance, Safety Net Assistance, Supplemental Nutrition Assistance (SNAP), or Code A Supplemental Security Income.

- The heating and/or electric bill is in your name and

- Your household's available resources are less than \$2,000 if no member of your household is age 60 or older; or less than \$3,000 if any member of your household is age 60 or older.

New training program available to help unemployed and underemployed New Yorkers

New York State recently launched a new online training platform that will enable unemployed and underemployed New Yorkers weathering the COVID-19 pandemic to learn new skills, earn certificates, and advance their careers at no cost.

The new tool will provide access to nearly 4,000 online programs taught by leading professors and industry professionals on Coursera, with a focus on high-growth and indemand sectors like advanced manufacturing, technology, and health care, among others.

The new course offerings are provided through a partnership between the New York State Department of Labor and Coursera, the world's leading online learning platform. The partnership will save New York millions of dollars over the next couple of years while providing free job skills training. New Yorkers can request a free account on the New York State Department of Labor website at

The nearly 4,000 courses available through Coursera are taught by leading professors and industry educators and cover topics ranging from mechanical engineering and project management to technology and data science skills. Many of these programs provide a pathway to professional certificates and other certifications that can help New Yorkers elevate their careers or compete in a new industry. The Department of Labor is working with stakeholders across the state to curate the content catalog to respond to industry and regional

needs, so that job seekers can easily find courses that will make them the most competitive for open positions in New York State.

The state will also partner with New York-based businesses to encourage their employees to utilize this free learning opportunity. By offering additional skills and training to their employees, employers can meet the changing needs of our New York Workforce as our economy continues to build back better.

During the pandemic, Coursera has helped more than 330 government agencies across 70 countries and 30 US states and cities support impacted workers with job-relevant skills training.

Since the launch of the Coursera Workforce Recovery Initiative, more than 1 million workers

have enrolled in over 7 million courses to gain critical skills for jobs of the future. Coursera Workforce Recovery Initiative is modeled after a successful initiative that the company launched in March 2020, which offered free courses to over 3,700 colleges and universities that closed their campuses in response to the COVID-19 pandemic. In just six weeks, that initiative launched 6,400 programs for 2,800 colleges and universities around the world, helping enroll 475,000 displaced students in 1.1 million courses.
