#### Dear Commissioner Annucci:

I write on behalf of the dedicated, hard-working public safety professionals that help ensure the safety and security of all New Yorkers. Specifically, my correspondence concerns the ongoing movement of furloughed inmates in and out of Hudson Correctional Facility, a medium-security facility located in my 43<sup>rd</sup> Senate District outside the City of Hudson in Columbia County.

As you are aware, the Hudson Correctional Facility has a substantial work-release and furlough program for inmates residing there. Work release program inmates are picked up via bus in the morning and are transported around the area including the cities of Albany and Hudson, respectively, where they work all day and then return to the facility. Furlough program inmates are allowed to leave the facility for a few days, travel about the state, and return on designated days.

The public safety professionals of the New York State Correctional

Officers and Police Benevolent Association, Inc., (NYSCOPBA) shared with me their serious concerns – concerns that I share – about these particular inmates traveling to areas that the Governor has designated "micro-clusters" or "hot spots" for COVID. The inmates spend time out in Erie County, the City of Rochester, and New York City, and then return to the Hudson Correctional Facility. As you know, Erie County has some of our state's highest rates of COVID spread.

Furthermore, it was shared with me that should an inmate visit a microcluster area and contract COVID from family or friends, the virus can, and will, spread like a fire through dry grass at the Hudson Correctional Facility. This would most certainly lead to the inmates contracting the virus and spreading it inadvertently to the public. Additionally, should the infection rate climb high enough in the Hudson Correctional Facility, it could warrant the Governor designating the City of Hudson as a "microcluster," placing significant restrictions on local businesses that are already struggling.

As New York State's prison system continues seeing an alarming increase in positive COVID Cases, NYSCOPBA's leadership has recommended that minimizing the movement of furloughed inmates in and out of facilities would help reduce the spread of COVID. I concur with their recommendation and ask that you work with NYSCOPBA to make the necessary temporary changes that would minimize the movement of these inmates and, in so doing, decrease the dangerous spread of COVID. Temporarily suspending inmate visits, as well as the furlough and work release programs, would be in the best interests of not only public safety professionals and inmates but the general public as well.

The men and women of NYSCOPBA have done, and continue doing, an incredible job protecting and serving in some of the most challenging conditions available. I ask that you share this recommendation with the Governor so we can continue minimizing the spread of COVID and help protect the health, safety, and well-being of all New Yorkers.

Thank you for your attention to this urgent matter and my request.
