# Gillibrand sounds alarm over AFM

430 cases of paralyzing disease spark investigation

WASHINGTON - Legislators are urging colleagues to head off an epidemic that is killing children across 46 states.

With an increase in cases of acute flaccid myelitis (AFM), a debilitating, polio-like disease that has been affecting children in New York and across the

for research, treatment, and prevention efforts against this disease.

AFM is a rare condition that targets the nervous system, specifically the spinal cord, and can cause serious muscle weakness or paralysis. There is no known cause or treatment for this disease. The Centers for Disease Control and Prevention (CDC) have confirmed or are investigating hundreds of suspected cases of AFM in 46 states and in DC. Ninety percent of cases have been in children under the age of 18, with the majority of patients between the ages of two and eight.

The CDC has not identified a cause or how the illness

On Nov. 13, the CDC announced the formation of a new task force to investigate AFM. As Congress finalizes the Fiscal Year 2019 appropriations bill, Gillibrand will call on Congressional appropriators to provide the emergency funding necessary to give the CDC the resources it needs to investigate, treat, and prevent this debilitating disease.

"As a mother and as a Senator, I am taking AFM extremely seriously. I've been disturbed to read reports about this debilitating disease that has been affecting children in New York and across the country. Parents are extremely worried about what this disease means for their children, but doctors still don't know what causes AFM or how it spreads," said Senator Gillibrand. "I am calling on Congressional appropriators to include emergency funding to support the CDC's efforts to learn more about AFM. I won't stop fighting until the CDC has the support they need to keep our children healthy and safe."

WAYLAND - The expansion of a staple business in the local economy is now complete, according to state authorities touting the \$2.6 million project to support the addition of 110 jobs at Gunlocke Company in Wayland.

Governor Andrew M. Cuomo announced Tuesday that the commercial furniture manufacturer in the Southern Tier has completed its expansion project, bolstered by state incentives that include a lowcost power allocation from

# Wet, wintry weather impacts local projects

23 North Main, **Madison Creek culvert** projects slowed

WELLSVILLE - Neardaily precipitation, whether it's in the form of rain or snow, is impacting local infrastructure and construction projects.

That was spectacularly evident Monday when a section of 23 North Main collapsed, a failure that site officials believe was due to the weight of snow on the roof. Neighboring Hamar's Pub remained closed Tuesday as a precaution.

A notice on the building from owner Ingo Hamar read, "We have been temporarily closed by order of the Village of Wellsville Code Enforcement Officer.

The closure is expected to be short term and is the result of an additional area of collapse next door. The collapse and its impact is to be evaluated by a professional structural engineer. We hope to be open for business within the next day or two. Thank you for your continued support and understanding."

Two Plus Four Construction Co. crews have avoided the Hamar's Pub end of 23 North Main in the wake of the collapse. The area that collapsed had been scheduled to be removed during the rebuilding project, but that timetable will likely be moved up due to safety concerns.

The Main Street project isn't the only one impacted by constant wet weather.

Ongoing work at the

## Tax Department highlights 'Quick Pay' option

ALBANY — The New York State Department of Taxation and Finance today announced more than 62,000 payments worth more than \$46.6 million have been made through its convenient Quick Pay application since the beginning of 2018.

This free service provides individuals a way to promptly pay a tax bill or debt owed from an audit or collection case, or as part of an installment payment agreement.

The Quick Pay application, launched in March of 2017, provides individuals the option to pay directly from their bank account.

"This simple and convenient payment option has been a huge success," said Acting Commissioner Nonie Manion. "Taxpayers can access the online

application on their schedule 24/7 and not spend time arranging the transaction over the phone or through the mail."

Those who use the Quick Pay application need the number associated with the tax bill, audit or collection case, installment payment agreement, or income execution, along with: first and last name; taxpayer Social Security or ID number (and spouse's number, if applicable); filing status; mailing ZIP code; and bank routing and

account numbers.

anytime at the NYS Tax Department's Pay a bill or notice webpage.

On the same page, they'll also have the option to:

create an Online Services account, which offers a wider menu of free services, such as the ability to receive email alerts and respond to department notices; or access a link to request an Installment Payment Agreement if they can't pay a bill in full.

The first lady adds, "Our prayers remain with all those serving overseas and for the families who wait for them to come home."

Mrs. Trump then joined Mrs. Pence, cabinet secretaries' spouses, military families, Elizabeth Dole and

other volunteers to assembling the packages.

The packages contain snacks such as popcorn and peanuts, playing cards and toiletries including bottles of hand soap, toothbrushes, toothpaste and tissues. They will be sent to troops deployed in Iraq, Poland, Djibouti and
