TITLE X: THE NATIONAL LANDSCAPE

What is Title X?

- Only federal grant program dedicated to family planning – established in 1970 under President Nixon
- \$286.5m in FY2017
- Funds 91 agencies that support 3,898 health centers
 - 53% grantees are state, county or local health departments
 - 47% are family planning councils, Planned Parenthoods, and other private non-profit organizations



Cornerstones of Title X

- ✓ Care regardless of one's ability to pay
- ✓ Confidentiality
- ✓ More than just patient care: education and counseling, infrastructure support and staffing
- ✓ Access to federal 340B Drug Pricing Program
- ✓ Entry point to health care delivery system



Title X Patients: A snapshot

- Title X serves 4 million women, men and teens nationally
- 9 out of 10 clients are women
- 66% are under the age of 30
- 64% have incomes at or below the poverty level – an individual earning less than \$11,880 per year
- 3.5 million (88%) qualified for either subsidized or no-charge services
- Title X patients are disproportionately black and Hispanic or Latino, with 21% of Title X patients self-identifying as Black and 32% as Hispanic or Latino






Making A Difference

- Preventing unintended pregnancy
 - Services provided by publically funded family planning providers prevented 1.9 million unintended pregnancies which would have resulted in 876,100 unplanned births and 628,600 abortions
 - Title X centers alone helped women avert 43% (822,300) of these unintended pregnancies, which would have resulted in 387,200 unplanned births and 277,800 abortions
- Reducing transmission of STDs
 - In 2010, services at Title X centers averted 53,450 cases of chlamydia, 8,810 cases of gonorrhea, 250 cases of HIV, 1,900 cases of cervical cancer, and 6,920 cases of pelvic inflammatory disease
- Saving scarce resources
 - For every dollar invested in family planning, the taxpayer saves \$7.09 or a net \$13.6 billion in 2010


TITLE X IN NEW YORK

NY's Title X Grantees

- 2 Direct Grantees:
 - New York State Department of Health
 - Public Health Solutions (NYC)
- Approximately \$14m in federal funds
- 187 services sites that provided care to more than 306,000 individuals
 - 83% of New York Title X patients have incomes at or below 250% of the federal poverty level
 - In 2015, Title X services in New York
 - prevented 59,200 unintended pregnancies
 - prevented 13,300 unintended teen pregnancies



How Patients Access Care




Planned Parenthood Empire State Acts

New York's Family Planning Grant

- ≅ \$45M
- Funds 48 agencies, 173 sites
- 269,794 clients in 2016
 - 60% are at or below the federal poverty level
- Title X Program
 Guidelines are the
 foundation of the
 grant
- Planned Parenthoods serve 54% of FPG patients


Family Planning Grant Funding Components

Planned Parenthood Empire State Acts

The Federal Funding Opportunity Announcement

Timeline:

- Summer of 2017: Title X
 Grantees were notified that the current awards would end in 2018
- Fall of 2017: Widely anticipated that a new FOA would be issued
- February 2018: New FOA released
- May 2018: Applications due
- September 2018: Anticipated start of new awards

Concerning Highlights of the FOA:

- Designed to make it more difficult for reproductive health care providers to participate in the nation's family planning program.
- Encourages working with faith-based organizations that are unlikely to provide health care or the full range of services.
- ➤ Grantees can include in their network entities who have experience providing only a single method of family planning i.e. natural family planning.
- Removes reference to contraception and national standards on delivering quality family planning.
- Intended to fund providers that are willing to emphasize abstinence-only education and messaging.

Legal Action:

➤ 2 lawsuits challenging the FOA on the grounds that it violates the Administrative Procedure Act.

The Proposed Gag Rule

Timeline:

- May 22nd: Draft published on HHS's website
- June 1st: Proposed rule officially published
- July 31st: Public comments due
- Fall of 2018 or beyond: Final rule potentially published and implemented

Concerning Highlights of the Proposed Rule:

- Designed to make it impossible for millions of patients to get birth control or preventive care from Planned Parenthood and other providers.
- Doctors, nurses, hospitals, and community health centers across the country would no longer be able to refer their patients for safe, legal abortion.
- Removes the guarantee that patients get full and accurate information about their health care from their provider.
- ➤ Projects would be required to offer no-cost services to any woman whose employer refuses to provide her with contraceptive coverage for moral or religious reasons.

The Impact

- **Destabilize** a 40-year-old program
 - Re-envision the Title X network to emphasize primary care and introduce providers that offer only a single-method of family planning
 - Limit access to the full range of birth control options
 - Emphasis abstinence over evidence-based education and counseling
- Violate the medical ethics of providers by making it illegal for those
 participating in the Title X program to tell patients how they can safely and
 legally access abortion even if that's what the patient wants, and even if
 withholding that information threatens their health
- Remove the guarantee that patients get full and accurate information about their health care from their health care provider
