

Statement from Senator Daphne Jordan on Governor Kathy Hochul's 2022 State of the State Address

"I listened with great interest to Governor Kathy Hochul's 2022 State of the State Address today, the first-ever delivered by a female Governor of New York State, which was an important and noteworthy milestone.

It was nice to see – mentioned in her 2022 State of the State book released after today's address – that Governor Hochul supported important policy priorities I've continually called for such as funding the Joseph P. Dwyer Peer-to-Peer Veterans Counseling Support Program and expanding this successful, lifesaving program statewide. The Dwyer Program MUST be part of the State Budget and not continually be relegated to a 'legislative add' forcing veterans and veterans' advocates to annually fight for this critical funding. In addition, Governor Hochul's call for accelerating \$1.2 billion in middle-class tax cuts for six million New Yorkers directly mirrors my legislation, Senate Bill S.1808, which would accelerate the middle-class tax cut phase-in by one year. Also, during her Senate Floor remarks today, Senate Majority Leader Andrea Stewart-Cousins reportedly called for the enactment of a health care worker peer support program, an important proposal that I proudly sponsor in the form of Senate Bill S.2553. It was great seeing my good ideas being embraced!

Small Landlords




Over the past two years, we have seen the COVID-19 Emergency Eviction and Foreclosure Prevention Act's severe, negative impacts on mom-and-pop landlords, many of whom rely on the income they receive from renters to make ends meet. For almost 2 years, many of these mom-and-pop landlords haven't received a dime in rent payments and are facing financial devastation. This is a video of my

comments made back in December of 2020 on the Senate Floor where I publicly warned of numerous negative outcomes for mom-and-pop landlords including their being denied months of rent, the inability of the state to ever make them whole again, and Albany continually kicking the fiscal can down the road -- and the serious, long-term problems that would cause. Unfortunately, my warnings went unheeded, and my predictions came true. Albany needs to prioritize helping our struggling mom-and-pop landlords who are small businesses and need an economic lifeline, not a continuation of eviction moratoriums or to continue being treated like an afterthought by Albany.

School Bus Drivers Needed







Farm Laborers Wage Board



The New York Farm Laborers Wage Board is considering lowering the overtime threshold to 40 hours.
