My efforts to repeal the HALT Act



This was the view outside of my Albany office window on Thursday. Due to the complete oversight of Albany Democrats in passing the HALT Act, inmate on corrections staff assaults are up this year 37% and inmate on inmate assaults are up 30%. We are facing record levels of mandatory overtime requirements for our brave correctional officers who are resigning faster than ever due to the undue burdens placed upon them, and morale, which directly affects recruitment, is at an all-time low.

I am proud to join my colleague Senator Dan Stec as a cosponsor of his legislation

S.9378 to REPEAL the HALT Act. It is time Albany starts respecting and standing up for the brave men and women who put on their uniform, and put their lives on the line, every day to keep us safe. #RepealHALT

My reaction to the verdict in the Ayshawn Davis Case



I am saddened to hear the verdict of the getaway driver who participated in the devastating, senseless killing of 11-year old Ayshawn Davis in September of 2020. This heinous act rocked our communities and left us, understandably, stunned. For such a young and innocent life to be taken mercilessly at the hands of emotionless criminals is not only wrong, but sickening. The fact that the sentence to be decided for the driver of this horrific act of violence is only 5-15 years, is an injustice to the heartbroken family and innocent victim.

I introduced a bipartisan bill with Assemblyman Angelo Santabarbara shortly after this drive by shooting. S2565 /A1590 adds a death as a result of a drive by shooting to the list of offenses that can qualify as murder in the first degree. Murder in the first degree is a class A-I felony that is punishable by life in prison without the possibility of parole.

There have been many drive by shootings statewide in the past several years, so the need for this legislation is there. This year, I forced the bill to be voted on in the Codes Committee via a Notice of Committee Consideration. Every Democrat Majority member shot it down to kill the bill. It is a disgrace that our legislature failed to act on this necessary bill in order to properly dissuade would-be killers and allow for the proper dispensation of justice. I send my sincerest condolences to the family of Ayshawn Davis as they continue to grieve.

Columbia County Honor a Veteran Ceremony



It was my honor to recognize Specialist Third Class John Francis Murphy Junior and present his family with a Senate Proclamation and New York State Liberty Medal, in his honor, recognizing his extraordinary years of service to the United States Army at this month's Honor A Veteran Ceremony at the Columbia County Fire Training Center in Commerce Park, on Monday morning. John Francis Murphy Jr. was born March 14, 1936 to John F. and Marion Margaret (Brand) Murphy in Albany where he grew up and attended high school. Upon graduation, he enlisted for three years in the United States Army and was assigned to the 84th Engineer Aviation Battalion during the Korean War, where he served in combat for ten months and sixteen days. After a cease-fire was signed, he was assigned to the 132 Engineer Aviation brigade and was honorably discharged on February 17, 1956 at Wolters Air Force Base, Mineral Wells, Texas. For his service, SP3 John Francis Murphy Jr was awarded the National Defense Service Medal, Korean Service medal and the United Nations Service medal. After returning home to Albany on April 12, 1958, John married Helene Jan Van Beusichem, adopted three children: Thomas John, Linda Jean and James. He worked as an electric power lineman for Niagara-Mohawk Power Company until his retirement after 35 years of service and was a member of A.B Shaw Fire Company, St. John's and St. Thomas' Lutheran Church, the Hudson Elks, Hudson VFW, Hudson American legion, Hudson Power Boat Association and the Hudson Whalers Pop Warner Football. He served on the Hudson City School District Board of Education for 10 years, and was president for 2 years serving as liaison to the NY State Schools Board. Upon his death on July 8, 2021, John Francis Murphy Jr. left behind three children, and numerous grandchildren and great grandchildren. I am proud to recognize our heroic neighbors on a lifetime of service and dedication given to their nation, state, and communities. Specialist John Francis Murphy Jr. is an example to us all on selfless giving of oneself to protect the people and values we care for, and fiercely defend that which we love.
