This event highlighted the fact that thousands of thoroughbreds who are finished with their racing careers (usually by age 4...with an average of a 30 year lifespan to go) are given another home and other jobs in life. It has been my pleasure to assist ReRun Thoroughbred Adoption in East Greenbush throughout my time as Senator. ReRun is the leading thoroughbred adoption program in NY and the northeast, taking in and placing more than 100 horses per year. ReRun also provides sanctuary to 18 horses that are not deemed adoptable for various reasons. Those that are able and suitable are used for military veteran equine-assisted therapy. ReRun's Program Director, Lisa Malloy, and crew brought Bourban Rising and Sicilia Sal to demonstrate the skills they've learned for the show ring (Remember, these horses were race horses and raced here in Saratoga). They performed wonderfully! Keeping cool in a shed with a fan and a net of Canadian alfalfa was ReRun's Flash Trading who gave me horse kisses and flirted with me. He entertained a lot of other fans as well, including Najja Thompson, Executive Director of New York Thoroughbred Breeders. There are many other aftercare programs in NYS for our retired thoroughbred racers and that ensure they live long, happy, well-cared-for lives.

New York State Association of County Clerks Memorandum Regarding New Gun Control Legislation

As Constitutional Officers of the State of New York and stakeholders in the handgun licensing process; we are writing to expressly voice our concerns over the recent changes to the NYS gun laws which were offered and passed on July 1, 2022, during an "Extraordinary Session" ordered by Governor Hochul.

The resulting legislation is both confusing and cumbersome to navigate for both the citizenry as well as the various agencies in charge of administering and implementing the new laws. In haste to pass the new regulations as a reaction to the recent United States Supreme Court ruling, the process as it stands will now be riddled with complex, confusing, and redundant barriers of compliance. Furthermore, to enact three potentially separate processes for license recertification, with different recertification agencies, will not only lead to further confusion but also create additional problems of record sharing between agencies while placing unfair burdens on handgun license owners.

The County Clerks, County Sheriffs, New York State Police and the Licensing Officers are all partners in the handgun license process. It is imperative that we are provided the necessary tools to best serve all New Yorkers wishing to exercise their right to obtain a handgun or semiautomatic rifle license. To set arbitrary deadlines for compliance and new mandates on local governments without seeking their input, again, sets us and the citizenry up for failure.

The New York State Association of County Clerks is right to be deeply concerned by the new gun laws that were forced through the Legislature by the Governor. These unworkable new laws will place unfair burdens on local governments to enforce Albany's dictates.
