My Analysis of the Extraordinary Session



Extraordinary Session in Extraordinary Times By Senator Daphne Jordan Extraordinary times indeed. Inflation is at its highest in 40 years where gas and food prices are at an all-time high forcing people to choose what needs they can afford. Out of control crime for the past several years is causing nearly 80% of New Yorkers to be concerned that they could be a crime victim. Yes, there should be an Extraordinary Session to address these issues so New Yorkers can afford to live and feel safe to live in New York. An Extraordinary Session to make it more difficult for law-abiding citizens (they are law-abiding if they are going through the process proposed and passed) to get a license for a concealed carry firearm is not the fix.

The Legislative Process

On Friday, June 24 Governor Hochul sent to every Legislator an Executive Chamber Proclamation stating there would be an Extraordinary Session on Thursday, June 30th at noon to address "necessary statutory changes regarding firearm safety, in a way that ensures protection of public safety and health, after the United States Supreme Court decision in NYS Rifle and Pistol Association, Inc. v. Bruen."

SENATOR DAPHNE JORDAN GETS TWO BILLS PASSED AND SIGNED FOR SARATOGA COUNTY

"On Thursday, June 30, 2022, the Governor signed two bills sponsored by Senator Daphne Jordan (R,C-Halfmooon) and Assemblywoman Mary Beth Walsh (R,C-Ballston). Senate bill S9350 allows for the electronic appearance of defendants. S9466 will increase the number of family court judges in Saratoga County by one.

The electronic appearance legislation, sponsored by Senator Daphne Jordan and Assemblywoman Mary Beth Walsh adds Saratoga County to the list of New York counties and boroughs that already utilize this technology. For over two years the Saratoga County Court system has been using electronic appearances to great effect and this legislation makes the benefits to the county permanent.

"I'm pleased to partner with Assemblywoman Walsh to get Senate bill S9350 passed and deliver real results for Saratoga County," said Jordan. "Permitting electronic court appearances was a practice used out of necessity during the COVID pandemic and proved beneficial. It allows for detainees to participate in legal proceedings from a designated space through a two-way, closed-circuit, audio-visual system rather than being physically transported to a Saratoga County Court. Making it permanent for Saratoga County will cut costs by reducing the number of transports while enhancing public safety."

"By utilizing audio-visual technology, defendants will be able to have their cases heard before a judge more expeditiously than what current practices allow," said Walsh. "This measure will not only produce significant cost savings associated with holding and transportation of the defendant, but also an extra level of safety and security in the process."

New York State Sheriffs' Association Statement



New York has a serious problem with gun crime and the Democrat's latest gun control measure is not a serious way to address the problem. The law enforcement professionals of the New York State Sheriffs' Association are making it clear that this unconstitutional gun control bill is not what New York needs. New York needs common sense policies that will protect our rights and public safety!

"July 6, 2022 — Once again the New York State Legislature has seen fit to pass sweeping new criminal justice laws that affect the rights of millions of New York citizens, and which impose burdensome new duties on local government officials, without any consultation with the people who will be responsible for carrying out the provisions of those new laws. This has become a habit with the Legislature and has resulted in other criminal justice disasters such as New York's so-called Bail Reform Law.

Some action by the Legislature was necessary to fill the firearms licensing vacuum created when the Supreme Court struck down New York's unconstitutional restrictions on our citizens' right to keep and bear arms. But it did not need to be thoughtless, reactionary action, just to make a political statement."


Big Moose Deli Visit
