It is befitting that State Route 9P between I-87 and East Avenue in the City of Saratoga Springs that leads to and is adjacent to the Saratoga Race Track, be designated as Marylou Whitney Way. Her advocacy helped the Race Track stay open and helped the Saratoga Meet draw over a million people annually. Her horses were recognized as regular fixtures at the Travers stakes and she claimed victories and a distinguished career as an owner. Marylou was also a consequential figure who did philanthropic good works on behalf of backstretch workers and retired thoroughbreds. In addition, she was a founding member of SPAC, helped to establish the National Museum of Dance, worked to restore the National Museum of Racing, and provided years of support to Saratoga Hospital. Marylou Whitney Way will forever be associated with Marylou Whitney and the contributions she left to Saratoga Springs. I was honored to present a special Proclamation to John Hendrickson, Marylou's husband, in recognition of this important occasion. Thank you to Governor Hochul for celebrating this designation and for signing my Senate bill S6738A to make this a reality. I also thank my legislative colleague, Assemblywoman Woerner, for her work in ensuring the companion bill's passage through the Assembly.

SENATE & ASSEMBLY REPUBLICANS CALL ON FARM LABOR WAGE BOARD TO REJECT REDUCTION OF OT THRESHOLD

To Save the Future of Family Farming in New York State

SCHODACK LANDING, NY -- New York State Senators Sue Serino and Daphne Jordan today stood with Assembly Members Jake Ashby and Chris Tague and members of the local agriculture community calling on the Farm Labor Wage Board in Albany to reject a reduction of the overtime threshold from the current 60 hours to the proposed 40 hours.

"The Farm Laborers Wage Board must heed what they are being told as the future of New York's farms is hinged on the Wage Board's decision in just five days. Lowering the threshold 40 hours will impact our family farms significantly, including leaving the industry and heading out of New York. Our economy cannot afford to lose farmers and the important agricultural resources they bring to communities. Instead we should be developing and working on policies that enable our Agriculture community to thrive and prosper," said Senator Daphne Jordan.

"I govern by listening and when our family farmers and workers tell me that this change could devastate the agricultural industry that our state depends on, I take notice," said Senator Sue Serino. "It is far past time for others in Albany to do the same and put an end to their misguided attempts to lower the overtime threshold. Our family farms are a staple in our communities and the backbone of our economy, and we should be focusing instead on advancing policies that actually enable them to thrive. I am committed to ensuring that the voices of our farmers and workers are heard and their needs met, which is why I am urging the Board to do the right thing, stay at 60 and save the future of farming in New York State," said Senator Sue Serino.

"Our State relies on our agricultural industry not just as vital food producers but also as the economic backbone of many communities. It is imperative that we ensure the continued success and existence of our local family farms and an easy start is eliminating this unnecessary

Columbia County Honor a Veteran









On Monday, I joined Columbia County to present a New York State Liberty Medal to the family of US Army Veteran John A Mesick. Born in Valatie, NY John joined the Army in March of 1943 and was deployed to Europe as a member of Battery C, 21st Field Artillery Battalion, 5th Inf. Div., 3rd Army. He saw his first combat as a member of the first wave to hit Omaha Beach on D-Day. Cpl. Mesick and his unit would fight alongside the rest of General George Paton's 3rd Army across France and into Germany, seeing intense fighting in the Battle of the Bulge in particular. After completing the liberation of Western Europe, John was sent home and was discharged in October of 1954.

For his honorable service Cpl. John Mesick was awarded the French Croix de Guerre, 5 Bronze Stars, and a Good Conduct Metal.

After returning from war, John met and married his wife Frances, and together they raised four children. While working for the Columbia County Telephone Company, John continued to serve his community as Mayor, Police Chief, and Fire Chief of Chatham. He was a life member of Ghent VFW #5933, the Chatham American Legion Post #42, and the Ground Observer Corps during the" Cold War". John Mesick passed away on December 31st, 2019 after 70 beautiful years with Frances and their wonderful family. Thank you to Columbia County for Honoring such a remarkable American.

NEW YORK STATE LEGISLATURE

Dear U.S. Senators and Members of the New York Congressional Delegation:

The Centers for Disease Control and Prevention (CDC) recently updated its guidance to better reflect the progress made after understanding and combating the COVID-19 virus. Most notably, the CDC now recommends that those exposed to COVID-19 are no longer required to quarantine, regardless of vaccination status. Per the CDC, the new guidelines "help us to move to a point where COVID-19 no longer severely disrupts our daily lives."

A return to normalcy is long overdue, but New Yorkers deserve so much more after over two years of living under pandemic restrictions, some of which cost them their livelihood. We continue to face shortages in the fields that are critical to our residents' well-being, including our law enforcement, firefighters, teachers and healthcare workers. We are sure we can all agree that we must do everything we can to advocate for these essential workers.

Just last week, CDC Director Rochelle Walensky admitted the agency's actions throughout the pandemic "fell short in many ways" and "had some pretty public mistakes. . ." She then announced an agency reset aimed at improving CDC operations during public health emergencies, including how the agency develops public health guidance. It is crucial that this reset include a reevaluation of executive agency regulations made permanent or still in effect related to the COVID-19 pandemic, particularly 86 FR 61555 entitled "Medicare and Medicaid Programs; Omnibus COVID-19 Health Care Staff Vaccination."

We have seen and heard firsthand how the healthcare workforce shortage is substantially affecting patient care, increasing healthcare costs and jeopardizing New York's healthcare infrastructure. Governor Hochul first declared a Statewide Disaster Emergency Due to Healthcare Staffing Shortages on September 27, 2021 and continues to extend it to date. Even with final acknowledgement of this crisis, the state and federal governments continued implementation of the COVID-19 vaccine mandate on healthcare personnel. Dedicated healthcare workers not only unjustly lost their livelihoods after giving so much throughout the pandemic, but this only exacerbated the emergency in the state. Reevaluating mandates such as these, given the new CDC guidelines and the Director's admission of mistakes, is crucial as we move out of the pandemic and glean wisdom from this horrendous experience.


We strongly urge your partnered advocacy in standing up for our displaced healthcare workers following the easing of CDC guidelines. We will continue to advocate for reevaluation of this mandate here in New York as the Governor moves forward with an assessment of the State's COVID-19 response and urge you to do the same at the federal level. We must not allow ineffective decisions made at the height of the pandemic to continue to negatively affect our healthcare sector. We look forward to an opportunity to work with you on behalf of all our heroes.
