My reaction to the Farm Labor Board Report



There were 440,000 acres of farm land in the 43rd Senate district when I became Senator in 2019. I personally know of farms that have dried up and closed up since then and I know of more that won't be able to make it economically if the overtime threshold is decreased from the current 60 hours to 40 hours.

There is a grave misconception among the downstate interests that pushed for the lower threshold in comparing farming to the standard 40-hour workweek and overtime pay in manufacturing and other industries. You see, in farming, you gotta make hay while the sun shines. For those of you that don't know, when you cut hay for feed, you've got to put as many man hours as it takes to bale that hay and store it away before it rains and loses its nutrients and consequently is no good. That saying holds true for planting seeds and harvesting fruits and vegetables. Farming is not the constant hum of machinery in manufacturing ...hour by hour...day by day...week by week.

There is also a misguided thought that New York's agricultural community is dominated by large, corporate-supported factory farms that are common in the West and Midwest and therefore, farms should abide by a 40-hour manufacturing workweek. Actually in New York, 96 percent of farms are small, family-owned businesses. These small family farms ensure quality farm products to nourish New Yorkers and also, drive economies of rural communities.

The Farm Laborers Wage Board needs to be reminded of the recent state-funded report conducted by researchers at Cornell University. The study found that if the overtime threshold was lowered to 40 hours, two-thirds of dairy farmers would make significant changes to their operation, including leaving the industry or investing out of state, and half of fruit and vegetable farmers indicated they would decrease their operations or leave the industry.

It was also reported that approximately 70 percent of H-2A workers would be less likely to do their current job or would consider going to another state without capped hours if they were capped at 40 per week. The findings of the report are what we hear from our farmers and farmworkers. The Wage Board heard these same concerns from farm managers at their public hearings.

The Farm Laborers Wage Board's recommendation to lower the overtime threshold to 40 hours on Tuesday, ignored what New York Farmers and farmworkers told

them. Department of Labor Commissioner Reardon has 45 days to accept or reject the Wage Board's recommendation. I urge the Commissioner to listen up and heed New York's farmers and farmworkers; the future of New York's farms is hinged on this decision.

If anyone is to remember anything, common sense prevails in just two sayings:

Gotta make hay while the sun shines...

And...

No farms, no food.
