Dear Governor Hochul and Commissioner Bassett:


We write to you today seeking immediate action and the full resources of the state to address the widespread baby formula shortage affecting New York. As you may or may not be aware, this shortage has reached crisis proportions across our entire country. In recent weeks, we have heard from countless families in our districts about empty store and pharmacy shelves – and parents with nowhere left to turn.

As parents ourselves, we fully understand the struggles facing those raising newborns and infants on a day-to-day basis. No mother or father should ever have to worry about whether or not they can feed their infant child.

Albany Must Use Full Force of the State to Tackle Widespread Formula Shortages Harming Infants & Parents Across NYS.

No mother or father should ever worry about whether or not they can feed their infant child. In recent weeks, I have heard from countless families in my district about empty store and pharmacy shelves where baby formula should be – and parents with nowhere left to turn. New Yorkers are fed up. It's time for Albany to unleash the full strength of our state government to address the crisis. The time to act is now. Rally in support of safe at-grade pedestrian access to the Village of Castleton-on-Hudson Riverfront Park









Saturday in the Village of Castleton-On-Hudson I joined Mayor Joe Keegan, Deputy Mayor Jenifer Pratico, Trustees Sharon Martin, and Lissa D'Aquanni, President of Castleton-on-Hudson Main Street Association Suzanne Donnelly, Schodack Town Supervisor Chuck Peters and Director of Land Use Advocacy for Scenic Hudson Jeffrey Anzevino to rally in support of safe at-grade pedestrian access to the village Riverfront Park. 28 years ago the Village and New York State Department of Transportation agreed to close Scott Ave. crossing to vehicular traffic—as long as pedestrian access was provided to Riverfront Park. Because high-speed rail was considered, fencing and gate were installed. In 2014, a study determined that high-speed rail would not be feasible. Residents are still gated out from their park along the Hudson. NYSDOT's answer is to build a \$5 million dollar overpass with an elevator in which the Village taxpayers would be responsible for its operation and maintenance. The common sense solution to this is for the State to advance a reasonable, responsible, realistic solution that FINALLY provides safe at-grade access to the Hudson River. Local control, local access to their local community is important to reclaim waterfront and in so doing, improve the local economy and strengthen the local quality of life. In the words of an astute observer, "It's time to put Castleton-BACK-On-the-Hudson!




