I Stand Against Partisan Gerrymandering



The Democratic Majority's gerrymandered maps prove the saying that 'power corrupts – and absolute power corrupts absolutely.' Their maps were the result of a corrupt process, failed to respect, and respond to, the will of New Yorkers, demonstrated political partisanship run amok, and utterly failed to fulfill the promise of truly independent redistricting that New Yorkers wanted, and voted for, twice, and rightfully deserved. Bail Reform Press Conference






Assessment Program
