ORDERED, ADJUDGED and DECREED, that the motions to dismiss by Respondent Espada and Respondents Alesi, et al. are hereby denied; and it is further

ORDERED, ADJUDGED and DECREED, that Petitioner be granted a judgment of *mandamus* against each Respondent *to convene into session as* ~~compelling said respective Respondent's personal~~ *one group consistent with the Senate Rules on 6/30/09* ~~attendance in full assembly~~ at extraordinary sessions of the Senate called by Petitioner pursuant *10:00 AM*

to Article 4, Section 3 of the Constitution; and it is further


ORDERED, ADJUDGED and DECREED, that Petitioner be granted a judgment of *mandamus* against Respondents compelling Respondents to convene in simultaneous full assembly with the capacity to conduct Senate business; and it is further
