An order of the Albany County Supreme Court (Teresi, J.) granting petitioner a writ of mandamus to compel.

Nature and Object of Proceeding:

Petitioner, Governor of the State of New York, sought a writ of mandamus to compel to force all elected Senators to act on legislation he submitted pursuant to Article IV, § 3, extraordinary session.

Appellate Issue(s):

Whether the Governor can compel a quorum to attend and/or pass specific action on legislation once the New York State Senate convenes pursuant to a proclamation for extraordinary session.

Whether the speech or debate clause, separation of powers, mootness, and actual compliance with proclamations of extraordinary legislative sessions, precludes the relief sought.
