Most importantly, I will continue to do my best to raise awareness of the harmful affects of animal cruelty. I have been – and will always be – a strong supporter of Lollypop Farm and its efforts to build lifelong bonds between people and animals through education, community outreach and the prevention of animal cruelty.

Penfield Celebrates 200 Years!

This past Tuesday, March 30th, the Town of Penfield turned 200 years old, making Penfield the oldest town on the east side of Monroe County. Penfield kicked-off her Birthday in grand style, celebrating the Town's Bicentennial last Saturday night at the Daisy Flower Mill with local dignitaries, community leaders and Town residents. I was delighted to be on hand to present Supervisor Tony LaFountain, and members of the Town Board, with a resolution commemorating Penfield's Bicentennial and rich history. The resolution was passed in the NYS Senate and is part of our state's permanent record.

Incorporated in 1810, Penfield's history began years earlier when, in 1795, Daniel Penfield began purchasing land in Township 13, Range IV, and began building mills in 1800 along the falls of Irondequoit Creek to encourage settlement. The population grew rapidly, and on March 30, 1810, Township 13 and the adjoining Township 14 were designated by the New York State Legislature as the Town of Penfield.

Today, I am honored to represent such a great community in the Senate. Since my days in the Assembly, I have formed lasting friendships with many Town officials – both past and present – and have had the great privilege of assisting thousands of Town residents through the years. From its humble beginnings on the banks of Irondequoit Creek, Penfield is now home to more than 35,000 residents, and I am excited to share this Bicentennial year with each of them.
