usinesses regularly benchmark their cost of doing business against their competitors — because they know that if their costs are too high, they won't be in business much longer. The table below does the same for government in New York State — comparing the key, government-related costs of living and doing business in New York, with the national average. **These key costs are more than \$35 billion higher** than they would be, if New York matched the national average. That's about \$1,830 a year for every man, woman and child in the state — or \$5,015 for every private-sector job.

Data summary and sources

Data in this table are statewide averages. Costs for taxes, energy and health insurance vary significantly within New York State, and are typically higher in the Downstate metropolitan region than in most of Upstate.
