

# Strengthening regional public health and safety

■ here were two very positive announcements on regional public health and safety recently that I think are worthwhile to highlight again here. The first one deals directly with what many of us consider the No. 1 public health crisis facing our region, state and nation at the moment: the heroin epidemic. As you've been reading in this column over the past few years the Senate Task Force on Heroin - working in a strong bipartisan fashion with the Cuomo administration and the state Assembly – has been diligently enacting a four-pronged strategy to combat the epidemic of addiction that's destroying individual lives, families and communities.

The strategy focuses on the following: Prevention. Recovery. Treatment. Lawenforcement.

So we're encouraged by the recent announcement that Cayuga Addiction Recovery Services in Trumansburg is being awarded \$1 million to construct a new, 25-bed residential facility to treat patients suffering from substance use disorders. We could use many more

beds, we know that, but this is an important step forward in the Southern Tier. It allows us to keep building on this new foundation.

Treatment and recovery services are cornerstones of the ongoing battle. These new residential treatment beds are critical. I look forward, together with the colleagues I serve with on the Senate's Heroin Task Force, to keep working with the Cuomo administration, our Assembly colleagues, and all of the local leaders, treatment providers, law enforcement agencies and concerned citizens doing our best to strengthen the statelocal-federal partnership that we need to most effectively respond to this crisis.

Bill Rusen, CEO of Cayuga Addiction Recovery Services, predicted

that the new residential treatment facility will have a "big impact" in the Southern Tier region for those for whom this type of care has not been an

The 2016-17 state budget invests nearly \$200 million to combat the heroin and opioid epidemic - an 82 percent increase in funding since 2011. It invests in new residential treatment beds, including counseling and support services; medication-assisted treatment programs that serve clients in residential or outpatient settings; state-operated Addiction Treatment Centers; outpatient services that provide group and individual counseling; and crisis/detox programs to manage and treat withdrawal from heroin and opioids, among other initiatives.

In addition to these new foundations, we've enacted a comprehensive package of new anti-heroin laws this year including actions to: significantly reform insurance laws and regulations to ensure broader coverage of substance use disorder treatment and

improve access to addiction treatment; place limits on opioid prescriptions; increase, from 48 to 72 hours, evaluation for individuals incapacitated by drugs; require training to improve connections to substance use disorder care upon hospital discharge; require ongoing education about addiction and pain management for physicians and prescribers; and mandate pharmacists to provide information about risks of substance use disorder to clients.

This new facility is extremely positive news.

The second example of positive news deals with a recent meth labrelated bust in the town of Erin that resulted from a public tip to the Chemung County Sheriff's Office. News of this arrest provides an opportunity to make this point: regional police tip lines make a difference in law enforcement's daily fight against meth, heroin and other illegal drug trafficking and criminal activity.

Our local law enforcement agencies are grateful for anything and everything we can do to support their sacrifices

and their incredible service - day after day, night after night – to protect our neighborhoods and communities.

Yates County Sheriff Ronald Spike writes, "Communications with those we serve has always been paramount in law enforcement. We will go forward together into the future facing the public safety challenges as through the Internet you become a partner with us in enhancing the quality of life for all who live in and visit Yates County."

Remember: We can all make a difference in public safety, and we can't thank our law enforcement officers enough for their service and sacrifices on our behalf.
