Decent affordable housing is one of the most fundamental human needs. However, far too many New Yorkers are burdened by skyrocketing rents, unsafe living conditions, and other conditions that destabilize individual households and entire communities.

The state's rent regulation laws, which apply throughout New York City and in certain localities in Nassau, Westchester, and Rockland Counties are scheduled to expire and must be renewed by June 15, 2019. In the past, the legislature and the Governor have enacted renewal legislation with only modest changes, leaving in place many provisions that limit the effectiveness of the laws. This year, a wide range of bills have been proposed to strengthen tenant protections and expand the geographic scope of the laws, and to enact protections to supplement those offered by the rent laws. The Senate Committee on Housing, Construction, and Community Development is holding a series of public hearings to take testimony from New Yorkers with an interest in these matters, to inform the legislative process.

Those wishing to present pertinent testimony to the Committee at the above hearing should complete and return the attached reply form as soon as possible. It is important that the reply form be completed and returned so that potential witnesses may be notified in the event of emergency, postponement, or cancellation.

Oral testimony will be limited to 10 minutes, with additional time at the Committee's discretion to respond to any questions Senators may have. In the event a large number of witnesses wish to testify, the Committee may reduce the 10 minute time limit, to permit more participants. In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times, but can offer no guarantees. Requests should be made on the attached reply form or communicated to Committee staff as early as possible. If translation services are needed, please email the Committee staff person below.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. In addition, the Committee would appreciate advance receipt of prepared statements, in PDF or similar digital format.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.

In order to meet the needs of those who may have a disability, the Senate, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities.
