IMAM SHOT

Detectives question man in slayings

NEW YORK - Police detectives investigating the slayings of an imam and his friend have detained and questioned a man as part of an attempt to identify a vehicle seen leaving the scene of the shooting, authorities said Monday.

The man was taken into custody in connection with "an unrelated incident" but had been questioned by detectives regarding the Saturday afternoon shooting of Imam Maulama Alauddin Akonjee and Thara Uddin, said Stephen Davis, the New York Police Department's top spokesman.

He was still in custody late Monday afternoon but hadn't been charged with a crime. Police didn't identify him.

shot shortly after leaving the Al-Furgan Jame Masjid mosque in the Ozone Park neighborhood of Queens.

Passions ran hot at a funeral service for the two victims.

About 1,000 people, including New York City Mayor Bill de Blasio, gathered under tents in a parking lot to praise the two men.

The ceremony featured several speakers who said they believed the victims were targeted because of their religion. Some members of the congregation shouted, "Justice!" periodically throughout the service.

"I want you to know that we are all mourning with you," de Blasio

In that case, a witness to the crash recorded the car's license plate. Investigators from a warrants squad tracked it to an address in Brooklyn where they waited in an unmarked police cruiser for the man to enter before blocking him in, police said.

The man intentionally bumped their vehicle with his car before he was placed in handcuffs, they said.

The case has not been classified as a hate crime, and police haven't said what prompted the brazen daytime shooting. The gunman is a dark-haired, bearded man wearing glasses, according to a police sketch artist's depiction.

The shooting has shocked the largely Bangladeshi Muslim community in Queens and Brooklyn. Some residents have described harassment in recent months by people who shouted anti-Muslim epithets.

Hornell, Arkport bring in \$7.5+ million in aid

HORNELL - State Sen. Tom O'Mara (R-Big Flats), chairman of the Senate Environmental Conservation Committee, announced Monday that the city of Hornell and the Village of Arkport are among eight Southern Tier municipalities selected to share \$13.7 million as part of the second round of funding being awarded under the state's Water Infrastructure Improvement Act of 2015.

"It's great news that the state is taking steps to distribute this vital funding as quickly as possible to help localities across the Southern Tier and Finger Lakes regions, and statewide, undertake these critical water infrastructure improvement projects," O'Mara said. "We're hopeful that ongoing state assistance will prove successful in helping localities complete vital projects including sewer and pipeline repairs."

The grant awards include a \$3 million Water Infrastructure Improvement Act grant for Hornell

to undertake a major work to be able to take the drinking water infrastructure improvement project. The grant for Hornell will be supplemented by lowto-no interest loans for \$3,830,000, from the state's Environmental **Facilities Corporation**

Hornell Mayor Shawn Hogan was grateful for the much needed funding.

"The governor's office called me and said the news would be released. We have several major projects going on at the water filtration plant, creating a new storage tank, making sure we had two upgraded clarifiers up and working, and bringing the plant up to the 21st century as far as digital operation," Hogan said.

The money will also allow the city to repair its main line running from the reservoirs in Fremont to the city.

"A lot of that line over time has become exposed, this will help us make sure it's protected from any elements, floods or other problems," Hogan said.


However, getting the project to the working phases is expected to take up to six months as the city consults with engineers who will make detailed plans.
