<u>PURPOSE</u>: To discuss and examine the creation of an automatic voter registration system in

Currently, New York has one of the lowest voter registration and turnout rates in the country. According to 2016 Census data, 66% of citizens in New York State are registered to vote and just 57% of New Yorkers turned out to vote in the 2016 election. This puts New York at 46<sup>th</sup> out of 50 states for registration and 43<sup>rd</sup> for voter turnout. New York also has one of the most burdensome voter registration systems in the country. In order to participate in their democracy, potential voters are required to mail paper forms, and in many cases, register up to thirteen months before an election depending on their party affiliation. New York's paper-based voter registration system is inefficient, error prone, and unjustifiably costly. A modern voter registration system that electronically transmits voter registration information will reduce costs involved in processing voter registrations, maintain complete and accurate voter registration lists, and increase voter participation.

Automatic voter registration (AVR) is an innovative policy that streamlines the way Americans register to vote. Automatic voter registration works in two steps. Eligible voters (except for those who opt out) who interact with government agencies such as the Department of Motor Vehicles and the Department of Health, are automatically registered to vote or have their existing registration information updated, unless they affirmatively decline. Voters can opt-out; it is not compulsory registration. Second, those agencies transfer voter registration information electronically to election officials instead of using paper registration forms. It is a simple process that eliminates unnecessary paperwork and lowers barriers to political participation. Fifteen other states and the District of Columbia have either approved or implemented automatic voter registration. Other states, such as Oregon and Colorado, that have implemented similar programs, have experienced increased voter registration and significant cost savings.

This hearing will explore the implications of establishing an automatic voter registration system in New York, and the steps necessary to achieve and implement a robust and accurate system.

**Oral testimony will be limited to 5 minutes' duration**. In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

**Ten copies** of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.
