#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Finance has legislative oversight responsibilities for issues concerning Budget, Fiscal Review, Resolutions and Nominations .

During the 2023 Legislative Session, 765 bills were referred or dual referenced to the Committee for its review. Of these bills, 495 were reported from the Committee, 218 were passed by the Senate, and 116 passed in both houses. This work was conducted through a series of 17 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

- In addition to its regular meetings, the Committee held 14 Joint Legislative Budget Hearings, and co-sponsored a hearing to examine issues in the New York State market related to consumer accessibility and retail sale of legal adult-use cannabis.
