COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Transportation has legislative oversight responsibilities for issues concerning canals, highways, navigation, transportation authorities, railroads, rapid transit, aviation, and vehicle and traffic laws.

During the 2023 Legislative Session, 517 bills were referred to the Committee for its review. Of these bills, 133 were reported from the Committee. 106 were passed by the Senate, and 46 passed in both houses. This work was conducted through a series of eight committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2023:

- **S.5527** (Cleare) Chapter 491 of 2023. This bill provides that information concerning services for human trafficking victims must be posted within MTA facilities. Transportation facilities are known hubs for human trafficking, and having resources posted may help victims escape their captors.
- **S.1368** (Kennedy) Veto 68 of 2023. This bill extends the stretch limousine task force and requires at least one additional report on the topic. This bill passed the Senate as part of a larger limousine safety package of bills.
- S.2712B (Kennedy) Chapter 532 of 2023. This bill dedicates specific revenues from drug-impaired driving surcharges to the STOP-DWI program. Over the past decade, STOP-DWI programs have seen a reduction in funding by 21%. Dedicating surcharges to the program will eliminate that funding reduction, resulting in over \$7 million more for STOP-DWI programs statewide.
- **S.4671** (Thomas) Chapter 722 of 2023. This bill enacts "Angelica's Law." This law creates a new Class E Felony offense for operating a vehicle without a license with five or more previous license suspensions or revocations for moving violations.
- S.5129A (Webb) Chapter 517 of 2023. This bill requires an operator of a motor vehicles to exercise due care and move over to another lane, if possible, should a vehicle be stopped, parked or standing on the shoulder of a highway.
- S. 5775 (Kennedy) Chapter 707 of 2023. This bill requires any freight rail operator within the state have a minimum of two persons on board as crew. There have been attempts by some railroad companies to only have one crew member on a freight train, and with a rise in concern over freight rail derailments, this law will require at least two crew on board.

TWO HOUSE BILLS

In 2023, 46 of the 517 bills referred to the Standing Committee on Transportation passed both houses of the Legislature. Of these bills, the Governor has signed 45 and vetoed one.
