I am pleased to transmit the Annual Report of the Senate's Standing Committee on Judiciary for the 2023 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters under my committee's jurisdiction, such as filling Court of Appeals vacancies, addressing court backlogs statewide, protecting families and medical providers with the Transgender Safe Haven Act, and shining a light on the widespread issues in Family Court.

During the 2023 Session, this Committee met sixteen times in Session, reported eighty bills, and favorably reported one nominee for Chief Judge of the Court of Appeals, one nominee for Associate Judge of the Court of Appeals, fifteen nominees for Court of Claims, one nominee for Monroe County Family Court, and three nominees for Interim Supreme Court Justice. The Committee reported one nominee for Chief Judge of the Court of Appeals without recommendation. The Committee also held one hearing this past year.

I thank my colleagues who served on the Committee for their efforts and support of the work that was done in the Committee this year, and I thank you for the continued support from the Majority Conference in the Committee's operations.

COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Judiciary has legislative oversight responsibilities for issues concerning New York's civil justice system, debtor and creditor laws, domestic relations laws, estates, powers and trusts laws, general obligations laws, real property laws, and the judicial branch of state government. The Judiciary Committee also has the special responsibility of considering resolutions to amend the State Constitution, and to consider and approve certain gubernatorial judicial appointments, including appointees to the New York State Court of Claims and Court of Appeals.

During the 2023 Legislative Session, 347 bills were referred to the Committee for its review. Of these bills, eighty were reported by the Committee. Sixty-five were passed by the Senate, and twenty-seven passed in both houses. This work was conducted through a series of nine committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

The committee also favorably reported one nominee for Chief Judge of the Court of Appeals, one nominee for Associate Judge of the Court of Appeals, fifteen nominees for Court of Claims, one nominee for Monroe County Family Court, and three nominees for Interim Supreme Court Justice. The committee reported one nominee for Chief Judge of the Court of Appeals without recommendation.

In addition to its regular meetings, the Committee held a joint hearing with the Children & Families Committee on the New York Family Court.

TWO HOUSE BILLS

In 2023, 27 of the 347 bills referred to the Standing Committee on Judiciary passed both houses of the Legislature. Of these bills, the Governor has signed eighteen and vetoed none, with six bills remaining to be acted on. Four bills were delivered to the Secretary of State, of which two went before the voters and were ratified in a statewide referendum.
