COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Women's Issues has legislative oversight responsibilities concerning the right, health and any issues pertaining to women in New York State. This includes legislation dealing with reproductive health, bodily autonomy, and women's rights.

During the 2023 Legislative Session, thirty-seven bills were referred to the Committee for its review. Of these bills, twenty-two were reported from the Committee with two additional bills discharged through the Rules committee. Twenty-one bills were passed by the Senate, and nine passed in both houses. This work was conducted through a series of five committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held a meeting with the Office of Prevention of Domestic Violence (OPDV) and a joint hearing with the Senate Social Services Committee on domestic violence. In the meeting with OPDV, committee members were educated on the role of OPDV, the resources that are available for domestic violence victims through the office, and the critical issues facing providers of services for victims of domestic violence across the state. The joint hearing examined whether the current continuum of care is meeting the needs of survivors of gender-based and domestic violence, with pertinent human service agencies, advocates, and service providers giving testimony on the state of services.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2023:

- S.3608A (Webb) Chapter 588 of 2023. This bill directs the Department of Health to create and make available a video regarding the dangers of drowning geared toward toddlers and young children to be viewed by new parents prior to their release from the maternity ward.
- S.4263 (Webb) Chapter 490 of 2023. Relates to information concerning services for human trafficking victims in lactation rooms in Port of New York Authority terminals.
- S.4266A (Webb) **Chapter 732 of 2023.** Establishes a task force on missing women and girls who are Black, Indigenous and people of color.
- S.4267 (Webb) Chapter 495 of 2023. Requires the Port Authority to provide information concerning services for human trafficking victims in lactation rooms at its bus terminals.
- S.5913A (Chu) Chapter 662 of 2023. This bill requires menstrual products to be offered for free in non-public schools.
- S.6082A (Fernandez) Chapter 533 of 2023. This bill will provide informational pamphlets for those experiencing pregnancy loss or infant loss on what to expect and resources to help them navigate through the healing process.

A complete list of all chaptered bills and a summary of committee activity is provided at the end of this report.

TWO HOUSE BILLS

In 2023, twenty-four of the thirty-seven bills referred to the Standing Committee on Women's Issues passed both houses of the Legislature. Of these bills, the Governor has signed nine and one bill is awaiting the Governor's action.
