I would like to thank you for the opportunity to serve as Chairman of the Senate Standing Committee on Social Services. The important work of this committee affords us the opportunity to enhance many aspects of citizens' lives, including serving those with disabilities; ensuring the upholding of human rights as well as equal opportunities for all New York State citizens; and also ensuring that those programs are accessible for low-income families.

As is outlined in this report, our work this year served to identify the delicate balance between our responsibility as public officials to provide for those in need or those who cannot defend themselves, with our interests in ensuring that government operates at the highest level of efficiency with the least amount of resources exhausted. #### **Legislative Overview**

In 2017, the Social Services Committee reported 29 bills from Committee. Of these 29 bills, 14 were advanced to a committee of secondary reference and did not advance further. A total of 15 bills advanced to calendar, none of which died on third reading calendar. Of the 15 bills that advanced to calendar, 9 of them passed the Senate only, and died in the Assembly, and the remaining 6 passed both Houses. From the 6 that passed both Houses, 5 were signed into law and 1 was vetoed by the Governor.
