Dear Senator Flanagan:

I am pleased to submit the annual report of the Senate Standing Committee on Veterans, Homeland Security and Military Affairs for the 2017 Legislative Session. It has been my privilege to work with my colleagues to bring about the passage and enactment of several laws that will positively impact the people of New York.

This fall, I hosted my Second Annual Veteran's Day Coloring and Essay Contest. The contest was open to all 4th and 8th grade students residing in, or attending an educational institution in, the Third Senate District. Again, I was overwhelmed by the participation from our young children and am immensely proud to be part of a community that has such respect and admiration for our veterans. The winning poster is displayed on the front cover of this report, and the winning essay is featured on the back cover. The John P. Jennings Veterans Advisory Panel conducted the judging for this contest, and I am grateful to the panel for their time and continued service to our veterans.

This report details the activities of the Committee from January 1, 2017 through December 31, 2017. In 2017, 169 bills were referred to the Committee, and 85 bills were reported from the Committee. Of the 85 bills reported from committee, 61 bills were subsequently passed by the State Senate. Of the 61 bills approved by the State Senate, 10 were also passed by the State Assembly. The Governor has signed nine pieces of legislation into law, and has vetoed one measure which was aimed at improving the state's disaster emergency preparedness plan by requiring that consideration be given to how medication and supplies can be delivered to an impacted area during a declared disaster.

- Angelo LoMonaco, Denis J. McEneaney, and Elizabeth R. Carr as Members of the Board of Visitors for the New York State Home for Veterans and Their Dependents at St. Albans.
- Steven Ferrari and Raymond F. Shields, Jr., as Major General of the New York Army National Guard.

The Committee wishes Commissioner Parrino much success as he carries out the crucial missions of the Division and sincerely thanks Major General Steven Ferrari and Major General Raymond F. Shields, Jr., for their service and dedication. The Committee also thanks the Board of Visitors members who agreed to be reappointed this Session, for their continued commitment. These board members serve an important role in the operation of the state-operated veterans homes. They serve as ambassadors, in monitoring the way the home is administered, recruiting residents, soliciting funds, participating in Resident Council meetings, and in financing and arranging off-site activities. While the Committee appreciates the Governor's efforts in reappointing many past members to the various state-operated veteran home boards, further measures must be taken by the State to recruit new members and fill several long-standing vacancies.

The Committee remains dedicated to monitoring the progress of the Service Disabled Veteran Owned Business Program. Enacted in 2014, this program is overseen by the Office of General Services. While the Office has done tremendous work in certifying and assisting our service-disabled veteran owned businesses, more work needs to be done by state agencies to ensure that every entity is working towards meeting their statutory goal of setting aside 6% of state contract work for service-disabled veteran owned business enterprises.

Finally, the Committee remains concerned about Homeland Security generally, and the deteriorating conditions occurring around the world. Unfortunately, New York remains the number one target of terrorists, worldwide. The Senate again passed several landmark pieces of legislation meant to improve cyber security, prevent terror attacks, and help ensure that our law enforcement agencies have the tools and resources they need to combat this growing threat. We welcome partnership from the Governor and Assembly on these initiatives.

I would like to thank all the committee members for their continued support and commitment throughout the legislative session. I would also like to thank the Committee's Ranking Minority Member, Senator Joseph Addabbo, for his partnership in advancing causes that will improve the lives of our veterans, service members and all New Yorkers. I would also like to thank you for the opportunity to Chair this Committee. It is a great honor to serve in this capacity and I look forward to continuing this important work.

Appendix - Summary of Action on All Legislation Referred to the Senate Standing Committee on Veterans, Homeland Security and Military Affairs

I. Committee Jurisdiction and Summary

The Senate Standing Committee on Veterans, Homeland Security and Military Affairs is a trifurcated committee. It addresses the following: (1) issues impacting veterans and their families; (2) concerns related to homeland security and emergency preparedness; and (3) matters involving current military members and their families.

Almost one million veterans have made New York State their home. The Committee seeks to promote legislation and protect the programs that benefit our veterans and their families. Given that 70% of our state veterans served during war and that 25% have servicerelated disabilities, particular care is taken to address the needs of our combat and servicedisabled veterans. The Committee examines all issues relating to veterans' benefits, and those veteran affairs issues that arise under the Civil Rights Law, Civil Service Law, Education Law and the Executive Law. The Committee maintains contact with the veteran community, the organizations which serve them, the NYS Division of Veterans Affairs and the Office of General Services Division of Service-Disabled Veteran Owned Business Development, in order to address issues impacting this population.

The Committee also oversees matters related to disaster preparedness and counterterrorism readiness. New Yorkers suffered disproportionately on September 11, 2001. We must never forget the lives that were lost and the lessons that were learned from this devastating terrorist attack. Given the deteriorating conditions around the world, ensuring that our law enforcement agencies have the tools they need to prevent a future terrorist attack is one of the primary focuses of this Committee. Addressing issues of cyber-security, particularly those impacting state-owned critical infrastructure, is of upmost concern. Additionally, ensuring that law enforcement agencies and first responders have the training and necessary tools to respond to both natural and man-made disasters, is within the purview of this Committee as well.

Third, the Committee addresses issues arising under the Military Law, generally, and matters concerning the State Defense Emergency Act, the Interstate Civil Defense Compact and military and national defense. Given the tragic events in Chattanooga, TN in 2015, where a gunman opened fire on two military installations, the hardening of state-operated recruiting centers is a current focus of the Committee.

II. Legislative Highlights

Several significant pieces of legislation, originating in this Committee, passed both Houses of the Legislature this past Session. They are as follows:

*S946A (Croci): This legislation waives the State Civil Service exam fee for original appointments, for all honorably discharged veterans and those discharged under honorable circumstances. Chapter 404 of 2017.

*S1724 (Carlucci): This legislation establishes a local option for school districts to extend the "eligible funds" veterans' real property tax exemption, for purposes of school taxes. Chapter 376 of 2017.

*S1852 (Croci): This legislation requires the Division of Veterans' Affairs to include on their Information for Veterans concerning Health Care Options fact sheet, contact information for each New York State veterans' home. Chapter 287 of 2017.

*S4730 (Larkin): This legislation requires that the Division of Veterans' Affairs and the Department of Taxation and Finance to annually remind assessors that for purposes of the Veterans Alternative Real Property Tax Exemption, the Persian Gulf conflict includes those who served in the hostilities in Afghanistan and Iraq. Chapter 286 of 2017.

*S2911A (Croci): This legislation affords state employees with military combat experience with additional paid leave, so that they may obtain health related services without suffering loss in pay. Chapter 406 of 2017.

*S5016A (Lanza): This legislation includes home care and hospice agencies among the local parties providing "advice and assistance" into the New York City Comprehensive Emergency Management Plan. Chapter 385 of 2017.

*S5317A (Croci): This legislation amends the annual reporting requirement due from the Division of Service-Disabled Veterans' Business Development, so that the report they issue is parallel to the report issued for the utilization of minority-women business enterprises. Chapter 352 of 2017.

*S5411 (Croci): This legislation provides towns the local option of extending the Veterans Alternative Real Property Tax Exemption to those persons who served pursuant to Executive Order 11519, Operation Graphic Hand. Chapter 141 of 2017.

*S5659A (Gallivan): This legislation allows local governments the option of extending the Cold War Veterans Real Property Tax Exemption, without regard to the ten-year limitation. Chapter 290 of 2017.

*S5998 (Croci): This legislation requires that the State Disaster Preparedness Plan consider how medication and supplies can be delivered to pharmacies, hospitals and nursing homes located within an are declared disaster area. Veto No. 169 of 2017.

III. Budget Highlights

The State Budget for 2017-18 reflects the Senate's unwavering support for the heroic service men and women who have sacrificed so much on behalf of our nation. Veteran-related budget increases include:

- \$1 million in new funding for veteran-to-veteran support services run by Veterans Service Organizations;
- \$3.1 million for the Joseph P. Dwyer Veteran Peer-to-Peer Program;
- \$500,000 for the Veterans Outreach Center in Monroe County;
- \$120,000 in new funding for Veterans of Foreign Wars NYS Chapter Field Service Operations; and
- \$50,000 for the Vietnam Veterans of America New York State Council.
- \$500,000 for the NYS Defenders Association Veterans Defense Program;
- \$200,000 for Legal Services of the Hudson Valley Veterans and Military Families Advocacy Project;
- \$200,000 for Warrior Salute;
- \$100,000 for the Veterans Justice Project;
- \$100,000 for the SAGE Veterans Project;
- \$200,000 for Helmets-to-Hardhats; and
- \$25,000 for the Veterans Miracle Center.

The Senate also secured \$20 million for state Armory upgrades through the Division of Military and Naval Affairs.

With respect to the Division of Homeland Security and Emergency Services, the Legislature concurred with the Executive All Funds recommendation of \$70 million for State Operations, \$1.5 billion in Aid to Localities, and \$53 million for Capital Projects.
