#### S.3667-C Serrano/A.5284-C Rosenthal

Requires the anchoring of furniture and electronics in child day care centers, public institutions for children and certain other facilities.

Reported to Finance.

#### S.5724-A Golden

Prohibits the alleged child victim of a child abuse report from being interviewed in the presence of any other person named in the report.

Reported to first reading of calendar.

#### S.7406-A Golden

Creates a temporary state taskforce on child protective services caseworker caseload management, and providing for the repeal of such provisions upon expiration thereof.

Reported to Finance.

#### S.1746- Golden/A.1107 Richardson

Directs the Office of Children and Family Services and the NY City Administration for Children's Services to submit annual reports concerning information related to children served by their respective programs. Reported to Finance.

#### S.6519-A Golden/A320-A Rosenthal

Establishes "Brendan's law"; requires child day care centers, public institutions for children and certain other facilities installing new or replacement window coverings to install cordless window coverings; requires child day care centers, public institutions for children and certain other facilitates that have window coverings in place to meet safety standards Reported to Rules.

#### S.7613 Marchione/A9559 Walsh

Establishes a living allowance for an adult child with a developmental disability. *Reported to Rules*.
