I am pleased to transmit the Annual Report of the Senate's Standing Committee on Aging for the 2019 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters under my committee's jurisdiction. I am very proud of our victory in the budget of securing enhanced funding for home and community-based services for older New Yorkers. This funding has helped area agencies on aging to clear waiting lists of clients - some in their 90s - in need of vital home-based services. Seniors are the fastest growing segment of our state's population, and we have to ensure we have the services and resources to support them in their daily living.

During the 2019 session, this committee met 4 times in session and reported 18 bills. The Committee also held participated in the Older New Yorkers Day Celebration honoring older volunteers from communities across the state in May of this past year. The Committee's work was enhanced by the presentations of several advocacy and research groups at Committee meetings and we look forward to continuing this practice during the 2020 Legislative Session.

I thank my colleagues who served on the Committee for their efforts and support of the work that was done in the committee this year, and I thank you for the continued support from the Majority Conference in the committee's operations.

#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Aging has legislative oversight responsibilities for issues concerning welfare, protection and support of the State's growing population of older individuals.

During the 2019 Legislative Session, 66 bills were referred to the Committee for its review. Of these bills, 18 were reported from the Committee. Eleven of those bills were passed by the Senate, and 6 passed in both houses and were subsequently chaptered. This work was conducted through a series of 4 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee sponsored an Aging Advocacy Day in February, 2019 and welcomed many groups for discussion and recognition of the special needs of the aging populations and those which could be met by adequate appropriation in the 2019-20 budget.

#### **COMMITTEE HIGHLIGHTS**

S5958 - To improve the State Office of the Aging's approach to LGBT populations through a series of measures including competency training, updates to the intake form that area agencies on aging use, and generally recognizing that this group of our population has a unique set of realities and needs especially as they age.

S4407 - This bill places new regulations on reverse mortgage products pertaining to the marketing, origination, and management of these products issued in New York State under the federal home equity conversion mortgage program for seniors in the hope of preventing defaults or foreclosures on mortgages.

S5780 - The Long Term Care Ombudsman Program (LTCOP) is an important advocate for older adults in long term care facilities such as nursing homes, assisted living facilities, and adult homes. This bill would extend the authorization of the LTCOP to advocate on behalf of managed long term care participants for two more years until December 31, 2021 and help to ensure older adults are receiving quality, appropriate care.

S4060 - To put in place a reminder mechanism for renewal for senior citizens enrolled in the Senior Citizen Rent Increase Exemption Program (SCRIE). The program provides much needed assistance to senior citizens in New York City by supplementing their rent payments, thereby keeping them in their homes and out of nursing homes. This bill will make the renewal process simpler, help prevent expiration of benefits, and maintain continuity of services.

S5489 – This bill will require the state office for the aging to include reports on older adults who are primary caregivers or guardians of minors and on substance use disorders among older adults in such office's annual reports to the governor and legislature. These are two areas of growing importance among the state's older population and will now be considered by SOFA in their annual report.

#### TWO HOUSE BILLS

In 2019, 6 of the 66 bills referred to the Standing Committee on Aging passed both houses of the Legislature. Of these bills, the Governor has signed 6 and vetoed none of them.
