COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Crime Victims, Crime and Correction has legislative oversight responsibilities for issues concerning victims' rights and restitution, incarceration in state and local correctional facilities, alternatives to incarceration, re-entry, community supervision and the classification and management of sex offenders. The Committee also nominates members of the Board of Parole and commissioners of the State Commission of Correction.

During the 2019 Legislative Session, 167 bills were referred to the Committee for its review. Of these bills, 38 were reported from the Committee. Sixteen were passed by the Senate, and thirteen passed in both houses. This work was conducted through a series of six committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee also advanced the nominations of six new candidates to serve as commissioners on the State Board of Parole, five of whom were approved by a full vote of the Senate. Those commissioners were Michael S. Corley, Chanwoo Lee, Carlton S. Mitchell, Sheila Y. Samuels, and Elsie Segarra. In addition, the Committee also advanced the nomination of Sheriff Allen Riley as a member of the State Commission of Correction.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2019:

S724A (Montgomery) Provides the Department of Corrections and Community Supervision shall place incarcerated persons with minor children close to home whenever practicable.

S1623 (Sepúlveda) Restricts the use of solitary confinement to no more than 15 days at which limit an incarcerated person with additional disciplinary sanctions must be moved to a residential rehabilitation program in lieu of isolation.

S2144 (Hoylman) Provides incarcerated persons over the age of 55 who have served more than 15 years of their sentences shall be considered for discretionary parole release.

S2161B (Bailey) Provides medication assisted treatment for incarcerated people with chemical dependence or abuse.

TWO HOUSE BILLS

In 2019, 13 of the 167 bills referred to the Standing Committee on Crime Victims, Crime and Correction passed both houses. Of these bills, the Governor has signed twelve and vetoed one.
