#### **COMMITTEE JURISDICTION AND OVERVIEW**

The New York State Senate Standing Committee on Education has legislative oversight responsibilities for primary and secondary schools' requirements including Pre-K to twelfth grade as well as public libraries and services to adults with special needs. Issues before the committee range from teacher qualifications, curriculum requirements, school district operations and school and library budget votes and elections. The New York State Senate Standing Committee on Education has a diverse range of topics within its jurisdiction.

During the 2019 Legislative Session, three hundred sixty-five bills were referenced to the Committee for its review. Of these bills, seventy were reported from the Committee. Sixty-two were passed by the Senate, and thirty-seven passed in both houses. This work was conducted through a series of eight committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held **eight** hearings and/or roundtable meetings. Topics of these hearings and/or roundtables included Foundation Aid and Vaping.
