COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Children and Families has legislative oversight responsibilities for issues concerning child abuse, adoptions, cults, custody and support, day care, foster care, neglect and visitation, juvenile delinquency, determination of need of supervision, and protective and preventive services.

During the 2020 Legislative Session, 113 bills were referred to the Committee for its review. Of these bills, 18 were reported from the Committee. Nine were passed by the Senate, and four passed in both houses. This work was conducted through a series of four committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

TWO HOUSE BILLS

In 2020, four of the 113 bills referred to the Standing Committee on Children and Families passed both houses of the Legislature. The Governor has signed all four of these bills.
