COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Commerce, Economic Development, and Small Business has legislative oversight responsibilities for issues concerning small and large businesses arising under the Economic Development Law and the State Administrative Procedures Act. The Committee also handles issues arising under specific provisions of five other laws: Alcoholic Beverage Control Law provisions relating to beer and cider as well as liquor licensing and fees; Banking Law provisions concerning the New York business development corporation and small business investment companies; an Executive Law provision providing for the Office of Business Permits; Public Authorities Law provision pertaining to NY Job Development Authority, Long Island Job Development Authority, and Public Health Law's NYS Small Business Health Insurance Partnership Program.

During the 2020 Legislative Session, sixty-one bills were referred to the Committee for its review. Of these bills, sixteen were reported from the Committee, twelve were passed by the Senate, and four passed in both houses, with 1 bill chaptered to date. This work was conducted through a series of four committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held three hearings and/or roundtable meetings. Topics of these hearings and/or roundtables included the first ever, virtual Joint Public Hearing during which this Committee received testimony on the issue of the Federal Response to the Economic Impact of the COVID-19 Pandemic on Small Business in New York State and Small Businesses. This Committee also continued to be active by co-hosting a roundtable discussion on the Impact of the Coronavirus on MWBEs, as well as co-hosting another Public Hearing on Access to Capital for Small Businesses during the COVID-19 Pandemic.

COMMITTEE HIGHLIGHTS

 businesses or otherwise affecting small businesses, including but not limited to:

assault, arson and other violent felony offenses; robbery, burglary, theft, identity theft counterfeiting, check and credit card fraud and other fraud; and vandalism, graffiti and other property damage; further provides that information on eligibility and applications for financial assistance be made available to small businesses; authorizes the New York state urban development corporation to provide loans, loan guarantees, interest subsidies and grants to small businesses, municipalities, not-for-profit corporations or other organizations for the purpose of preventing crimes against small businesses or on the premises or in the vicinity of small businesses; makes related provisions.

 \$7357 KAPLAN, AKSHAR, METZGER- Provides that the departments of agriculture and markets, environmental conservation, labor, transportation and taxation and finance shall designate an existing employee to serve as its liaison to small businesses regulated by such department; further provides the duties of such small business liaison.

TWO HOUSE BILLS

In 2020, four of the sixty-one bills referred to the Standing Committee on Commerce, Economic Development, and Small Business passed both houses of the Legislature. Of these bills, the Governor has signed none and vetoed none.
